INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Day & Zimmermann 401(k) Plan for Contract Employees, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Day & Zimmermann 401(k) Plan for Contract Employees' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Day & Zimmermann 401(k) Plan for Contract Employees and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Day & Zimmermann 401(k) Plan for Contract Employees' ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. The Plan

The following description of Day & Zimmermann 401(k) Plan for Contract Employees (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a qualified defined contribution plan covering various classifications of employees of Day & Zimmermann, LLC (the “Company”), related companies and subsidiaries who have attained the age and service requirements for their employment classification and location, if any, as defined by the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – The Plan consists of a 401(k) pre-tax and Roth salary reduction feature that allows participants to contribute 1 percent to 75 percent of eligible compensation, as defined by the Plan, up to the maximum annual deferral allowed by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions (rollovers) and transfers from other qualified defined benefit or contribution plans or accounts. Participants may defer a portion of their compensation as an after-tax Roth contribution, as well as in-plan Roth rollover contributions and in-plan Roth transfers. Participants direct the investment of their contributions into the various investment options offered by the Plan. The Company may, at its discretion, match employee contributions each year. The Company did not elect to make any matching contributions in 2024 or 2023. The Company may also make Qualified Non-Elective Contributions (“QNEC”) and Prevailing wage contributions.

For the years ended December 31, 2024 and 2023, the Company’s QNEC totaled \$365 and \$160, respectively. There were no Prevailing wage contributions for the years ended December 31, 2024 and 2023.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, allocations of the Company’s contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting and Forfeitures – Participants are immediately vested in their deferral and rollover contributions plus earnings thereon. Participants are 100 percent vested in Company matching contributions after three years of service. Prevailing wage contributions made on behalf of participants are immediately 100 percent vested. Forfeited balances of terminated participants’ non-vested accounts may be used in the following order to 1) pay outstanding administrative expenses of the Plan; 2) reduce the employer matching contributions for the Plan year; and 3) reduce the employer’s profit sharing contributions for the Plan year.

As of December 31, 2024 and 2023, the forfeited non-vested accounts totaled \$-0- and \$7,316, respectively. For the years ended December 31, 2024 and 2023, \$7,348 and \$10,618, respectively, were used to pay administrative expenses of the Plan.

Notes Receivable from Participants – The plan allows loans for certain participants, who change their employee status, to be transferred to the plan from other plans sponsored by the Company. Loans are subject to the terms of the transferor plan. The loans are secured by the balance in the participant's account balance which were also transferred to the plan. Principal and interest are paid ratably through bi-weekly payroll deductions. The plan does not allow new loans to participants.

Payment of Benefits – Upon termination of service, retirement, death, or total permanent disability, a participant may elect to receive a lump-sum distribution of his or her entire accumulated plan balance, subject to the terms and certain limitations of the funding vehicles. In addition, participants may elect in-service withdrawals after reaching age 59-1/2. Participants are also permitted to make hardship withdrawals in certain cases of immediate and heavy financial need. Rollover account balances may be withdrawn at any time. Minimum required distributions for certain participants also apply per IRS regulations.

Terminated or deceased participants with a vested account balance equal to or less than \$1,000 shall be paid in a single sum as soon as administratively possible. Terminated participants with a vested account balance greater than \$1,000 and less than or equal to \$5,000 will be automatically rolled over into an IRA.

Revenue Sharing – The Plan entered into a revenue sharing agreement with The Principal Trust Company ("Principal") through April 2, 2024. Under the terms of the agreement, the plan will earn revenue credits based upon the Plan's holdings that Principal shall fund to the Plan. The plan administrator may use amounts held in the revenue sharing credit account to reimburse the Employer for fees and expenses associated with services provided to the Plan, or pay vendors, including Principal or third parties. For the years ended December 31, 2024 and 2023, Principal contributed \$4,555 and \$19,131, respectively, in revenue sharing credits to the Plan. At April 2, 2024 and December 31, 2023, the balance in the revenue sharing credit account was \$-0- and \$7,689, respectively.

The Plan has entered into a revenue sharing agreement with the Fidelity Management Trust Company ("Fidelity"), the new trustee effective April 2, 2024 (Note 3). Under the terms of the agreement, the participants will earn revenue credits based upon the Participant's holdings that Fidelity shall fund to the Participant. At December 31, 2024, the balance in the revenue sharing credit account was \$81.

Amounts contributed for revenue sharing are included within administrative expenses on the statements of changes in net assets available for benefits..

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s governing committee determines the Plan’s valuation policies utilizing information provided by the investment advisers and trustees. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are reclassified as distributions based upon the terms on the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. Information Certified by the Trustee

On April 2, 2024, assets of the plan, amounting to \$11,202,075 were transferred from Principal who held the Plan’s investment assets and executed investment transactions as of December 31, 2023 and for the period January 1, 2024 to April 1, 2024, to a new trustee, Fidelity, who held the Plan’s investment assets and executed transactions from April 2, 2024 to December 31, 2024.

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal and Fidelity, qualified institutions.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the framework are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the daily closing price as reported by the Fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed actively traded.

Common Collective Trust Funds: The units of the common collective trust funds are valued using the NAV as a practical expedient to estimate fair value as determined by the issuer based on the fair value of the underlying assets within the fund and the present value of future cash flows using the current discount rate.

Self-Directed Brokerage Account: Valued at the quoted market prices of the underlying investments, which include mutual funds and common stock. Due to the short-term highly liquid nature of cash and cash equivalents, the carrying amount approximates fair value. Any gains and/or earnings by the underlying assets are paid out as interest.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present information about the Plan's investments measured at fair value on a recurring basis as of December 31, 2024 and 2023, and indicates the fair value hierarchy of the valuation techniques utilized by the Plan to determine such value:

5. Plan Termination

Although it has not expressed any intention to do so, the plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

6. Tax Status

The underlying standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the "Code") and, therefore, the related trust is tax exempt. The plan sponsor has determined that it is eligible to and has chosen to rely on the current IRS prototype opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since the date of the most recent determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, the Plan continues to be qualified and the related trust tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by trustees of the Plan, for which fees are charged, by the trustees or affiliated entities for record keeping and other services. Certain administrative fees are paid to other service providers. Therefore, these transactions qualify as party in interest transactions. The Plan also has revenue sharing agreements with trustees (Note 1), and holds notes receivable from participants, which qualify as related-party and party in interest transactions. Although the above investments and transactions in the investments qualify as related-party and party in interest transactions, they are exempt from the prohibited transaction rules of ERISA.

9. Transfers To Affiliated Plans

Certain participants, who change their employee status, are permitted to transfer assets to and from other plans sponsored by the Company. During 2024, participants transferred \$1,434 in from and \$(140,547) out to other plans for a net transfer of \$(139,113). During 2023, participants transferred \$18,867 in from and \$(83,462) out to other plans for a net transfer of \$(64,595).
