NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the NNPP Contractor Capital Accumulation Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General - In 2018, Fluor Marine Propulsion, LLC (FMP or Company) was awarded the contract for the Naval Nuclear Laboratory (NNL) that was previously held by Bechtel Marine Propulsion Corporation (BMPC). All employees of BMPC were transitioned to FMP, and the Plan, along with a new master trust, was established solely for FMP employees. FMP has established the Plan to provide Company contributions on behalf of eligible employees for retirement savings. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is a defined contribution plan covering certain salaried and bargained employees of FMP, whether full-time or part-time. Employees are eligible the first day of employment. Additionally, employees retained previous service credited while employed with BMPC. Former BMPC employees are only eligible to participate in the Plan if they were new hires or rehires after a specified date determined by location and employee status on that date, and are not eligible to participate in one of the Company-sponsored defined benefit plans. Participants are automatically enrolled in the Plan.

The designated trustee of the Plan is Northern Trust Corporation (Northern Trust); Fidelity Management Trust Company (Fidelity) provides recordkeeping and administrative services.

Contributions - The Plan does not permit employee contributions. Contributions, up to specified limits, made by the Company are based on a specified percentage of salary and years of service. Participants direct the contributions made on their behalf into various investment options offered by the Plan. Participants may also contribute amounts representing distributions (rollovers) from other qualified plans maintained by their previous employers, subject to the language of the Plan document or approval of the Plan administrator.

Participant Accounts - Each participant's account is credited with the Company's contributions and Plan earnings. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. If an employee files a Qualified Domestic Relations Order, the participant is required to pay a fee in order to have it be qualified.

Vesting - Vesting in the employer's contributions and earnings thereon is based on years of service. A participant is 100% vested after three years of service.

Payment of Benefits - On retirement, termination of employment, death or attainment of age 59-1/2, a participant is entitled to the full value of his or her vested account balance. If employment is severed (as defined in the Plan document) by a vested employee with an account balance of \$1,000 or less, the account will be automatically distributed to the employee as soon as administratively feasible in a lump sum or installments as designated by the participant. If employment is severed by a vested employee with an account balance of more than \$1,000, the account will not be distributed to the employee until a distribution is requested or, if earlier, by April 1 following the close of the year in which the employee reaches age 73.

Forfeited Accounts - Forfeitures of terminated participants' nonvested accounts are used to reduce subsequent Company contributions. Forfeitures used and available for use by the Plan were immaterial at December 31, 2024 and 2023.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying statements of net assets available for benefits and related statements of changes in net assets available for benefits and the related notes to the financial statements (financial statements) follows:

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - The Plan holds an interest in the net assets of the NNPP Contractor DC Master Trust (Master Trust) as of December 31, 2024 and 2023. The Master Trust investments are reported at fair value (except for the fully benefit-responsive guaranteed investment contracts, which are reported at contract value). (See Note 5.) Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. (See Note 4 for discussion of fair value measurement.)

Purchases and sales of securities are reflected on a trade-date basis. Gains and losses on securities sold or redeemed are determined on the basis of average cost. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investment income from the Plan's interest in the Master Trust includes the Plan's gains and losses on investments bought and sold as well as held during the period as well as interest and dividends.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - Substantially all fees, such as recordkeeping and trustee fees, are paid by the Company. The Plan pays investment management fees, which are included in the Plan's interest in Master Trust investment income. Fees related to the administration of participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses.

**Risks and Uncertainties** - The Plan invests in securities that are subject to various risks, such as interest rate, market and credit risks. Due to the level of risk and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in value will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Subsequent Events** - Subsequent events are defined as events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are issued or are available to be issued. Management has evaluated subsequent events through September 30, 2025, the date that the financial statements were issued and determined that there have been no events that have occurred that would require adjustments to disclosures in the financial statements.

NOTE 3 - INVESTMENTS IN THE MASTER TRUST

The Plan holds an interest in the net assets of the Master Trust. The interest is expressed in units of value. Each plan rolls up into the Master Trust, as the trustee maintains separate accounts that reflect each plan's share of the Master Trust investments. Each plan account holds units of the various investment manager accounts within the Master Trust. Allocation of investment income is based on each plan's specific interest in the underlying plan investments, which are based on participant direction of the investments. Separate reporting is provided for each plan, as well as for the Master Trust in the aggregate.

NOTE 4 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identifiable assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Interest-Bearing Cash - Valued at amortized cost plus accrued interest.

Corporate Common Stocks - Valued at the closing price in the active market on which the individual security is traded.

Depository Receipts - Investments in a foreign entity through a U.S. exchange-traded security held in DTC priced nightly by a third party.

Common Collective Trusts - Valued at net asset value (NAV) of units of a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value, and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

NOTE 5 - GUARANTEED INVESTMENT CONTRACTS

The Master Trust holds an interest in a fixed-income fund, which invests directly in fully benefit-responsive guaranteed investment contracts issued by various banks and insurance companies. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

These guaranteed investment contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is a relevant measure for fully benefit-responsive investment contracts because this would be the amount received by participants if they were to initiate permitted transactions under terms of the Plan. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses, and is the amount participants would receive if they were to initiate withdrawals under terms of the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet financial obligations. The issuer's ability to meet contractual obligations might be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer, including: (1) amendments to the Plan document (including complete or partial plan termination or merger with another plan); (2) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan; (3) bankruptcy of the Plan sponsor or other Plan sponsor events; (4) the failure of the Plan to qualify for exemption from federal income taxes or any prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation or (4) a material amendment to the agreement without the consent of the issuer. As of December 31, 2024 and 2023, management was not aware of any such events.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the net assets of the Plan will be distributed to the participants in proportion to their respective account balances.

NOTE 7 - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan administrator by a letter dated July 27, 2020 that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

NOTE 7 - TAX STATUS (Continued)

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Should the Plan incur penalties and interest related to unrecognized tax benefits, such amounts would be recorded as administrative expenses. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Mercer Investment Consulting acts in a fiduciary role as the outsourced chief investment officer for the Plan. Mercer Investment Consulting is a subsidiary of Marsh & McLennan.

Certain investments of the Plan were managed by an affiliate of Mercer, therefore these transactions qualify as party-in-interest transactions.
