**1. Description of Plan**

The following description of the Lattice Semiconductor Corporation 401(k) Employee Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

Lattice Semiconductor Corporation (the “Company”) established the Plan effective January 1, 1988. The purpose of the Plan is to encourage and assist Company employees in a long-range program of retirement savings. The Company is the Plan sponsor and serves as the Plan administrator. The Plan operates under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

b. Eligibility

A full-time employee is eligible to participate in the Plan upon employment unless covered under a collective bargaining agreement, is a non-resident alien, temporary employee or leased employee.

c. Contributions

Participants may contribute up to 80% of annual compensation, as defined by the Plan, subject to the maximum set by the IRC and results of non-discrimination testing. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, as defined. Participants may also contribute amounts representing distributions from other qualified plans. Under the Plan’s automatic enrollment feature, all eligible employees are automatically enrolled in the Plan upon employment with a 3% salary deferral. Employees may change the rate of deferral at any time.

The Company may make discretionary matching contributions and profit-sharing contributions. The Company made discretionary matching contributions during 2024 and 2023. In 2024 and 2023, the match was equal to 100% of the first 3% and 50% of the next 3% of employee salary deferrals with no dollar limitations. There were no profit-sharing contributions made during 2024 and 2023.

d. Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, and an allocation of the Plan’s net earnings and losses. The allocation of net earnings and losses is based upon the number of units of various investment funds assigned to each participant’s account. Participants direct the investment of their account balances, including salary deferrals and employer contributions. The benefit to which a participant is currently entitled is the benefit that can be provided from the participant’s vested account.

e. Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance incurred by the participant during the one year period ending on the day before the date on which such loan was made, or 50% of the value of the vested interest in his or her participant account. The terms of the loan repayments range up to five years for general purpose loans and in excess of five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan's 401(k) Administrative Committee. Principal and interest is paid not less than quarterly through payroll deductions. Interest rates on loans outstanding at December 31, 2024 ranged from 4.25% to 9.50% and mature through 2039.

If an active participant fails to make payments when they are due under the terms of the loan, the loan will be considered in default. Upon an event of default, all principal and interest is due and payable as of the date of the missed payment. However, the amount of the defaulted loan will not be considered distributed to the participant until an event of withdrawal occurs (a deemed distribution).

f. Benefit Payments

Upon termination of service, retirement, or prior to retirement upon death, disability, or resignation, participants may elect to receive a lump sum distribution or installment payments as a form of benefit distribution. The amount of benefit to which a participant is entitled is the vested portion of the participant's account. The Plan features a mandatory cash-out provision for balances less than \$7,000. In the event of a mandatory distribution greater than \$1,000 but less than \$7,000, if the participant does not elect to have such distribution paid in a specific manner, then the Plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator.

Hardship withdrawals are limited to participants' vested account balances, other than his or her qualified matching contributions account, and are subject to approval by the Plan administrator and preclude the participant from making salary deferral contributions to the Plan for a period of six months.

g. Vesting

Participants are immediately vested in their employee contributions, matching contributions and earnings thereon.

h. Forfeitures

Forfeitures related to previously partially vested participants may be used to pay Plan administrative expenses with any remaining forfeitures to be used to reduce future employer contributions. Additionally, the Plan has received revenue credits from certain investments which can be used to reduce administrative expenses or be reallocated to participants. During the years ended December 31, 2024 and 2023, forfeitures of approximately \$6,000 and \$190,000, respectively, were used to pay administrative expenses or reduce employer contributions. As of December 31, 2024 and 2023, unallocated amounts available for future use totaled approximately \$196,000 and \$165,000, respectively.

## 2. Summary of Significant Accounting Policies

### a. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”) and present the net assets available for benefits and the changes in those net assets.

### b. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net appreciation in fair value of investments consist of the net change in unrealized gains or losses during the year and the realized gain or loss on investments sold during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis; dividends are recorded on the ex-dividend date.

### c. Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance plus any accrued but unpaid interest. Notes receivable from participants are fully secured by the participants’ vested accounts and as such, the Plan did not establish any allowance for credit losses. Delinquent notes receivable from participants may be treated as a distribution based on the terms of the Plan document.

### d. Payment of Benefits

Benefit payments are recorded when paid.

### e. Administrative Expenses

Administrative expenses of the Plan may be paid by the Company or by the Plan. Direct expenses paid by the Plan totaled approximately \$120,000 and \$119,000 for the years ended December 31, 2024 and 2023, respectively. Certain administrative costs are incurred as investments are bought and sold and are not separately quantifiable.

### f. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of any contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

## 3. Investments

Participants can direct their accounts among the various mutual funds and the common collective trust fund available through the Plan.

The T.Rowe Price Stable Value Common Trust Fund A’s (“Stable Value Fund”) objective is to maximize current income and maintain principal stability by investing primarily in a diversified

portfolio of guaranteed investment contracts, bank investment contracts, and separate account contracts. The beneficial interest of each participant is represented by units. Units are issued and redeemed at the Stable Value Fund's constant net asset value ("NAV") of \$1.00 per unit. Distributions to the Stable Value Fund unit holders is declared daily from the net investment income and automatically reinvested in the fund on a monthly basis, when paid.

Certain events limit the ability of the Plan's investment in the Stable Value Fund to transact at contract value with the issuer. Such events initiated by the Plan sponsor include plant closings, layoffs, Plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of a trust or other events. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

#### **4. Fair Value Measurements**

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 — Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 — Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 — Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Shares in mutual funds are valued at fair value based on quoted market prices in active markets.

*Common collective trust:* The Plan's interest in the common collective trusts is based on the NAV practical expedient of the common collective trusts' underlying investments as based on information reported by the investment advisor using the audited financial statements or daily reported NAV of the common collective trust at year-end. Participant transactions can occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **5. Tax Status**

Effective September 1, 2021, the Plan was restated utilizing a Fidelity Non-Standardized Pre-Approved Plan Document (“Plan Document”). Fidelity received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, in which the IRS stated that the Plan Document, as then designed, was in compliance with the applicable requirements of the IRC. Management believes that the Plan is currently designed and being operated in compliance with the applicable provisions of the IRC.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **6. Information Certified by the Trustees**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for reporting and Disclosure under ERISA. The following information included in the financial statements and supplemental schedule was provided and certified by the trustee, Fidelity, as of and for the years ended December 31, 2024 and 2023 is complete and accurate:

- Investments, at fair value
- Notes receivable from participants
- Investment income
- Interest on notes receivable from participants
- Schedule of assets (held at end of year)

## **7. Plan Termination**

Although it has not expressed any intent to do so, the Company may terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the employer profit sharing contributions and the earnings thereon.

## **8. Party-in-Interest Transactions**

Certain Plan investments are managed by Fidelity Investments, an affiliate of Fidelity. Fidelity is the trustee as defined by the Plan. Certain investment fees are paid by the trustee and are reflected in the investment income or loss for the year. The Plan also issues loans to participants that are secured by the vested balance in the participants’ accounts. As such, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Additionally, the Plan sponsor, Lattice Semiconductor Corporation, is a party-in-interest. However, there were no transactions with the Plan sponsor other than the funding of contributions to the Plan and payment of certain administrative expenses of the Plan.

**9. Risks and Uncertainties**

The Plan assets are invested in a variety of investments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits, and related participant account balances.

**10. Subsequent Events**

The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued.
