SCHEDULE SB, PART V - SUMMARY OF PLAN PROVISIONS

1. **Eligibility** All Eligible Employees will enter on the January 1 or July 1 following the completion of one Year of Service and attainment of age 21.
2. **Normal Retirement Date:** First of the month following the attainment of age 65 or the fifth anniversary of Plan Participation, if later.
3. **Compensation:** Gross compensation for the year ending December 31.
4. **Normal Retirement Benefit:** The benefit that can be provided by the actuarial accumulation of contributions each year, which shall be determined as follows:
 - i. For Andrew Tupler, the Hypothetical Contribution shall be equal to 40.00% of Compensation.
 - ii. For Dara Tupler, the Hypothetical Contribution shall be equal to 40.00% of Compensation.
 - iii. For Anthony Schaub, the Hypothetical Contributions shall be equal to \$0
 - iv. For all other eligible participants, the Hypothetical Contribution shall be equal to 3.00% of Compensation.
5. **Accrued Benefit:** Same as Normal Retirement Benefit.
6. **Interest Crediting Rate:** 4.00%
7. **Standard Form of Retirement Benefit:** Life Annuity. If the Participant is married, the benefit must be converted to an actuarially equivalent Joint & Survivor Annuity, unless elected otherwise with spousal consent.
8. **Early Retirement Benefit:** None
9. **Disability Benefit:** Upon retirement due to Total and Permanent Disability, the Actuarial Equivalent of Accrued Benefit is payable.
10. **Death Benefits:** Upon death prior to retirement, actuarial present value of Accrued Benefit is payable (in the form of a Pre-Retirement Survivor Annuity unless elected otherwise with Spousal Consent).
11. **Termination of Employment:** Upon termination of employment prior to retirement, death, or disability, the vested Accrued Benefit is payable.
12. **Vesting:** Vested in the accrued benefit based on years of service. 0% for less than 3 years increasing to 100% on or after 3 years. A year of vesting service is credited for each Plan Year in which an employee completes at least 1,000 hours of service.
