Opinion

Note 1. Plan Description

The following description of the Orlando Health, Inc. Retirement Savings Plan 401(a) (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan was established on January 1, 1988, and subsequently amended, as a defined-contribution plan covering all eligible employees of Orlando Health, Inc. (the “Organization”), who have completed one year of service, as defined by the Plan, and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

The Plan does not permit participant contributions; all participant contributions must be made to the Orlando Health, Inc. Retirement Savings Plan 403(b) (“Plan II”). Discretionary employer contributions to the Plan, if any, are only permitted for those participants who are not participating in Plan II. No such contributions were made for the year ended December 31, 2024.

Participant Accounts

A separate account is maintained for each participant. Each participant’s account is credited with Organization contributions, as applicable, earnings from investments, and an allocation of investment credits, if any, and is charged a quarterly fee for Plan administrative expenses. Allocations of investment credits are based upon account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Participants may elect to have contributions and related earnings thereon allocated to one or more investment options offered by the Plan.

Vesting

Effective December 31, 2022, the Plan’s vesting provision was amended and all participants employed by the Organization on December 31, 2022 became fully vested.

Administrative Expenses

Administrative expenses paid by the Plan included recordkeeping and trustee fees. Commissions and other investment-related expenses are netted against the net change in fair value of investments. Certain administrative expenses and professional fees are paid directly by the Organization. Expenses that are paid by the Organization are excluded from these financial statements.

Forfeited Accounts and Investment Credits

Forfeited balances of participants’ non-vested accounts are used to reduce future Organization contributions and may be used to pay Plan expenses. During the Plan year ended December 31, 2024, no forfeitures were used by the Plan for year ended December 31, 2024. The Plan did not use any of the amounts to pay Plan expenses during the year ended December 31, 2024. Unallocated forfeitures approximated \$170,000 and \$45,000 as of December 31, 2024 and 2023, respectively.

The Plan receives investment credits from certain investment funds that may be used to pay Plan expenses or allocated to participants. Unallocated investment credits held by the Plan as of December 31, 2024 and 2023 approximated \$278,000 and \$277,000, respectively. Investment credits received and dividends credited during the year ended December 31, 2024 approximated \$14,000.

Participant Notes Receivable

Notes to participants may only be granted from the participant's rollover account, and no loan may be granted to any participant having a note currently outstanding from the Plan or Plan II.

Participants may borrow from their rollover account a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. Notes bear a reasonable rate of interest, with terms that may not exceed 5 years, or up to 15 years for the purchase a principal residence. Note principal and interest must be repaid in equal installments made via payroll deduction.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum payment equal to the value of the participant's vested interest in his or her account, installments, or an annuity over a fixed period of time, not to exceed the life expectancy of the participant/designated beneficiary. Upon termination of service, for reasons other than death, disability, or retirement, a participant may receive a lump-sum payment equal to the vested value of his or her account.

Plan Termination

Although it has not expressed any intent to do so, the Organization has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan or complete discontinuance of contributions, all participants' accounts will remain 100% vested.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are presented on the accrual basis of accounting.

Investment Valuation and Income Recognition

As of December 31, 2024 and 2023, the Plan's funds were invested in a money market fund, target date common trust funds, various registered investment companies, and unallocated investment contracts.

The Plan's investments, other than its unallocated fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Registered investment companies and money market funds are valued at the reported net asset value ("NAV") of shares held by the Plan at year end determined by quoted market prices in active markets. The NAV is based on the fair value of the underlying assets owned less any fund liabilities.

Common trust funds are valued at their NAV which represents the unit value as determined by the issuer on the last day of the Plan year.

In accordance with the Plan's policy of stating marketable securities at fair value, the unrealized depreciation or appreciation for each year is reflected in the Plan's statement of changes in net assets available for benefits as net appreciation in fair value of investments.

Purchases and sales of securities are recorded on a trade-date basis, and interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation in the fair value of the Plan's investments includes the Plan's gains and losses on investments bought and sold, as well as the unrealized gains and losses on those investments that are held at the end of the year.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts. Contract value is deemed to be the relevant measurement attribute for those contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions and reinvested income, less any withdrawals, plus accrued interest. The Plan's investments in unallocated contracts are fully benefit responsive and stated at contract value (see Note 3).

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balance, plus accrued but unpaid interest. Interest income on participant notes receivable is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. If collection of a participant's note is deemed doubtful, the amount is recognized as a distribution in the period the determination is made. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Other Liabilities

Other liabilities represents amounts arising from unsettled trades related to purchases of marketable securities, which are recorded on a trade-date basis.

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no amounts allocated to the accounts of individuals who have elected to withdraw from the Plan but had not yet been paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities in the accompanying financial statements and notes thereto and supplemental schedule. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan's investments are not insured and are subject to credit and market risks. Financial information relating to those investments is included in these financial statements, based on information provided collectively by Fidelity Management Trust Company ("Fidelity") and The Variable Annuity Life Insurance Company ("VALIC"), a wholly owned subsidiary of Corebridge Financial, Inc. (collectively, the "Plan Custodians").

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 3. Fully Benefit-Responsive Investment Contracts

Investments held in unallocated contracts consist of the MetLife Stable Value Plus Account, the VALIC Fixed Account Plus, and the VALIC Short-term Fixed Account. These funds are deemed to be fully benefit-responsive investment contracts and, therefore, are reported at contract value.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. However, withdrawals influenced by Organization-initiated events, such as reallocation of investments, may result in a distribution at other than contract value, and are subject to certain restrictions. The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the contract issuer's ability to meet its financial obligations. There are no reserves against contract values for credit risk of the contract issuer or otherwise.

The MetLife Stable Value Plus Account Fund contracts held by the Plan are guaranteed investment contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rate is reset annually by the issuer with a minimum guaranteed rate of 1%.

The VALIC Fixed Account Plus Fund and VALIC Short-term Fixed Account Fund contracts held by the Plan are guaranteed investment contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting interest rates for these contracts are set monthly by the issuer with a minimum guaranteed rate of 3%.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (the "Code") or the failure of the trust to be tax-exempt under Section 501(a) of the Code
- Plan termination or merger
- Amendments or other changes to the Plan that significantly affect the Plan's normal operations
- Bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operation

No events are deemed probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 4. Fair Value Measurement

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy under GAAP are described as follows:

- Level 1** Inputs to the valuation methodology that are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The preceding methods may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service (the "IRS") dated September 23, 2015, stating that the Plan is qualified under section 401(a) of the Code, and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended and restated. Once qualified,

the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Subsequent Events

In preparing these financial statements, the Organization has evaluated events and transactions for potential recognition through September 23, 2025, the date the financial statements were available to be issued.
