We have performed audits of the financial statements of Interstate and Istate 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **Note 1: Description of Plan**

The following description of the Interstate Companies, Inc. ("Company") 401(k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of the Company. Eligible employees must complete thirty days of credited service and be age eighteen or older. Plan entry dates are the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

Each year, participants may contribute up to 50% of pre-tax annual compensation, as defined in the Plan, and post-tax Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. Matching contributions are discretionary and are determined by the Employer. The Company may elect on a quarterly or annual basis to make discretionary matching contributions on behalf of all participants employed on the last day of the specific period equal to a percentage of the salary deferral reduction elected by the participants. The Company may also make a discretionary profit sharing contribution at the discretion of the Company. The discretionary profit sharing contributions were 25% of employee deferrals for the year ended December 31, 2024. During the year ended December 31, 2024, the Company made matching and profit sharing contributions of \$2,050,605 to the Plan. Contributions are subject to certain statutory limitations.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching and profit sharing contributions and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested after six years of credited service. A participant is also fully vested upon reaching normal retirement age, upon death, or upon becoming totally and permanently disabled.

### **Note 1: Description of Plan (Continued)**

#### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The participants may have up to two outstanding notes receivable. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% - 10.50%, which is the prime rate plus two percent. Principal and interest is paid through payroll deductions.

#### **Payment of Benefits**

On termination of service for any reason, a participant may receive the value of the vested interest in the participant's account as a lump-sum or partial distribution. If a participant terminates with a vested balance of less than \$7,000, the amount of their vested balance is required to be removed from the Plan.

#### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$91,510 and \$97,016, respectively. These accounts will be used to reduce future employer contributions or Plan expenses. In 2024, employer contributions were reduced by \$213,448 from forfeited nonvested accounts.

### **Note 2: Summary of Significant Accounting Policies**

#### **Statement Presentation**

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value and all are participant directed. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the plan year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

#### **Reclassifications**

Certain reclassifications have been made in the prior-year's financials statements to conform to the classification used in the current-year. These reclassifications have no effect on net assets available for benefits.

#### **Subsequent Events**

The plan sponsor has evaluated subsequent events through September 3, 2025, the date on which the financial statements were available to be issued.

### **Note 3: Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs would only be used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

The fair value of registered investment companies consists of mutual funds and is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The mutual funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The fair value of corporate common stock is based on quoted net asset values of the shares. The shares are registered with the U.S. Securities and Exchange Commission.

Other investments primarily consist of unit investment trusts. The fair value of unit investment trusts consists of redeemable units and is based on quoted net asset values of units as reported by the investment. The units are registered with the U.S. Securities and Exchange Commission. The trusts must publish their daily net asset value and transact at that price. The unit investment trusts held by the Plan are considered to be actively traded.

Redemptions may be made daily by participants, however, require a 12 month notice for plan sponsor initiated actions.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers of investments into or out of Level 3.

### **Note 4: Priorities Upon Termination of the Plan**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become fully vested in their employer contributions.

### **Note 5: Trustee and Administration of the Plan**

The Plan is administered by Interstate Companies, Inc., the plan sponsor. The Company uses a third party administrator to aid in the acquisition, disposition, and accounting for trust assets. Principal Trust Company is the appointed trustee.

### **Note 6: Tax Status**

The Plan is qualified under Section 401 of the Internal Revenue Code (IRC) and is exempt from federal and state income taxes. The non-standardized pre-approved plan obtained its latest opinion letter June 30, 2020, in which the Internal Revenue Service stated that the underlying non-standardized pre-approved plan was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in process.
