Note 1: The Plan and its significant accounting policies:

The following description of the CAQH 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan that was established by Council for Affordable Quality Healthcare, Inc. (the Company) on January 1, 2014, to provide benefits to eligible employees. The Plan covers all full-time employees of the Company, other than union and leased employees, interns, and nonresident aliens, who are 21 years of age or older. Employees classified as temporary or part-time are eligible to participate only if they complete 1,000 hours of service within a 12-month period. The Plan is subject to the provisions of ERISA.

Basis of accounting - The accompanying financial statements are prepared on the accrual basis of accounting.

Administration - Under the terms of the Plan, designated officers of the Company act as trustees. The Company has contracted with Voya Retirement Insurance and Annuity Company (Voya) to act as recordkeeper and custodian. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are also charged directly to the participant's account and included in administrative expenses.

Investment valuation and income recognition - Investments of the Plan are held by Voya and invested based solely upon instructions received from participants. Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date within the pooled separate accounts and are included in net appreciation, which also includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 1: The Plan and its significant accounting policies: (continued)

Investment valuation and income recognition (continued) - The Plan is invested in a Voya fixed account. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the contract. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. The Plan administrator believes all notes receivable from participants are collectible.

Payment of benefits - Benefits are recorded when paid.

Income taxes - The Internal Revenue Service has determined and informed Voya by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not applied for or received an individual determination letter and has been amended since June 30, 2020, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. Plan assets may have decreased in value since December 31, 2024 due to normal market fluctuations.

Plan amendments - Effective January 1, 2023, the Plan was amended to exclude Long Term Incentive Plan compensation from plan compensation.

Adoption of new accounting policy - On January 1, 2024, the Plan adopted ASU 2016-13 *Financial Instruments – Credit Losses (topic 326): Measurement of Credit Losses on Financial Instruments*, as amended, which replaces the incurred loss methodology with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology.

Adoption of new accounting policy (continued) - The measurement of expected credit losses under CECL methodology is applicable to financial assets measured at amortized costs, including contribution receivables and held-to-maturity debt securities. The Plan adopted ASC 326 using the modified method for all financial assets measured at amortized costs. The Plan has analyzed its financial assets and deemed that no adjustment is necessary. Therefore, total net assets available for benefits and change in net assets available for benefits are unchanged due to the adoption of this new standard. The Plan will continue to analyze their financial assets for expected credit loss under this new standard.

Note 2: Participation and benefits:

Participant contributions - Participants may elect to have the Company contribute a percentage of their eligible pre-tax compensation up to the amount allowable under current income tax regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. These eligible employees may also elect to make Roth elective deferrals. Roth elective deferrals are made after taxes have been withheld. Participants may contribute a combination of pre-tax elective deferrals and Roth elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions withheld are invested in accordance with the participant's direction.

Participants are also allowed to make rollover contributions of amounts received from other tax-qualified employer-sponsored retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with the participant's direction and the Plan's provisions.

Employer contributions - The Company is allowed to make matching contributions as defined in the Plan and as approved by the Company. In 2024 and 2023, the Company made matching contributions of 50% of each eligible participant's contribution to the Plan up to 3% of compensation. The matching contributions totaled \$400,524 and \$378,336, respectively, for the years ended December 31, 2024 and 2023. For 2024 and 2023, the Company also provided a safe harbor fixed contribution of 3% of each participant's eligible earnings. The safe harbor contribution was \$864,693 and \$792,509, respectively, for the years ended December 31, 2024 and 2023. The Company also provided a profit sharing contribution of 3% of each participant's eligible earnings, plus an additional 3% of each participant's eligible earnings in excess of the social security wage base. The profit sharing contribution was \$1,016,999 and \$950,155, respectively, for the years ended December 31, 2024 and 2023.

Participant accounts - Each participant's account is credited with the participant's contributions, Plan earnings or losses, administrative expenses, Company matching and safe harbor contributions, and an allocation of the Company's profit sharing contribution, if any. Allocation of the Company's matching contributions is based on participant contributions. Allocation of the Company's safe harbor and discretionary profit sharing contributions is based on participants' compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their salary deferral, rollover contributions, safe harbor contributions, and related earnings. Participants vest ratably and are fully vested in the employer's profit sharing and non-safe harbor matching contributions allocated to their account after three years of credited service.

Forfeited accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$171 and \$5,990, respectively. These accounts will be used to pay administrative fees and reduce future employer contributions. Forfeitures of \$59,097 and \$79,308, respectively, were used to reduce employer contributions for the years ended December 31, 2024 and 2023. Additionally, forfeitures of \$2,803 and \$-0-, respectively, were used to pay administrative expenses for the years ended December 31, 2024 and 2023.

Payment of benefits - Upon termination, the participant or beneficiary will receive the benefits in a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in installments, paid at least annually over a period not exceeding the joint and survivor life expectancy of the participant and beneficiary. The Plan allows for automatic lump-sum distributions of participant vested account balances which do not exceed \$1,000. Account balances which exceed \$1,000 but are less than \$5,000 for which the participant has not made a distribution election are rolled over to an individual retirement account designated by the Plan administrator. Effective January 1, 2024, the threshold above increased from \$5,000 to \$7,000.

Notes receivable from participants - The Plan allows participants to borrow a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the participant's vested account balance and bear interest at the available market financing rates. The loans must be repaid to the Plan within a five-year period unless the loan is used for the purchase of a primary residence. The specific terms and conditions of such loans are established by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

Note 3: Certified information:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained and derived from information supplied to the plan administrator and certified as complete and accurate by Voya, the custodian of the Plan.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule. In addition, the information in the Form 5500 Supplemental Attachment to Schedule H has been certified by Voya as of December 31, 2024.

Note 4: Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Additionally, the Plan issues loans to participants, which are secured by the participants' accounts. These transactions are considered party in interest transactions.

Note 6: Reconciliation of financial statements to Schedule H of Form 5500:

The differences between the information reported in the financial statements and the information reported in the Form 5500 arise from classification differences in investment income.
