## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the IntelePeer Cloud Communications, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### 1. Description of the Plan

The IntelPeer Cloud Communications, LLC 401(k) Plan (the Plan) was established by IntelPeer Cloud Communications, LLC (the Company), effective March 23, 2007 to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General:*

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by Company employees. Fidelity Management Trust Company (Fidelity) serves as the Plan's trustee and record keeper. Fidelity is authorized to invest, manage and reinvest Plan assets, pay benefits and ensure proper accounting records are maintained. Plan investments are invested based on instructions from participants and their beneficiaries.

#### *Eligible Participants:*

Employees, as defined by the Plan agreement, aged 21 or older may participate in the Plan on the first day of the month following their date of hire.

#### *Contributions:*

Participants are permitted to make voluntary pre-tax salary deferrals and Roth post-tax contributions up to 90% of their annual eligible compensation, as defined in the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional "catch-up" contributions under the Code. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), excluding rollovers of after-tax contributions, subject to Code regulations.

The Company may make discretionary matching contributions to the Plan, as determined by the Company's Board of Directors. The Company did not make any matching contributions to the Plan through December 31, 2024.

Contributions are subject to certain limitations under the Code.

### 1. Description of the Plan (continued)

#### *Participant Accounts:*

Participant accounts are credited with participant contributions and rollovers, Company contributions, if any, plus earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

#### *Vesting:*

Participants are fully (100%) vested in their contributions and Company qualified non-elective contributions, plus actual earnings (less any losses) thereon. Participants vest in Company matching contributions, if any, plus actual earnings (less any losses), after three years of service.

#### *Forfeitures:*

The non-vested portion of a terminated participant's account balance is forfeited upon a five-year break in service or, if earlier, upon distribution of the vested account balance. Forfeitures, if any, may be used to reduce Company contributions or pay Plan administrative expenses. Forfeited non-vested accounts were \$6,849 and \$6,411 at December 31, 2024 and 2023 respectively.

#### *Notes Receivable from Participants:*

Participants may borrow up to one-half of their account balance, a minimum of \$1,000 and not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which terms of up to 30 years are permitted. Participant notes are evidenced by a written note, secured by the balance in the participant account, and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator under the note policy. Participants may not have more than one note outstanding at any time. The interest rates on the notes outstanding at December 31, 2024 ranged from 4.00% to 9.00%. Repayment of principal and interest is generally made through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

### 1. Description of the Plan (continued)

#### *Payment of Benefits:*

Upon termination of service, participants may receive a lump-sum cash payment in an amount equal to the balance in their accounts. Account balances of \$1,000 or less may be distributed without the consent of the participant. All distributions are subject to the applicable provisions of the Plan agreement. Benefits are recorded when paid.

#### *Administrative Expenses:*

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the financial statements. Certain management, participant note and contract administration fees are paid by the Plan and charged directly to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

#### *Risks and Uncertainties:*

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risks in the near term could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

#### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, participants would remain fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting:*

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### 2. Summary of Significant Accounting Policies (continued)

#### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### *Investments:*

Investments reported at fair value consist of mutual funds, a money market fund, and a common/collective trust. These investments are accounted for as follows:

*Mutual Funds and Money Market Fund:* These funds are valued at the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

*Common/Collective Trusts (CCT):* The Invesco Stable Asset Fund – Class III is a CCT and stable value fund that is composed primarily of fully benefit-responsive investment contracts. Units held in the CCT are valued using the NAV practical expedient of the CCT, as valued by Invesco Trust Company (Invesco), the issuer. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV of a CCT is calculated based on the compilation of primarily observable market information. The Plan has no unfunded commitments with the CCT and investments are redeemable daily.

The NAV practical expedient would not be used if it is determined to be probable the Plan will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the trust, Invesco reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidated will be carried out in an orderly business manner. The Plan has no unfunded commitments with the CCT.

#### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with investing in those financial instruments.

#### *Fair Value Measurement:* (continued)

The three-level hierarchy for fair value measurement is defined as follows:

**Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

**Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

**Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The Plan's mutual funds and money market fund are recorded at fair value and are classified within Level I of the fair value hierarchy as of December 31, 2024 and 2023. The collective trust is valued based on the NAV practical expedient and is excluded from the fair value hierarchy under GAAP.

#### *Income Recognition:*

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on the Plan's investments bought, sold or held during the year.

### 3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### 4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Party-In-Interest Transactions

Certain Plan investments include investment options managed by Fidelity. As Fidelity is the Plan trustee, purchases and sales of these investments by the Plan qualify as party-in-interest transactions. Note receivable transactions with participants also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

## INDEPENDENT AUDITOR'S REPORT

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters we identified during the audit.

### 1. Description of the Plan

The IntelPeer Cloud Communications, LLC 401(k) Plan (the Plan) was established by IntelPeer Cloud Communications, LLC (the Company), effective March 23, 2007 to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General:*

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by Company employees. Fidelity Management Trust Company (Fidelity) serves as the Plan's trustee and record keeper. Fidelity is authorized to invest, manage and reinvest Plan assets, pay benefits and ensure proper accounting records are maintained. Plan investments are invested based on instructions from participants and their beneficiaries.

#### *Eligible Participants:*

Employees, as defined by the Plan agreement, aged 21 or older may participate in the Plan on the first day of the month following their date of hire.

#### *Contributions:*

Participants are permitted to make voluntary pre-tax salary deferrals and Roth post-tax contributions up to 90% of their annual eligible compensation, as defined in the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional "catch-up" contributions under the Code. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), excluding rollovers of after-tax contributions, subject to Code regulations.

The Company may make discretionary matching contributions to the Plan, as determined by the Company's Board of Directors. The Company did not make any matching contributions to the Plan through December 31, 2024.

Contributions are subject to certain limitations under the Code.

### 1. Description of the Plan (continued)

#### *Participant Accounts:*

Participant accounts are credited with participant contributions and rollovers, Company contributions, if any, plus earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

#### *Vesting:*

Participants are fully (100%) vested in their contributions and Company qualified non-elective contributions, plus actual earnings (less any losses) thereon. Participants vest in Company matching contributions, if any, plus actual earnings (less any losses), after three years of service.

#### *Forfeitures:*

The non-vested portion of a terminated participant's account balance is forfeited upon a five-year break in service or, if earlier, upon distribution of the vested account balance. Forfeitures, if any, may be used to reduce Company contributions or pay Plan administrative expenses. Forfeited non-vested accounts were \$6,849 and \$6,411 at December 31, 2024 and 2023 respectively.

#### *Notes Receivable from Participants:*

Participants may borrow up to one-half of their account balance, a minimum of \$1,000 and not to exceed \$50,000, for a period not to exceed five years, except for notes used to purchase a primary residence for which terms of up to 30 years are permitted. Participant notes are evidenced by a written note, secured by the balance in the participant account, and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator under the note policy. Participants may not have more than one note outstanding at any time. The interest rates on the notes outstanding at December 31, 2024 ranged from 4.00% to 9.00%. Repayment of principal and interest is generally made through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

### 1. Description of the Plan (continued)

#### *Payment of Benefits:*

Upon termination of service, participants may receive a lump-sum cash payment in an amount equal to the balance in their accounts. Account balances of \$1,000 or less may be distributed without the consent of the participant. All distributions are subject to the applicable provisions of the Plan agreement. Benefits are recorded when paid.

#### *Administrative Expenses:*

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the financial statements. Certain management, participant note and contract administration fees are paid by the Plan and charged directly to participant accounts. All other administrative expenses related to the Plan are paid by the Company and are not reflected in the Plan's financial statements.

#### *Risks and Uncertainties:*

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risks in the near term could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

#### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to terminate the Plan at any time, subject to the provisions of ERISA. In the event of a Plan termination, participants would remain fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

### 2. Summary of Significant Accounting Policies

#### *Basis of Accounting:*

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### 2. Summary of Significant Accounting Policies (continued)

#### *Use of Estimates:*

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### *Investments:*

Investments reported at fair value consist of mutual funds, a money market fund, and a common/collective trust. These investments are accounted for as follows:

*Mutual Funds and Money Market Fund:* These funds are valued at the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

*Common/Collective Trusts (CCT):* The Invesco Stable Asset Fund – Class III is a CCT and stable value fund that is composed primarily of fully benefit-responsive investment contracts. Units held in the CCT are valued using the NAV practical expedient of the CCT, as valued by Invesco Trust Company (Invesco), the issuer. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, minus its liabilities, and then divided by the number of units outstanding. The NAV of a CCT is calculated based on the compilation of primarily observable market information. The Plan has no unfunded commitments with the CCT and investments are redeemable daily.

The NAV practical expedient would not be used if it is determined to be probable the Plan will sell the investment for an amount different from the reported NAV. If the Plan initiates a full redemption of the trust, Invesco reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidated will be carried out in an orderly business manner. The Plan has no unfunded commitments with the CCT.

#### *Fair Value Measurement:*

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability as of the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with investing in those financial instruments.

#### *Fair Value Measurement:* (continued)

The three-level hierarchy for fair value measurement is defined as follows:

**Level I:** Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

**Level II:** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

**Level III:** Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement.

The Plan's mutual funds and money market fund are recorded at fair value and are classified within Level I of the fair value hierarchy as of December 31, 2024 and 2023. The collective trust is valued based on the NAV practical expedient and is excluded from the fair value hierarchy under GAAP.

#### *Income Recognition:*

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on the Plan's investments bought, sold or held during the year.

### 3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

### 4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded, as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Party-In-Interest Transactions

Certain Plan investments include investment options managed by Fidelity. As Fidelity is the Plan trustee, purchases and sales of these investments by the Plan qualify as party-in-interest transactions. Note receivable transactions with participants also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
