## INDEPENDENT AUDITOR'S REPORT

To the Participants and Trustees of

### Opinion

#### 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### **Basis of Accounting**

The accompanying financial statements for Northern California Sheet Metal Workers Health Care Plan (the "Plan") are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

##### **Investment Valuation, Transactions and Income Recognition**

###### *General*

Investments are carried at fair value, which is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards *Codification* ("FASB ASC") 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan's assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

*Level 1* - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

*Level 2* - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

*Level 3* - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities' own judgments and estimations, or some other pricing method using unobservable inputs.

###### *Inputs and Valuation Methods*

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for each of the Plan's investment classes are presented below.

*Mutual funds*: The fair value of mutual funds is based on quoted market prices in active markets (*Level 1*).

*Money market account*: The fair value of the money market account is based on cost, which approximates fair value (*Level 2*).

###### *Valuation Methods, Consistency*

The valuation techniques used in the accompanying financial statements have been consistently applied. Plan management determines the Plan's valuation policies utilizing information provided by its investment advisor and custodian.

#### *Transactions and Income Recognition*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Contributions Receivable**

Contributions from employers are accrued based upon subsequent cash receipts and an estimation of amounts due based on historical remittance trends. The carrying amount of contributions receivable is reduced by an allowance for credit losses that reflects management's best estimate of the amounts that will not be collected. Factors which influence management's judgement in determining the appropriate allowance for credit losses include past collection experience, industry standards, current economic conditions, and expected future economic conditions. The allowance was \$0 as of December 31, 2024 and 2023.

#### **Prescription Rebate and Other Receivables**

Prescription rebate and other receivables earned but not received prior to year-end are recorded as receivables.

#### **Stop-loss Reimbursements**

Claims that were already paid from the Plan that exceeded the stop-loss coverage and are due to the Plan at year-end are recorded as a receivable. Stop-loss reimbursements are recognized on the statements of changes in net assets available for benefits. During the years ended December 31, 2024 and 2023, self-funded benefits exceeding the stop-loss deductible totaled \$0 and \$155, respectively. Stop-loss amounts earned but not yet received as of December 31 are recorded as stop-loss receivable.

#### **Participant Contributions**

Contributions, including those from retirees, are recognized as income in the same month as benefit coverage is provided.

#### **Cash**

Cash consists of monies held in checking accounts and highly liquid, interest-bearing accounts without significant withdrawal restrictions.

#### **Recognition of Benefits**

Benefits are recorded when paid.

#### **Benefit Obligations**

Claims payable and incurred but not reported and accumulated eligibility credits were estimated by the Plan's actuary based on claims experience, premium costs and estimated administrative expenses, as applicable.

#### **Post-Retirement Benefit Obligations**

Post-retirement benefit obligations include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. This obligation was estimated by the Plan's actuary.

#### **Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

**Risks and Uncertainties**

Post-retirement benefit obligations are calculated based on certain assumptions pertaining to future contributions, participant demographics, interest rates and other assumptions, all of which are subject to change. Due to the inherent uncertainty of the assumption process, it is at least reasonably possible that changes in these assumptions in the near-term would be material to the post-retirement benefit obligations.

The Plan invests in mutual funds and a money market account. Such investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

**Reciprocity**

The Plan is a party to a sheet metal industry reciprocal agreement that provides for employer contributions to be remitted to/from other participating plans when members work for employers outside of their local jurisdiction. Reciprocity agreements allow for participants to have their contributions remitted to other plans, while also allowing other plans to remit the funds to the Plan. During the years ended December 31, 2024 and 2023, the Plan had received \$1,282,860 and \$1,802,120, respectively, of reciprocity income and made \$1,238,176 and \$753,769, respectively, of reciprocity payments, both of which are included in employer contributions on the statements of changes in net assets available for benefits. As of December 31, 2024 and 2023, the Plan does not have obligation for payments due to other plans, or an estimated receivable due from other plans.

**2. DESCRIPTION OF THE PLAN**

The Plan was established by the terms of an agreement and declaration of trust on March 29, 1995, between Sheet Metal Workers International Association Local Union 162 and various employer associations and individual employers' signatory to the agreements. Substantially all employer contributions received are from participating employers located in Northern and Central California and engaged in the sheet metal industry. The Plan is subject to the provisions of ERISA, as amended.

General eligibility rules under the Plan are as follows:

- a) A participant becomes eligible under the Plan after the participant works the minimum qualifying period hours. Each hour worked by a participant in covered employment is credited as one hour in a reserve hour bank. The requirements a participant must meet before Plan coverage begins depends on the benefit schedule for which the participant is eligible. Active participants are eligible for coverage under Schedules 1, 1A or 2. The minimum qualifying period ranges from 120 to 290 hours and one to two months. There is also a time limit of eleven consecutive months during which a participant must accumulate all qualifying period hours.
- b) For each month a participant is covered under the Plan, a certain number of hours from their reserve hour bank will be withdrawn. The number of hours withdrawn will range from 120 to 145, based on the schedule of benefits.
- c) There is a maximum number of hours a participant can accumulate in their reserve hour bank, depending on the schedule of benefits for which the participant is eligible. The maximum reserve hours range from 145 to 480.
- d) Retirees that meet the Plan's eligibility requirements are eligible to participate in the Plan.

Benefits of the Plan include medical, dental, prescription drug, vision, life, death, dismemberment and substance abuse. Vision benefits are provided through an agreement with Vision Service Plan. Certain participants may elect optional medical coverage under the Kaiser Foundation Health Plan and dental coverage under Bright Now. All other benefits are paid on a self-funded basis out of the assets of the Plan.

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-funded benefits. If the claims paid on behalf of an eligible participant or dependent exceed the deductible amount of \$1,000,000 during the policy period, the carrier will reimburse the Plan for the excess in accordance with the terms of the stop-loss insurance arrangement.

The Plan also provides for Health Reimbursement Accounts (“HRAs”) for eligible Plan participants. The HRAs are funded by employer contributions. For the years ended December 31, 2024 and 2023, the HRA contribution rates ranged from \$1.00 to \$2.00 and \$.50 to \$2.00 per covered hour, respectively, depending on the terms of the collective bargaining agreements. Each eligible Plan participant has a “benny card” that contains their HRA balance and can be used to pay for qualified medical expenses. The HRA activity is separately identified on the statements of changes in net assets available for benefits. This program may be terminated by the Board of Trustees at any time, in which event the HRAs would revert to the general assets of the Plan.

Certain benefits provided to retirees, reflected as post-retirement benefit obligations in the statements of benefit obligations, are being funded by current employer contributions and monthly co-payments from retirees. Retiree benefits are not guaranteed. Benefits for retirees are paid as long as the income and net assets provide sufficient excess funds over those required for payment of health benefits for active participants, as determined at the discretion of the Trustees. If such funds are insufficient, the subsidy of retiree benefits may cease or be reduced significantly. In either event, retirees may make increased self-payments to continue coverage. The costs of the post-retirement benefit plan are shared by the Plan’s participating employers and retirees. In addition to deductibles and co-payments, 26.7% and 25.7% of the estimated cost of providing post-retirement benefits for the years ended December 31, 2024 and 2023, respectively, are through retiree contributions.

Although these benefits were provided by the Plan for the current fiscal year, they are not guaranteed. The Board of Trustees reserves the right to reduce or discontinue these benefits or to increase the contributions and/or co-payments required to fund these benefits.

Continuation of health care benefits for persons who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act (“COBRA”), has been adopted by the Plan.

Participants should refer to the summary Plan description and recent Plan amendments for more complete information.

**3. PRIORITIES UPON TERMINATION**

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

**4. TAX STATUS**

The Plan obtained its latest determination letter, dated June 4, 1996, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**5. FUNDING POLICY**

The Plan is financed by employer and retiree contributions and from members electing COBRA coverage. The monthly contribution rate is agreed to by the parties signatory to the collective bargaining agreements. The monthly retiree and COBRA contribution rates are determined annually by the Board of Trustees in consultation with the Plan's actuary.

**7. POST-RETIREMENT BENEFIT OBLIGATIONS**

Postretirement benefit obligations represent the total actuarial present value of those estimated future benefits that are attributed to employee service rendered as of the valuation date, by employees of participating employers who have elected to provide these benefits. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the postretirement obligation is the portion of the expected postretirement benefit obligation that is attributed to the employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. This obligation was estimated by the Plan's actuary.

The trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the post-retirement obligations for the years ended December 31, 2024 and 2023, by \$43,044,624 and \$45,522,882, respectively.

Some of the more significant actuarial assumptions used to calculate the post-retirement health and death benefit obligations at December 31, 2024 and 2023, are as follows:

**8. MEDICARE SUBSIDY**

On December 8, 2003, the Medicare Prescription Drug, Improvement, and Modernization Act of 2003 (the “Act”), for employers sponsoring post-retirement health care plans that provide prescription drug benefits, was signed into law. The Act introduces a prescription drug benefit under Medicare, as well as a federal subsidy to sponsors of retiree health care benefit plans, providing a benefit that is at least actuarially equivalent to Medicare Part D.

Under the Act, for multiemployer plans, any Medicare subsidy is received directly by the Plan and not the individual employers participating in the Plan. During the years ended December 31, 2024 and 2023, the Plan earned \$273,537 and \$282,516, respectively, in Medicare Part D subsidies; amounts earned but not yet received as of December 31 are recorded as Medicare Part D subsidy receivable. The effect of the Medicare Part D subsidy has been included as a component of the post-retirement benefit cost for the Plan years ended December 31, 2024 and 2023.

**9. CASH CONCENTRATIONS**

The Plan has significant cash balances at financial institutions which throughout the year regularly exceed the federally insured limit of \$250,000. Any loss incurred or a lack of access to such funds could have a significant adverse impact on the Plan’s financial condition, results of operations, and cash flows.

**10. DUE FROM AFFILIATED PLAN**

Employer contributions (and certain participant contributions) for the Plan and other Northern California Sheet Metal Worker plans are paid by employers (and certain participants) with a single monthly check, which is initially deposited into the Sheet Metal Workers of Northern California Pension Fund's (the "Pension Fund") bank account. Employer/employee contributions are then allocated and transferred to this Plan. As of December 31, 2024 and 2023, the transfers due to the Plan from the Pension Fund totaled \$2,626,212 and \$2,553,180, respectively. These amounts have been recorded as "due from affiliated plan" on the statements of net assets available for benefits. The Plan and the Pension Fund are related in that several Trustees of the Plan are also trustees of the Pension Fund.
