Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the financial statements of the Kruse Western Holdings, LLC 401(k) and Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements ("Financial Statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the accompanying Financial Statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying Financial Statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (U.S. GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Kruse Western Holdings, LLC 401(k) and Profit Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Kruse Western Holdings, LLC 401(k) and Profit Sharing Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Note 1 – Description of the Plan

Kruse Western Holdings, LLC 401(k) and Profit Sharing Plan (the “Plan”) is a defined contribution plan covering substantially all eligible employees of Kruse Western Holdings, LLC (the “Plan Sponsor”), and the employees of related employers participating in the Plan, including: Artois Feed, LLC, Kruse Investment Company, Inc., Western Foods Operating Company, LLC, Western Foods Grimes Ops, and Winema Elevators, LLC (collectively the “Employers”). The Plan became effective January 1, 2022, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All Plan assets are held by Empower Trust Company, LLC (“Empower”). Participants should refer to the plan document for a more complete description of the Plan’s provisions.

Administration - The Plan Sponsor has contracted with Empower to act as the custodian to the Plan, as well as an affiliate of Empower to process and maintain the records of participant data.

Eligibility – The Plan covers substantially all employees of the Employers except union employees covered by a collective bargaining agreement, leased employees and certain nonresident aliens. Eligible employees who are at least 18 may participate in the Plan after completing three months of service, as defined in the plan document. Participants must be employed on the last day of the Plan year, and complete a minimum of 1,000 hours of service, as defined in the plan document, during a Plan year to be eligible to receive Employers discretionary non-elective contributions.

Contributions - Participants are allowed to make elective pre-tax or Roth contributions to the plan of up to 100% of their annual eligible plan compensation, as defined by the plan document, subject to limitation under the Internal Revenue Code (“IRC”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing rollovers from other qualified retirement plans or individual retirement accounts.

The Employers make safe harbor matching contributions equal to 100% of the first 3% and 50% of the next 2% of the participant’s eligible deferred compensation, as defined in the plan document, for a total of approximately \$341,000 for the year ended December 31, 2024. The Employers are also allowed to make discretionary non-elective contributions to the Plan. For the year ended December 31, 2024, certain Employers contributed approximately \$124,000, net of forfeitures, to eligible employees. A contribution of \$2,000 per employee was declared by related employers Western Foods and Western Foods Grimes Ops. No other Employers made any discretionary non-elective contributions for the year ended December 31, 2024.

Participants direct the investment of contributions to their respective accounts into the investment options offered by the Plan.

Participant accounts - Participants direct the investment of their accounts among various investment options offered by the plan. Participants may change their investment options daily.

Each participant account is credited with (a) the participant’s contributions, (b) an allocation of employer contributions, and (c) certain administrative expenses. Allocations are based on participant earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting - Participants are immediately vested in their elective contributions, rollover contributions, safe-harbor matching contributions, plus earnings thereon. Vesting in the Employers discretionary non-elective contributions, plus earnings thereon, is based on years of credited service, as defined in the plan document; participants start to ratably vest after two years of service, and are fully vested after six years.

Note 1 – Description of the Plan (continued)

Notes receivable from participants - Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum of (a) \$50,000 reduced by the highest outstanding note receivable balance over the prior twelve months or (b) 50% of their vested account balance, whichever is less. Notes receivable from participants (“participant loans”) are secured by the vested balance in the participant’s account balance and bear interest. Principal and interest are paid ratably through payroll deductions over a period generally not to exceed five years, unless the funds are used for purchase of a principal residence, in which case repayment terms may be longer. Participant loans bear a rate of interest equal to the prime rate plus 1%.

Payment of benefits - Upon termination, the participants or beneficiaries may elect to leave their account balance in the Plan or receive their total vested benefits in a lump-sum amount. The Plan allows for the automatic lump-sum distribution of participant vested account balances that do not exceed \$5,000. Distributions are subject to the applicable provisions of the plan document.

In-service withdrawals of all or a portion of a participant’s vested account balance may be withdrawn by a participant after reaching age 59 ½. In-service withdrawals of all or a portion of a participant’s rollover account balance may be withdrawn at any time.

Withdrawals from the Plan may also be made upon circumstances of financial hardship in accordance with the provisions specific in the Plan document.

Distributions from the Plan will normally be subject to income taxes and in certain circumstances may also be subject to Internal Revenue Service (IRS) penalties, unless the distribution is transferred to another qualified plan or individual retirement account.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates - The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits, and changes therein and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition – The investments are reported at fair value. The Plan’s custodian, Empower, certifies the fair market value of all investments. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought or sold as well as held during the year.

Notes receivable from participants – Notes receivable from participants (notes receivable), are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant’s account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. Delinquent notes receivable are reclassified as distributions upon the occurrence of a distributable event based upon the terms of the plan document.

Note 2 – Summary of Significant Accounting Policies (continued)

Payment of Benefits – Benefits are recorded when paid.

Plan Expenses – Certain expenses of maintaining the Plan are paid by the Plan Sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Certain transaction and maintenance fees are paid by the Plan.

Subsequent events – Effective January 1, 2025, the Plan Sponsor has amended the Plan name to the Western Foods LLC, 401(k) Profit Sharing Plan. The amendment had no other changes to the operations of the Plan or the net assets available for benefits of the plan as of December 31, 2024 and 2023. The Plan has evaluated subsequent events through September 25, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024, and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end investments that are registered with the U.S. Securities and Exchange Commission. These investments are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Note 3 – Fair Value Measurements (continued)

Collective Trust Funds: Units held in the collective trust funds (CTs) are valued using the NAV practical expedient of the CTs as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by each CT, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CT is calculated based on a compilation of primarily observable market information. There are no significant restrictions on redemption of units of investment in the funds.

Redemption by the Plan requires a 12-month notice period for the Galliard Stable Return Fund. The CTs may be redeemed daily by participants without restrictions. There are no unfunded commitments in the CTs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Tax Status

The Plan has adopted a non-standardized pre-approved plan document that has received an opinion letter dated November 14, 2022, from the IRS. The Plan Administrator believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Internal Revenue Code (IRC) and related state statutes, and therefore is exempt from federal income and state franchise taxes.

In accordance with guidance on accounting for uncertainty in income taxes (ASC 740-10), management evaluated the plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is at least reasonably possible given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

Note 6 – Information Certified by the Custodian

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, the custodian of the Plan, has certified to the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and notes receivable from participants reflected on the schedule of assets (held at end of year).

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 8 – Related-Party and Party in Interest Transactions

Certain Plan investments are managed by Empower, the Custodian of the Plan and, therefore, these transactions qualify as party in interest transactions. The Plan Sponsor pays certain fees and expenses on behalf of the Plan. These transactions qualify as party in interest transactions; however, they are exempt from prohibited transaction rules under ERISA.
