## INDEPENDENT AUDITORS' REPORT

To the Trustee and Plan Administrator of

### **Chesapeake Plumbing & Heating, Inc. 401(k) Profit Sharing Plan**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of Chesapeake Plumbing & Heating, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

( 1 ) Description of plan

The following description of the Chesapeake Plumbing & Heating, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan's adoption agreement and Basic Plan Document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

**General** - The Plan is a defined contribution plan sponsored by Chesapeake Plumbing & Heating Inc. (the "Company" or "Plan Sponsor") for the benefit of nonunion and U.S. resident employees who have completed one year of service and who are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions** - Participants may contribute a percentage of annual compensation as pre-tax contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover), if any. Additionally, participants aged 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan.

Participants are eligible to receive discretionary employer safe harbor matching contributions after completing one year of service. For the year ended December 31, 2024, the Company matched 100% of the first 3% of compensation that a participant contributed to the Plan, and an additional 50% of the next 2% of compensation thereafter. The Company may also make discretionary profit sharing contributions. No profit sharing contributions were made for the year ended December 31, 2024.

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market fund as investment options for participants. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

**Participant accounts** - Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's contribution and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - Participants' contributions and the employer safe harbor matching contributions plus actual earnings are 100% vested immediately. Vesting in the employer profit sharing portion of their accounts is based on years of continuous service. A participant is 100% vested in employer profit sharing contributions after six years of credited service.

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at the Wall Street Journal Prime Rate plus 1%. Principal and interest are paid ratably through payroll deductions.

#### ( 1 ) Description of plan (continued)

**Payment of benefits** - On termination of service due to death, disability, or retirement, a participant or his or her beneficiary(ies) may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments at least equal to the required minimum distribution amount. For termination of service due to other reasons or upon qualifying instance of hardship, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Balances under \$7,000 for terminated employees are distributed in a lump sum at the discretion of the Plan Sponsor.

#### ( 2 ) Summary of significant accounting policies

**Basis of accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Contributions** - Contributions from Plan participants and the discretionary matching contributions from the Company, if any, are recorded in the year in which the employee contributions are withheld from compensation.

**Notes receivable from participants** - Notes receivable from participants is measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are deemed to be distributions based on the terms of the Plan's adoption agreement.

**Payment of benefits** - Benefits are recorded when paid.

**Administrative expenses** - Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Investment-related expenses are included in net appreciation in fair value of investments.

#### ( 3 ) Information prepared and certified by the custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, the custodian of the Plan.

#### ( 4 ) Fair value measurements

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820, “*Fair Value Measurements and Disclosures*,” provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used as of December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued at the Net Asset Value (“NAV”) of shares held by the Plan at year end. Mutual funds and the money market fund held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds held by the Plan are deemed to be actively traded.

All of the Plan’s investments at fair value are considered to be Level 1 investments within the fair value hierarchy.

#### ( 5 ) **Related-party transactions and party-in-interest transactions**

Certain Plan investments are shares of mutual funds and a money market fund managed by Capital Bank and Trust Company, the custodian for the Plan. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. The Plan paid certain expenses to various service providers such as the custodian, recordkeeper, and retirement advisors of \$4,091 for the year ended December 31, 2024. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

#### ( 6 ) **Risk and uncertainties**

The Plan currently invests in various investment securities. Investment securities are exposed to various risks, such as interest, market, and credit. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

#### ( 7 ) **Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer profit sharing contributions.

#### ( 8 ) **Tax status**

The Internal Revenue Service ("IRS") has determined that the custodian's prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the IRC and informed the custodian of such in a letter dated June 30, 2020. The Plan has adopted the prototype Plan document, and the plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that "more likely than not" would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### ( 9 ) **Delinquent participant contributions**

For the years ended December 31, 2023 and 2022, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. For the year ended December 31, 2023, untimely remittances identified on the Schedule of Delinquent Participant Contributions totaled \$10,126, which have been corrected by funding the lost earnings during 2024. For the year ended December 31, 2022, untimely remittances totaled \$77,427, of which \$76,885 were corrected by funding the lost earnings during 2023, and the remaining \$542 of untimely remittances were corrected by funding the lost earnings during 2024, which have been identified on the Schedule of Delinquent Participant Contributions.

#### ( 10 ) **Subsequent events**

The Plan has evaluated subsequent events through September 11, 2025, which is the date the financial statements were available to be issued.



