**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The Los Angeles Country Club 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

Note 1 - Description of Plan

The following description of The Los Angeles Country Club 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provision.

a. **General.** The Plan is a defined contribution plan covering all eligible employees of The Los Angeles Country Club ("the Club") who have one year of service, at least 1,000 hours of employment and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Trustee of the Plan is Fidelity Management Trust Company (the "Trustee").

b. **Contributions.** The Club automatically enrolls eligible participants with a deferral of 3% of compensation. Participants must elect to opt-out of the automatic enrollment. Participants contribute a percentage of pretax annual compensation, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover"). The Plan offers various funds maintained by a mutual fund. Participants direct the investment of their contributions into various investment options offered by the Plan. The Club's Safe Harbor matching contribution is 100% of the first 3% of the employee deferral and 50% of the next 2%. In addition, the Club may decide each year to make a discretionary non-elective employer contribution on behalf of participants in the ratio that each participant's compensation bears to the total compensation for all participants for that year. The Club's contribution is invested in the same proportion as that directed by the participant for their contribution. The Plan permits the employer to reduce its contributions by the amount of forfeitures, if any. During the year ended December 31, 2024 no forfeitures reduced contribution paid by the Club. For the year ended December 31, 2023, forfeitures to reduce contributions paid by the Club were \$1,607.

c. **Participant Accounts.** Each participant's account is credited with the participant's contribution and an allocation of (a) the Club's matching and discretionary non-elective contributions and (b) Plan earnings and if the account balance is \$10,000 or more, is charged with a fixed record keeping fee per quarter. The participant is entitled to the benefit provided from the participant's vested account.

d. **Vesting.** A Participant is immediately fully vested in all employee contributions and employer matching contributions. A Participant is fully vested in the Club's non-elective employer contributions upon completion of three years of employment.

e. **Payment of Benefits.** On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum or in annual installments over a period as specified by Internal Revenue Service Regulations. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, subject to the appropriate Internal Revenue Service income tax withholding regulations.

f. **Notes receivable from participants.** Participants may borrow from their fund accounts in accordance with the plan document, not to exceed the lesser of \$50,000 or 50% of their vested account balance. Participants may have only one note receivable outstanding at any given time. Each note receivable is secured by the balance in the participant's account and bears interest at rates which are commensurate with local prevailing rates as determined from time to time by the Plan Administrator. Principal and interest is paid ratably through payroll deductions each payroll period.

NOTES TO FINANCIAL STATEMENTS

Note 2 - Summary of Accounting Policies

a. **Basis of Accounting.** The financial statements of the Plan are prepared using the cash method of accounting which from year-to-year is not materially different than the accrual method of accounting.

b. **Investment Valuation and Income Recognition.** Investment contracts held by a defined-contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The value of investments held as of each accounting date is determined based on the fair value of each underlying fund's investments principally using quoted market values from national exchanges. Purchases and sales of investments are reflected on a trade-date basis. The statement of net assets available for benefits includes the net appreciation (depreciation) in the fair value of investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Pooled separate accounts are reported at the closing net asset value per unit of participation as determined by the Plan's Trustee based upon the respective fund/portfolio as of the last business day of the Plan year. The purchase or redemption price of the units is determined based on the current net asset value per unit of participation. The value per unit is determined by the Trustee using the market values of the underlying assets or the fair values as determined by the Trustee in the absence of an available market price.

c. **Payment of benefits.** Benefits are recorded as paid.

d. **Estimates.** The preparation of financial statements requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

e. **Notes Receivable from Participants.** Notes receivable from participants are measured at unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses are reflected in the accompanying statements of net assets available for benefits.

f. **Subsequent events.** The Plan has evaluated subsequent events through the date the financial statements were available to be issued, September 16, 2025. Due to various conditions within the United States of America and globally, the Plan's various investment securities have experienced volatility in their fair values. It is reasonably possible that these conditions have materially affected participants' account balances and may continue to impact the accounts into the future.

Note 3 - Cash Equivalents

The Plan considers as cash equivalents amounts held in bank checking and money market accounts.

Note 4 - Information Prepared and Certified by Trustee

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan management instructed the plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Fidelity Management Trust, the trustee of the plan, as complete and accurate, except for comparing such information certified by the trustee with information included in the plan's financial statements and supplemental schedules:

Note 5 - Fair Value Measurements

The framework for measuring fair value provides fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective trust fund: Valued at the NAV of units of a common collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

These methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. The Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 - Tax Status

The Internal Revenue Service has determined and informed the Trustee of the Plan that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to routine audits by taxing jurisdictions. Currently no audits for any tax periods are in process. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2020.

Note 7 - Related-Party Transactions and Party-in-interest

Certain plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Investments is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Administrative fees presented on the accompanying statement of changes in net assets were paid to Fidelity Investments.

Note 8 - Expenses

The Club, as sponsor, pays certain record keeping fees and other administrative expenses on behalf of the Plan. Record keeping fees are charged based solely on a fixed fee per participant and are included only in administrative expenses. Record keeping fees for participants' accounts with balances of less than \$10,000 are paid by the Club. Record keeping fees for participants' accounts with balances of \$10,000 or more are charged directly to each participant's account. All expenses, including record keeping fees, related to 1) terminated participants, or participants otherwise no longer actively employed by the Club, and 2) the administration of notes receivable from participants, are charged directly to the participant's account and are included in administrative expenses. Total record keeping fees charged to the Plan for years ending December 31, 2024 and 2023 were \$30,884 and \$28,441 or 0.16% of investment balances.

Expenses, other than record keeping fees, that are paid from the Plan's forfeiture account are also included in administrative expenses. Expenses, other than record keeping fees, that are paid directly by the Club are excluded from these financial statements.

Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### Note 9 - Plan Termination

Although it has not expressed any intent to do so, the Club has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants remain 100 percent vested in their accounts and would be fully vested in the elective portion.

#### Note 10 - Risks and Uncertainties

The Plan's investments in mutual funds are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for plan benefits.
