INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of the
La Michoacana Meat Market 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the La Michoacana Meat Market 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

Note 1 - Description of the Plan

The following description of the La Michoacana Meat Market 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan sponsor is Michoacana Marketing Services, LLC (the Company). The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Progreso Management Services, LLC (PMS) is a participating employer in the Plan. Effective January 10, 2024, El Ahorro Services, LLC, Ortega SB Interests, LLC, and Excel Distribution, LLC were added as participating employers in the Plan.

Administration

The Plan's investment Custodian is John Hancock Life Insurance Company (U.S.A.) (John Hancock). The investment Custodian holds all of the Plan's assets and executes all of the Plan's transactions. Participant recordkeeping is performed by John Hancock Retirement Systems. The Plan Administrator is the Company. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance and fees. The Plan maintains Company officers as the Trustees of the Plan. The Plan utilizes Loren D. Stark Company for compliance and administration services.

Eligibility

All employees are eligible to participate in the Plan upon the attainment of age 21 and completion of one year of service. The Plan has entry dates on the first day of the Plan year and the first day of the seventh month of the Plan year. Effective January 1, 2024, eligible employees can enter the Plan at any time upon meeting the eligibility requirements.

Contributions to the Plan

Each year, participants may contribute up to 100% of eligible compensation, as defined in the plan document, through payroll withholdings. Participants who have attained age 50 before the end of the year are eligible to make additional 'catch-up' contributions. Participants may also contribute amounts representing distributions from other defined benefit or other defined contribution plan (rollovers).

The Company may make discretionary matching contributions as determined by resolution of its Board of Directors. During 2024, the Company made discretionary matching contributions of 50% of participant contributions up to 6% deferral rate in the amount of \$107,159. In order to be eligible for the discretionary matching contributions, participants must be 21 years of age and have completed one year of service.

The Company may also make discretionary profit-sharing contributions as determined by resolution of its Board of Directors. No discretionary profit-sharing contributions were made for the year ended December 31, 2024.

Participants direct the investment of their individual contributions into various investment options offered by the Plan. The Company's contributions are allocated in the same manner as that of the participant's elective contributions.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Benefits are payable from participant account balances upon termination of service due to death, disability or retirement or other reasons. On termination of service, participants with vested account balances of \$5,000 or less are subject to involuntary cash-outs, in which automatic distribution of their account balance will occur without direct consent unless they elect a rollover. Participants whose vested account balances exceed \$5,000 may elect to receive equal installment payments or a lump-sum equal to the value of the participant's vested interest in his or her account.

The Plan allows for in-service distributions from vested account balances upon attainment of age 59 1/2 for any reason. The Plan also allows for in-service distributions prior to attainment of Plan's normal retirement age due to financial hardship as defined in the Plan document, from vested account balances.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contributions is based on years of service. A participant begins vesting after one year of service and is fully vested after five years of credited service. Participants are fully vested upon death or permanent disability.

Forfeited Accounts

As permitted by the Plan, forfeitures of non-vested accounts are used to reduce future Employer contributions or to pay Plan expenses. As of December 31, 2024 and 2023, the Plan had \$12,672 and \$11,434, respectively of forfeitures available for future use. During 2024, no forfeitures were used to pay Company matching contributions or Plan expenses.

Participant Notes Receivable

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as participant-directed investments. Loan terms range from one to five years. Loan terms may exceed five years only in the event the loan proceeds are used to purchase or construct the participant's principal residence. Loans are secured by the balance in the participant's account and bear interest at a rate established by the Plan Administrator in a nondiscriminatory manner. Principal and interest is paid ratably through payroll deductions.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). Income from investments is recorded when they are earned. Employee contributions are recorded when withheld from pay. Employer contributions are recorded in the period to which they pertain. Expenses are recorded in the accounting period in which they are incurred.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Participant Notes Receivable

Participant notes receivable are measured at their unpaid principal plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Fees and Expenses

Professional fees incurred to operate the Plan, such as attorney and audit fees are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of benefit payments are charged directly to the participant's accounts and are included in administration expenses. Direct fees for custodian and recordkeeping services are paid by the Plan and are also included in administration expenses. Investment related expenses are included in the net depreciation of fair value of investments.

Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Note 3 - Unaudited Investment Information Certified by Custodian

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by John Hancock (the Custodian of the Plan) as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditor:

1. All investment balances reflected in the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023,
2. All investment activity reflected in the statement of changes in net assets available for plan benefits for the year ended December 31, 2024,
3. All investment-related information included in the Supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and
4. Notes receivable from participants as of December 31, 2024 and 2023 and the related income on notes receivable from participants for the year ended December 31, 2024.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 6 - Federal Income Tax Status

The Plan has adopted a volume submitter plan, which obtained its latest determination letter on November 30, 2020, in which the IRS stated that the Plan, as then designed was in compliance with the applicable requirements of the Internal Revenue Code (Code). Although the Plan has been amended since receiving the latest determination letter, the Plan Administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Code and that the Plan and related trust continue to be tax exempt.

Effective January 1, 2022, the Plan was amended and restated in its entirety to comply with the IRS Cycle 3 restatement requirement.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024, the Plan Administrator believes that the Plan has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, the Plan is currently not being examined.

The Plan has adopted mandatory provisions of the SECURE Act 2.0. Written amendments to the Plan document to reflect these operational changes will be executed at a later date in accordance with deadlines pursuant to applicable laws and IRS guidance.

Note 7 - Party-in-Interest Transactions

Certain plan investments are managed by John Hancock, the Plan's Custodian. In addition, the Plan pays direct compensation to the third-party administrator related to recordkeeping and administration services. Indirect compensation (that is netted against investment income on the statement of changes in net assets available for benefits) is paid to the Custodian from total annual operating expenses charged on the balance of fund investments, depending on the particular fund. Transactions involving these investments and services are considered party-in-interest transactions; however, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

Note 8 - Risks and Economic Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Prohibited Transactions

Department of Labor (DOL) Regulation 2510.3-102 requires employers to remit amounts paid by a participant or beneficiary to an employer and/or withheld by an employer for contribution to a 401(k) plan as soon as they can be reasonably segregated from the employer's general assets. Any contributions and loan repayments remitted to the plan beyond the time frame set forth by this criterion was considered a prohibited transaction and in violation of the provisions of ERISA and the Internal Revenue Code.

As reported on Form 5500, Schedule H, Line 4a - Schedule of Delinquent Participant Contributions, certain participant contributions were not remitted to the Plan within the time frame specified by the Department of Labor's ("DOL") Regulation 29 CFR 2510.3-102, thus constituting prohibited transactions between the Plan and the Company during the 2024 plan year. Late remittances totaled \$854 for 2024. The delinquent participant contributions from the 2024 plan year were not corrected as of December 31, 2024. Plan management is currently working with its third-party administrator on corrections and anticipates processing corrections by December 31, 2025. The Plan Sponsor believes that with the completion of these corrections, the Plan will continue to be in compliance with applicable requirements of the Code.

Note 10 - Subsequent Events

Management of the Plan has evaluated subsequent events through October 1, 2025, the date which the financial statements were available to be issued. Management has determined that no subsequent events require recognition or disclosure in these financial statements.
