## **Independent Auditor's Report**

To the Plan Administrator of the

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Transcom 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Note 1 – Description of the Plan

The following description of the Transcom 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan Document for a more complete description of the Plan's provisions.

**General.** The Plan is a defined contribution plan, which went into effect October 1, 2016, that is generally available to all employees of Transcom Worldwide U.S. (the "Company", "Plan Sponsor", or "Plan administrator") and Transcom Worldwide USA LLC, a participating employer (collectively, the "Employer"), who are age 18 or older and who have completed one month of service. The Plan excludes leased employees. Employees may enter the Plan on the first of the month coincident with or following the date they meet the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

**Contributions.** The following types of contributions are allowable under the Plan:

- Elective Deferral Contributions – Participants may contribute up to 90% of their eligible pre-tax compensation, as defined in the Plan document, subject to limitations. Participants may also contribute a percentage of their after tax compensation and designate it as a Roth deferral contribution. A participant's total contribution cannot exceed \$23,000 (\$30,500 if 50 or older) in 2024.
- Employer Matching Contributions – The Employer makes matching amounts to eligible participants each payroll period. For the year ended December 31, 2024, the Employer matched 50% of the participant's elective deferrals up to 6% of the participant's compensation.
- Rollover Contributions – Certain amounts distributed to participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan's investment funds at the direction of the participants.

**Participant Accounts.** Each participant's account is credited with the participant's contributions (elective deferrals and rollovers), the Employer's matching contribution, and Plan earnings, and charged with payments of benefits and an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options.** Participants may direct their investments into various registered investment companies and common collective trusts.

**Vesting.** Participants are immediately 100% vested in their elective deferral and rollover contributions plus actual earnings thereon. Vesting in the Employer matching contributions is based on a five year graded vesting schedule, whereas a participant becomes 100% vested after five years of service. Participants also become 100% vested upon reaching normal retirement age of 65, death, becoming disabled, or upon Plan termination or partial Plan termination.

**Forfeitures.** When certain terminations of participation occur, the non-vested portion of a participant's account represents a forfeiture. Forfeitures can be used to reduce future Employer contributions or can be used to pay administrative expenses of the Plan. During 2024, forfeitures of \$83,430 were used to reduce Employer contributions and forfeitures of \$4,656 were used to pay administrative expenses of the Plan. As of December 31, 2024 and 2023, unutilized forfeitures totaled \$4,119 and \$8,027, respectively.

**Payment of Benefits.** Benefits to participants or beneficiaries generally are payable as a lump sum equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. A terminated employee with a balance of less than a certain dollar threshold, as defined by the Plan document, may be automatically paid out by the Plan upon termination. Participants may also elect to rollover their vested account balance into an IRA or another qualified plan. Additionally, participants may request in-service withdrawals upon attainment of age 59½, for a qualified reservist distribution, or upon incurring a financial hardship, as defined in the Plan

### Note 2 – Summary of Significant Accounting Policies

**Basis of Accounting and Use of Estimates.** The financial statements of the Plan are prepared using the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions.** Participant contributions and the related Employer matching contribution are recognized in the period in which participant contributions are withheld from compensation.

**Benefits Payments.** Benefits are recorded when paid.

**Expenses.** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Included in administrative expenses are recordkeeping and other expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

### Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Registered investment companies ("RICs") are valued at the quoted net asset value ("NAV") of shares held by the Plan at year end; and
- Common collective trusts ("CCTs") are valued at the NAV of units held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- (a) The Putnam Stable Value 15 Fund's ("Putnam SVF") investment strategy is to preserve principal and achieve high current income through a diversified portfolio of high-quality investment contracts. The underlying investments of the common collective trust fund include cash alternatives, GICs, managed synthetics, and constant duration synthetics.

The investment objective of the TRP Retirement Trust CCTs is to invest over time primarily in a diversified portfolio of underlying trusts that represent various asset classes and sectors. Over time, the Retirement Trust CCTs allocation to bonds will increase and their allocation to stocks will decrease. The Trusts will receive their final most conservative allocation of approximately 30% stocks 30 years after reaching their target date.

- (b) The Plan Sponsor must provide a 5 business day notice upon the Plan's complete withdrawal from the Putnam SVF.

The Putnam SVF is intended to be a long-term investment vehicle and is not designed to provide investors with a means of speculating on short-term market movements. A pattern of frequent acquisitions and dispositions of Units can be disruptive to efficient management of the Fund. Accordingly, if the Fund's Trustee determines in its sole discretion that the Participating Trust (or any participants in the Participating Trust) is or may be following a market-timing strategy or is otherwise engaging in excessive trading, the Fund's Trustee reserves the right to reject or restrict acquisition or disposition requests from such Participating Trust (or participants in such Participating Trust).

- (c) Under the terms of the Declaration of Trust for the TRP Retirement Trust CCTs, unitholders may be required to provide up to 30-days advance written notice to the trustee prior to redemption of trust units; the notice period may be shortened or waived by the trustee in its sole discretion.

### Note 4 – Certified Information

The following information disclosed in the accompanying financial statements and ERISA-required supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan:

- Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Investment amounts, as shown in Note 3;
- Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024; and
- The investment information in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the supplemental schedule.

### Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination or a partial Plan termination, affected participants will become 100% vested in their accounts.

### Note 6 – Tax Status

The Company has adopted an ADP, LLC Non-Standardized Pre-Approved Profit Sharing Plan ("pre-approved plan"). The pre-approved plan received a favorable opinion letter from the Internal Revenue Service ("IRS") on October 6, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the pre-approved plan and Plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related Trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

The Plan's trustee, Reliance Trust Company; the Plan's third-party administrator, ADP; the Plan's investment advisor; the Plan's auditors; the Employer; and Plan participants are all parties-in-interest to the Plan. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

### Note 8 – Concentrations, Risks, and Uncertainties

The Plan provides for various investment options in registered investment companies and common collective trusts. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the statements of net assets available for benefits. As of December 31, 2024 and 2023, there was/were one and three investment(s), respectively, which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

### **Note 9 – Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 22, 2025, which is the date the financial statements were available to be issued.
