Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Kenshoo, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. Description of the Plan

General

The following description of the Kenshoo, Inc. 401(k) Plan (Plan) is provided for general information purposes only. The Plan is sponsored by Skai (the “Company”). Participants should refer to the Plan document for more complete information.

The Plan was effective January 1, 2013, restated most recently effective July 1, 2022, and is a defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Internal Revenue Code of 1986, as amended.

Eligibility

The provisions of the Plan provide that, in general, any person employed by the Company will be automatically enrolled as a participant in the Plan unless they specifically decline to enroll in the Plan. Eligible employees may begin participation in the Plan the first day of the month following date of hire.

Contributions

Employee Contributions:

Participants are able to make Pre-tax Elective Deferrals or Roth Elective Deferrals. Participants are permitted to contribute up to \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively, limited to 90% of their eligible earnings.

The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at five (5%) percent of eligible compensation and their contributions invested in a designated fund until changed by the participant.

Participants who have attained age 50 by the end of the Plan year may make additional “catch-up” contributions, of up to \$7,500 in 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Employer Contributions:

Plan provides for an employer match of 100% of a participant’s salary deferrals up to four (4%) percent of the participant’s eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, Plan earnings (loss), and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant's account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants are immediately 100% vested in their elective deferral contributions plus any actual earnings thereon. Employer matching contributions vested according to the schedule below:

<u>Years of Service</u>	<u>Vested %</u>
Less than 1 year	33%
At least 1 year, but less than 2	66%
2 years or more	100%

Forfeitures

Forfeited non-vested accounts are used to offset employer contributions. At December 31, 2024 and 2023, the unused portion of forfeited non-vested accounts totaled \$23 and \$13, respectively. During 2024 and 2023, \$16,228 and \$31,824, respectively were used to reduce employer's matching contributions, in accordance with the plan documents.

Investment Options

Upon enrolling in the Plan, participants may direct deferrals into a variety of investment options in a selection of mutual funds. The selection of mutual funds offered range from fixed-income, equity, money market and a blend of fixed-income and equity portfolios.

Notes Receivable from Participants and In-Service Withdrawals

Participants may borrow, in certain situations, from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. There can be a maximum of two active loans at a time. The loans are secured by the balance in the participant's account. The loan interest rate is set at two (2%) percent above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions. Loans must be fully repaid within 5 years unless the loan is used for the purchase of a primary residence, in which case the loan must be repaid within 30 years.

Employees may withdraw all or part of their fund balance once they reach age 59½.

Benefit Payments

On termination of service due to death, disability, termination or retirement, a participant may elect to receive the value of their accumulated plan benefits as a lump-sum distribution if the value of their account is \$5,000 or less. If the account balance is greater than \$5,000 employees have the option of a direct rollover into an IRA or Roth IRA, as allowed by law, or defer receiving payment until attaining the age of 70 ½.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosures of contingent assets and liabilities at the date of the financial statements, and reported amounts of changes in net assets during the period. Actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowances for credit losses has been recorded as of December 31, 2024 or 2023.

Investment Valuation and Income Recognition

The investments of the Plan are stated at fair value as of the end of the year. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note 3 for information related to the Plan’s valuation methodologies.

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in market value of investments held at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

For detailed information on each fund’s investment and concentrations of credit risk, the Prospectus and the Annual Report are available from Reliance Trust Company.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

3. Fair Value Measurements

The Plan's investments are stated at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels.

- Level 1 inputs consist of quoted prices for identical assets or liabilities for active markets that the Plan has the ability to access and have the highest priority.
- Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 inputs are unobservable and significant and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments

Following is a description of the valuation methodologies used for assets or liability's measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are actively traded.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

4. **Related Party Transactions and Party in Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, and employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Plan investments in the self-directed brokerage fund are managed by the Trustee; therefore, these transactions qualify as party-in-interest transactions. Transactions with parties-in-interest also include fees paid during the year for trustee, accounting, and other services, as well as contributions paid to the Plan by the Company and loans made to participants. All of these transactions are exempted from prohibited transaction rules under ERISA.

Reliance Trust Company is the trustee as defined by the Plan is responsible for the safekeeping of the Plan's trust fund. The Company is the plan administrator and is responsible for the management and administrative duties of the Plan. Plan investments are managed by Sequoia Investment Management Company. ADP Retirement Services is the record-keeper. Fees paid by the Plan for the investment management services amounted to \$66,743 for the year ended December 31, 2024.

5. Information Prepared and Certified by The Plan's Trustee

The Plan administrator elected the method of compliance as permitted by 29 CFR 252.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator limited auditing procedures with respect to the investment information certified by Reliance Trust Company, the Trustee of the Plan, which included total investments as of December 31, 2024 and 2023, the total investment income for the year ended December 31, 2024, and all information included in the supplemental schedule H, line 4i-schedule of assets (held at end of year).

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Reliance Trust Company.

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$3,160,110.

During 2024, the Plan's interest and dividends were \$982,490.

6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants automatically become 100 percent vested in the balances of their individual accounts.

7. Income Tax Status

The IRS has determined and informed the Company by a letter dated July 8, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

8. Risk and Uncertainties

The Plan invests in various investment securities. The Plan's investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. Reconciliation of Financial Statements to Form 5500
