INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators and Participants of the
Sterling Computers Retirement Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sterling Computers Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520. 103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520. 103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America. And for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibilities for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for the year ended December 31, 2024.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. DESCRIPTION OF PLAN

The following description of the Retirement Savings Plan (the Plan) for employees of Sterling Computers provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan was effective January 1, 2004. The Plan is a defined contribution plan allowing all employees to make contributions. Eligibility for participation in the Plan is based upon having attained age 18. Plan entrance dates are the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may voluntarily elect to contribute from 1% to 100% of their total eligible compensation (as defined by the plan document) provided that the contribution does not exceed limitations set by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions provided they do not exceed IRS limitations. Participants may elect to either contribute to the Plan on a pre-tax basis or use after-tax Roth contributions. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or contributions plans. Tax on the pre-tax amounts contributed is deferred until the funds are withdrawn from the Plan.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, and fixed income funds as investment options for participants. The Plan makes a matching Safe Harbor contribution equal to 100 percent of the first 3 percent, and 50 percent of the subsequent 2 percent of an employee's aggregate salary contribution reduction to the extent the aggregate contribution does not exceed 5 percent of compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The Plan has adopted Safe Harbor provisions and participants are immediately eligible and vested in Sterling Computer's contribution plus actual earnings thereon. Employer matching and additional contributions other than the Safe Harbor contributions vest at a rate of 25 percent for each year of service until a participant is 100 percent vested after four years of continuous service. Continuous service is one in which the employee has had 1,000 or more service hours per year.

Benefits

The Plan provides for normal retirement benefits to be paid upon attaining age 65 or actual retirement date, if later; and for total disability and death benefits for employees and/or beneficiaries eligible to receive such benefits. Total disability and death benefits are determined in accordance with the provisions of the Plan. Upon termination of services, if a participant's vested account is not greater than \$5,000, the vested portion of the account shall be distributed to the participant in a single lump sum payment.

Distribution Requirements

Distributions to a participant are required when the participant reaches age-based requirements in accordance with IRS regulations.

Forfeited Accounts

During the year ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$49,635 and \$1, respectively. These accounts were used or will be used to reduce future employer contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000. Participants may have a maximum of two such loans outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at rates that are based on the prime rate of interest published by any lending institution as of the date of the loan plus two percent. The notes are presented on the accrual basis of accounting.

Once the interest rate is determined, the amount of the loan will be amortized according to the selected repayment terms. Each repayment will include both principal and interest until the loan is no longer outstanding in the plan.

With limited exceptions, loans are required to be repaid through level installment payments at least quarterly, over a period not to exceed five years. Upon termination, the participant is required to pay off the loan balance or have the outstanding loan treated as a taxable distribution. Management believes the loans have a high probability of being collected and thus they have decided not to accrue an allowance for uncollectible notes from participants. Since its implementation in the Plan, none of the notes receivable have been written off as uncollectible.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America and in accordance with the terms of the plan agreement.

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are carried at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is measured at the end of the year if there is an active market for the investment. For investments with no quoted market price, fair value is determined based on the yields currently available on similar instruments. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and capital gains include the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by Sterling Computers. Expenses that are paid by Sterling Computers are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments. Certain administrative functions are performed by officers or employees of Sterling Computers. No such officer or employee receives compensation from the Plan.

Subsequent Events

The plan has evaluated subsequent events through September 15th, 2025, the date the financial statements were available to be issued.

3. PLAN TERMINATION

Although it has not expressed any intent to do so, Sterling Computers has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participant accounts would become 100% vested and non-forfeitable as of the effective date of complete termination of the Plan.

Accordingly, as permitted under such election, the Plan’s independent auditors did not perform any auditing procedures with respect to the following information certified by Reliance Trust Company (Trustee), except for comparing such information certified by the trustee to information included in the Plan’s financial statements and supplemental information:

5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Boards (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Quoted market prices in active markets for identical assets or liabilities.
- Level 2 Inputs to the valuation methodology include
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from and corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Unobservable inputs that are not corroborated by market data.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: The shares of mutual funds are actively traded in a public exchange and the quoted prices at which these securities trade in the exchange are readily available. These quoted prices are used to determine the fair values of mutual fund shares held by the Plan at year-end. Mutual funds are classified as Level 1 investments.

Common/collective trusts: Valued at the fair value of shares held by the plan at year end. Inputs for valuation and other share value disclosures can be found in the plan’s commingled pool participation agreement, prospectus, or through each fund’s investment manager provider.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ADP Retirement Services is the custodian of the Plan therefore these transactions qualify as party-in-interest transactions. The fees paid by the Plan for the years ended December 31, 2024 and 2023 to ADP Retirement Services were approximately \$59,000 and \$50,000 respectively. Separately, investment expenses paid to other fund managers through fund operating expense ratios amounted to approximately \$76,000 for the years then ended.

7. TAX STATUS

The plan document is a prototype defined contribution plan that received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

9. ASSETS HELD BY TERMINATED EMPLOYEES

At the Plan year end, terminated employees held \$1,356,091 of Plan assets. We did not note any requested funds at the Plan year end which have not yet been received by the participants.
