**Note 1: Description of the Plan**

The following description of the Litchfield Cavo LLP 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of Litchfield Cavo LLP (Firm) as set forth in the plan document. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

Reliance Trust Company is the Plan's trustee. ADP is the recordkeeper for the Plan. The recordkeeping agreement provides that the recordkeeper shall keep account of all receipts and disbursements, benefit payments and other transactions and shall provide annually a report setting forth such transactions and the status of the fund at the end of the period.

The amounts in the accompanying financial statements were accumulated from the reports of the recordkeeper.

**Contributions**

Each year participants may contribute up to 85% of annual compensation, as defined in the Plan. Participants may designate their deferral as pre-tax or Roth contributions and contributions cannot exceed \$23,000 in 2024, in accordance with the Internal Revenue Code (IRC). Age 50 and over participants can contribute an additional \$7,500 in 2024, in accordance with the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

New participants are automatically enrolled in the Plan and automatically defer 5% of annual compensation for each payroll period, unless an alternative election is made by the participant.

The Plan has an auto-escalation feature in which the employee's initial automatic deferral amount will increase by 1% of compensation up to a maximum of 15% of compensation; deferral elections made in dollars will be converted to a percentage and increased to the nearest whole percent and deferral election of zero will be escalated to 1%. The escalation provision applies as of the first date of each calendar year.

The Firm will contribute a safe harbor nonelective contribution of 3%, based on a participant's limited gross compensation for the plan year.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of the Firm's contribution and plan earnings and charged with an allocation of investment and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested immediately in their contributions and the Firm's contributions plus actual earnings thereon.

**Investments**

Participants self-direct the investment of contributions into various investment options offered by the Plan. Investment options include a common or collective trust stable value fund and registered investment companies. Participants may change their selection of investments at any time.

***Notes Receivable From Participants***

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions. Interest rates for the outstanding loans range from 4.25% to 9.50% at December 31, 2024.

***Payment of Benefits***

On termination of service due to death, disability or retirement, a participant may receive the value of their account balance in a lump sum.

***Forfeited Accounts***

Forfeited nonvested accounts are used to reduce employer contributions or to pay the Plan's ordinary and necessary administrative expenses. At December 31, 2024 and 2023, there were no forfeitures available for future use. No forfeitures were used during 2024.

**Note 2: Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan have been prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The Plan's investments in shares of registered investment companies are valued at quoted market prices of shares held by the Plan at year end.

The common or collective trust fund is valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by each fund less its liability. There are no participant redemption restrictions for these investments and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There are no unfunded commitments at December 31, 2024 and 2023.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded when paid.

***Administrative Expenses***

Certain administrative and trustee fees related to the general administration of the Plan are paid directly by the Firm and not reimbursed by the Plan. Administrative expenses incurred by the Plan include investment management service fees and are charged directly to participant accounts.

**Note 3: Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted market prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4: Risks and Uncertainties**

The Plan invests in investment securities. Investment securities are exposed to various risks such as changes in interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 5: Financial Information Certified by the Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

**Note 6: Plan Termination**

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA as amended by subsequent legislation.

**Note 7: Tax Status**

The Plan operates under a non-standardized pre-approved profit sharing/money purchase/CODA adoption agreement sponsored by ADP, LLC. This non-standardized plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter dated October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt as of the financial statement.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8: Parties-in-Interest**

Administrative expenses rendered by parties-in-interest for professional fees were \$105,205 in 2024. The Firm provides certain administrative services at no cost to the Plan.

**Note 9: Subsequent Events**

Plan management has evaluated subsequent events October 2, 2025, which is the date the financial statements were available to be issued.
