We have performed audits of the financial statements of Emerson Collective, LLC 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE A - DESCRIPTION OF THE PLAN**

***General***

The Emerson Collective, LLC 401(k) Profit Sharing Plan (the Plan), was formed January 1, 2016, and amended on January 1, 2024 to exclude certain compensation from eligible compensation. The Plan is a defined contribution plan established by Emerson Collective, LLC (Emerson Collective or the Employer) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of Emerson Collective. All employees of Emerson Collective aged 21 and older are eligible to participate following one month of service, with the exception of interns. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The following brief description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***Contributions***

Each year, participants may contribute up to 90% of pre-tax annual compensation, as defined in the Plan, not to exceed the Internal Revenue Service (IRS) limitation, which was \$23,000 for 2024. Participants who have reached the age of 50 by the end of the Plan year may make additional pre-tax "catch-up" contributions up to \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Emerson Collective's matching contribution formula provides a safe harbor matching contribution on behalf of each participant who has made salary deferrals in the Plan year. This contribution is equal to 100% of the first 6% of a participant's compensation deferred. The matching contribution shall be determined on an annual basis and shall be adjusted to the extent necessary after the end of each Plan year. All contributions are subject to and within limitations of the IRS. Participants direct the investments of all contributions into various investment options offered by the Plan.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, rollovers and the participant's portion of the Plan Sponsor's contributions and Plan earnings (losses). A participant may direct the investment of his or her employee and employer contributions in any of the Plan's investment options. The participant may change the investment elections on a daily basis. Earnings, expenses, and gains and losses on investments are allocated based on participant account balances, as defined in the Plan document.

***Vesting***

Participants are immediately vested in all contributions plus actual earnings thereon.

***Payment of Benefits***

Withdrawals from participants' accounts may be made for the following reasons: hardship, attainment of age 59½, normal retirement at age 65, death or totally disabled or termination of employment.

Hardship withdrawals are permitted if certain criteria are met, as defined by the Plan document, and are subject to taxes in the year received.

Distribution of the total of the fair value of a participant's contribution, and the Company's contributions on that participant's behalf (if vested), is made at retirement date, at employment termination or date of death, if earlier, or may be deferred until age 73. Upon termination of service due to death, disability, or retirement,

participants with vested account balances greater than \$5,000 generally receive payments in the form of a lump-sum or installment payments. Participants with vested account balances of \$5,000 or less may receive a single lump-sum payment.

***Participant Loans***

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may only have two notes receivable outstanding at any time. Principal and interest are paid ratably through payroll deductions. Interest rate is determined by the prime rate plus 2%. Loan terms are available up to five years with the exception of loans for the purchase of a primary residence which may extend up to 30 years.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting.

***Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. The investment management fees and operating expenses charged to the Plan were deducted from investment income earned on a daily basis and were included in net appreciation of fair value of investments.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**NOTE C - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform any auditing procedures with respect to information certified by the trustee, except for comparing such information to the related information included in the above named financial statements and supplemental schedule.

**NOTE D - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds: Valued at net asset value (NAV) of shares held by the Plan at year end based upon quoted market prices.

Collective Trust Fund: Valued at NAV of shares held by the Plan at year end, which is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets. The fund seeks to maintain a stable NAV of \$1 per share, however, it cannot guarantee that it will be able to do so. Collective trust funds may include investments that trade in markets that are not considered to be active, but whose values are based on quoted market prices, dealer quotations or valuations provided by alternative pricing sources supported by observable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Levels 1, 2 or 3.

**NOTE E - COMMON COLLECTIVE TRUST**

The Invesco Stable Value Fund (the Trust) is a collective investment trust fund. The Plan is applying the practical expedient as of December 31, 2024 to its investment in the Trust, a common collective trust fund. The Trust's investment objective is to seek the preservation of capital and to provide a competitive level of income over time that is consistent with the preservation of capital. Participants' ownership of the Trust is represented as units. Units are issued and redeemed daily at the Trust's constant NAV of \$1 per unit, see Note D - FAIR VALUE MEASUREMENTS for further details.

The underlying investments of the Trust are primarily in a pool of investment contracts that are issued by insurance companies and commercial banks and in contracts that are backed by high-quality bonds, bond trusts and bond mutual funds. Investment contracts include Synthetic Investment Contracts (SICs) and wrapper contracts. SICs are valued based on the aggregate market value of the applicable bond trusts, mutual funds and other investments. Wrapper contracts are valued at estimated fair value based on a replacement cost approach.

**NOTE F - TAX STATUS**

On October 6, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under IRC Section 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G - PARTY-IN-INTEREST**

The Plan's trustee performs services for, sells products to, and maintains certain investments for the Plan for which fees were charged to the Plan. Party-in-interest transactions also include participant notes receivable. Such transactions, while considered party-in-interest transactions under ERISA, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE I - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE J - SUBSEQUENT EVENTS**

The Plan Administrator has performed an evaluation of subsequent events through September 30, 2025, the date the financial statements were available to be issued. Except for below, management is not aware of any other subsequent events which would require recognition or disclosure in the financial statements.

Effective January 1, 2025, the Plan was amended to exclude certain compensation from eligible compensation.
