Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of T and T Consulting Services 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of T and T Consulting Services 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section—

- the amounts and disclosures in 2024 the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of T and T Consulting Services 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about T and T Consulting Services 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if

there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America. NOTE A – DESCRIPTION OF PLAN

The following description of the T and T Consulting Services 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement and the amendments thereto for a more complete description of the Plan’s provisions.

General

Effective January 1, 2019, T and T Consulting Services, Inc. (“the Company”) established the Plan to provide deferred compensation benefits to its employees. The Plan is a defined contribution plan with 401(k) salary deferral provisions covering all employees of the Company. All employees employed as of the effective date are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan qualifies under the Internal Revenue Code (“IRC”) as a 401(k) Plan.

Contributions

Each year, participants may contribute up to 90% of eligible salary on a pre-tax deferral with a maximum contribution of \$23,000 for 2024. However, participants who are over the age of 50 may make catch-up contributions of \$7,500 for 2024. Participants may also transfer monies from a former employer’s qualified retirement plan, as defined in the Plan’s provisions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan sponsor is required to make a matching contribution equal to 100% of the participant contribution that does not exceed 3% of the participant compensation. Safe Harbor matching contributions for the year ended December 31, 2024 were \$383,935.

Eligible employees may also rollover funds from a former employer’s qualified retirement plan into the Plan. The Company may also make discretionary matching contributions at the option of the Company’s Board of Directors. There were no discretionary employer matching contributions for the year ended December 31, 2024.

Participant Accounts

Plan assets are held by Reliance Trust Company and administered by the Company. Each participant’s account is credited with the participant’s contribution, including amounts rolled over from other qualified plans, and allocations of the Company’s discretionary matching and non-elective contributions, if any, and Plan earnings and losses, less any charges, if applicable. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, employer safe harbor matching contributions and employer non-elective contributions, as well as actual earnings thereon.

Notes Receivable from Participants

A participant may have one loan outstanding. The maximum loan amount available is \$50,000 or one-half of their vested balance in the Plan, whichever is less. The notes are secured by the vested account balance in the participant's account, have a one to five-year permissible term, and bear interest at the prime rate as specified by the Wall Street Journal plus one percent. With the approval of the Plan administrator, loans obtained to secure the acquisition of the participants principal residence may be extended beyond a five-year term. Principal and interest are paid ratably through payroll deductions. The participant also has the option to make additional repayments directly to the Plan.

Payment of Benefits

On termination of service due to death, disability, retirement or any other reason, a participant or beneficiary may elect to receive a lump sum amount equal to the value of participant's vested interest. Unless directed by the participant, payments cannot be deferred beyond the latest of the following:

- Normal retirement date under the plan or age 59 1/2, if earlier.
- Five years of Plan participation.

Generally, on termination of service and at any point in time thereafter, an employee may elect to receive a lump sum equal to his or her vested account balance. However, if the employee's vested balance is less than \$5,000, he or she must receive a lump-sum distribution.

Forfeited Accounts

Forfeitures resulting from terminated participants can be applied towards the employer profit sharing contribution. As of December 31, 2024, there were no forfeited accounts.

Investment Options

Contributions to the Plan are invested by the trustee in various investment funds, according to participant instructions. The Plan Administrator provides participants with current copies of the prospectus describing each investment option.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, additions to net assets, and deductions from net assets, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments and income recognition

Investments are reported at fair value. Quoted market prices are used to value investments in mutual funds. Units in common collective trusts are valued at the net asset value of units held by the plan at year-end, as reported by the trustee. Participant loans are valued at their unpaid principal balance plus accrued interest.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Party-in-interest transactions

Transactions with Reliance Trust Company, the trustee and custodian of the Plan, qualify as party-in-interest transactions under ERISA. See Note I – Related Parties for further disclosure.

ERISA Section 103(a) (3)(C) Audit Election

As permitted by ERISA Section 103(a)(3)(C), the Plan's financial statements are presented in conformity with an audit performed pursuant to this section. Accordingly, investments held and certified by Reliance Trust Company, a qualified bank and custodian, have not been audited by the Plan's independent auditor. The auditor's procedures were limited to information that is not so certified.

Risks and uncertainties

Investment securities are exposed to various risks, including market, interest rate, and credit risk. Further information about investment risks and concentrations is presented in Note F – Risks and Uncertainties

Cash and Cash Equivalents

Cash and cash equivalents represent monies deposited with the Plan Trustee which, at year end, were unallocated to investment accounts.

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants and are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as deemed distributions based on the terms of the plan document and the internal revenue code.

At December 31, 2024 and 2023, participant loans totaled \$30,201 and \$24,916, respectively. These balances exclude loans that have been deemed distributed but remain outstanding in the recordkeeping system. Deemed distributed loans are reported as taxable distributions to participants in the year of default and are not reflected as assets of the plan. The plan's trust report reflects both active loans and deemed distributed loans; however, for purposes of these financial statements, only active loans are included in notes receivable from participants.

Benefits are recorded when paid.

Investment Management Services

Investment management services, excluding transaction fees and loan fees, are paid for by plan participants.

NOTE D – TAX STATUS

The Plan, which is a prototype non-standardized profit-sharing plan with Cash or Deferred Arrangement (CODA), has received a favorable determination letter from the Internal Revenue Service dated July 8, 2014. The Internal Revenue Service has determined and informed the Company that the Plan is designed in accordance with applicable regulations of the Internal Revenue Code (IRC) and is exempt from income taxes.

The Plan's information return filings are subject to examination by the Internal Revenue Service and the Department of Labor for a period of three years after the date of filing. Returns filed for plan years prior to 2022 are no longer subject to examination.

The Plan invests in a diversified portfolio of investment securities, including mutual funds and common collective trusts. Investment securities are exposed to various risks, such as interest rate, market, and credit risks.

Due to the level of risk and potential volatility associated with these securities, it is at least reasonably possible that changes in the fair value of investments will occur in the near term. Such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Although the Plan's investments are broadly diversified across multiple asset classes and fund managers, concentrations of market risk exist to the extent that participants allocate their account balances to specific funds or asset classes.

Management has evaluated subsequent events through the date the financial statements were available to be issued and noted no events, including market fluctuations, that would materially affect the amounts reported in the financial statements.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to reduce or discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

NOTE H – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Level 1 Fair Value Measurements

The fair value of mutual funds in registered investment accounts is based on quoted net asset values of the shares held by the Plan at year end.

Level 2 Fair Value Measurements

The fair value of common/collective trusts and pooled separate accounts consists of a wide variety of investments such as equities, preferred stock, bonds, real estate, and mutual funds.

The net asset value is based on the market value of its underlying investments, but the net asset value is not a publicly quoted price in an active market and can be obtained directly from the applicable asset manager or investment sponsor.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Reliance Trust Company serves as the trustee and manages all of the Plan's investments. Accordingly, Reliance Trust Company qualifies as a party-in-interest to the Plan under ERISA. The fair market value of the funds managed by Reliance Trust Company totaled \$6,264,508 and \$4,371,040 as of December 31, 2024 and 2023, respectively.

For the year ended December 31, 2024, the Plan incurred management and investment service fees of \$29,468, which were paid directly from Plan assets.

All of the Plan's investments are participant-directed, and as such, transactions involving Reliance Trust Company are considered party-in-interest transactions that are specifically exempt from the prohibited transaction provisions of ERISA, provided they are conducted at fair market value and in accordance with applicable plan documents.
