Independent Auditor's Report

To the Trustees of the
AFG Group, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of AFG Group, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of AFG Group, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of AFG Group, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

(1) Description of plan and significant accounting policies

The following description of AFG Group, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and any amendments for a more complete description of the Plan's provisions.

General: AFG Group, Inc. (the Company), established a defined contribution plan effective March 9, 2000 covering all employees of the Company who are eligible to participate based on the eligibility requirements listed below.

Eligibility: Employees of the Company, excluding nonresident aliens and residents of Puerto Rico, are eligible to participate in the Plan on the first day of the month following their date of hire.

Contributions: Each year participants may contribute up to 86% of annual compensation, as defined by the Plan or the maximum allowed by law, as pre-tax or Roth deferrals. For the year ended December 31, 2024, a participant may elect to defer a maximum of \$23,000 on a pre-tax or Roth elective basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, in excess of standard limits. Such additional contributions were limited to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of registered investment companies (mutual funds) and collective investment trusts as investment options.

The Company makes a matching contribution equal to 50% of each participant's elective deferral up to 4% of participant's eligible compensation. Matching contributions were \$157,689 for the year ended December 31, 2024.

In addition, the Company may decide to make a nonelective contribution to the Plan, although the Company is not required to do so. The nonelective contribution will be allocated to all employees eligible to participate in the Plan. The Company did not make a nonelective contribution for the year ended December 31, 2024.

Contributions are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's matching contributions, and an allocation of (a) the Company's non-elective contribution, if any, and (b) Plan earnings/losses, and may be charged with an allocation of administrative expenses for certain transactions. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(1) Description of plan and significant accounting policies (continued)

Vesting: Participants are immediately vested in their elective and rollover contributions plus actual earnings, thereon. Vesting in the matching contributions plus actual earnings, thereon, is based on years of service. A participant is 100% vested after 5 years of credited service as follows:

Vesting in the non-elective contributions plus actual earnings, thereon, is based on years of service. A participant is 100% vested after 6 years of credited service as follows:

Three Years but less than Four Years	40%

Participants become automatically fully vested when they reach normal retirement age while employed or terminate employment due to total disability or death.

Years of service for vesting are counted from the date of hire. For vesting, participants are credited with a year of service for each plan year during which they earn credit for 1,000 hours of service.

Notes receivable from participants: Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. The loans are secured by the balance in the participant's vested account and will bear a commercially reasonable rate of interest on the date each loan is taken, as established by the Plan. Principal and interest are paid ratably through payroll deductions. Loans must be repaid within five years or longer if the loan is for the purchase of a principal residence. Loans used to purchase a primary residence may be repaid within a period of no more than 30 years. Interest rates on outstanding loans range from 5.25% - 10.50% as of December 31, 2024.

(1) Description of plan and significant accounting policies (continued)

Payment of benefits: On termination of service, death, disability, or retirement, a participant or beneficiary is eligible to receive a lump-sum distribution, installment payments, partial withdrawal or defer payment until age 70 ½ equal to the value of the participant's vested interest in his or her account. For accounts that are less than \$5,000, the Company can cash the entire vested account balance out of the Plan. If it is determined that the account is cashout-eligible and a distribution election is not made, the portion of the account attributable to Roth elective deferral or Roth rollover will be automatically rolled over to a Roth IRA. Hardship distributions are permitted if certain conditions are met. In-service withdrawals are also permitted for participants who have reached age 59½. Cash distributions are generally subject to federal and state income tax withholdings.

Forfeited accounts: Non-vested employer contributions from withdrawing participants can be used to reduce current year employer matching contributions or pay administrative expenses of the Plan. The forfeitures are from previous year's employer contributions. During 2024, \$35,461 in forfeitures were used to offset employer matching contributions. As of December 31, 2024 and 2023, forfeited accounts totaled \$5,876 and \$5,709, respectively.

A summary of the Plan's significant accounting policies follows:

Basis of accounting: The accompanying financial statements of the Plan are presented on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Participant contributions and employer matching contributions are recognized on the pay date to which they relate. Employer discretionary matching contributions, if any, are recognized in the year designated by the Company.

(1) Description of plan and significant accounting policies (continued)

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. The Plan has not identified any delinquent loans at December 31, 2024.

Funding policy: Contributions are funded as accrued.

Administrative expenses: Investment management expenses, loan fees associated with notes receivable from participants and other administrative and recordkeeping fees may be paid for by the Plan. Administrative expenses of the Plan can also be paid by the Company, as provided in the Plan document. Certain accounting and administrative functions of the Plan are performed by employees of the Company at no cost to the Plan. Administrative expenses paid by the Plan totaled \$42,237 for the year ended December 31, 2024.

Investment related expenses are included in net appreciation in fair value of investments.

Payment of benefits: Benefit payments to participants are recorded when paid.

(2) Information prepared and certified by the Plan's trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company has certified as to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

(3) Fair value measurements

FASB Accounting Standards Codification 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB Accounting Standards Codification 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the net asset value of shares held by the plan at year end. The mutual funds held by the Plan are mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Collective Investment Trusts: The fair value of the stable value fund is based on the net asset value (NAV) of participation units. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the NAV. Participant transactions (purchases and sales) may occur daily. The fund provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the fund's net asset value per unit. If the Plan initiates a full redemption, the issuer reserves the right to require twelve months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability to market date is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

(a) In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) as a practical expedient are not classified in the fair value hierarchy. The fair value amounts presented in this table for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value presented in the statements of net assets available for benefits.

(4) Related party and party-in-interest transactions

Plan administration and recordkeeping services were provided by ADP for the year ended December 31, 2024. Due to this relationship, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping and plan administration services amounted to \$6,947 for the year ended December 31, 2024.

Plan investment and financial advice services provided by Global Retirement Partners for the year ended December 31, 2024 amounted to \$35,290. Due to the relationship, these transactions qualify as a party-in-interest transactions.

(5) Plan termination

Although it has not expressed any intent to do so, the Company has the right under the terms of the Plan to discontinue its match and nonelective contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

(6) Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

(7) Tax status

The Plan has adopted a non-standardized form of a prototype plan sponsored by a third party administrator. The prototype plan received its latest opinion letter on October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has an uncertain tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan Administrator has evaluated the Plan's tax positions and has concluded that there are no uncertain positions taken or expected to be taken that would require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by federal, state, or local tax authorities for years before 2021.
