INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of
O'Gara Coach Company, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of O'Gara Coach Company, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

NOTE A. DESCRIPTION OF THE PLAN

The following description of the O’Gara Coach Company, LLC (the “Company” or “Employer”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. General

The Plan was established on September 1, 2000 by O’Gara Coach Company, LLC (the “Company”) and is maintained for the benefit of eligible employees of the following companies: O’Gara Coach Company, LLC; Westlake Coach Company, LLC; O’Gara Coach Company – San Diego, LLC; O’Gara Motorsport, LLC; and O’Gara Coach Company – Las Vegas, LLC.

The Plan is subject to the provisions of the Employee Retirement Income Security Act (“ERISA”).

Effective July 29, 2022, the Plan was amended and restated in order to comply with regulatory and legislative changes.

2. Eligibility

Eligibility in the Plan is available to any employee on the first day of the month following the completion of one (1) month of eligible service and the attainment of age twenty-one (21).

3. Contributions

Participants may elect to contribute, on a tax-deferred basis, amounts of their compensation up to eighty percent (80%), or the maximum deferral limit per Section 402(g)(1) Internal Revenue Code (“IRC”) of \$23,000 for the year ended December 31, 2024. Additional “catch-up” contributions can be made beginning in the Plan year in which a participant will be at least age fifty (50) by the end of the Plan year. The maximum “catch-up” contribution was \$7,500 in 2024.

At the option of the Company, employer contributions can be made. No employer contributions were made for the Plan year ended December 31, 2024.

4. Rollovers

An employee who qualifies as part of an eligible class of employees can make rollover contributions subject to the guidelines of the Plan.

5. Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, and an allocation of the Plan's earnings, and charged with an allocation of administrative expenses. Allocations are based on participant’s earnings or account balances, as defined. A participant is entitled to the benefit that can be provided from their vested account.

NOTE A. DESCRIPTION OF THE PLAN (Continued)

6. Investment Options

Participants may direct employee and Employer contributions, if the Employer decides to make such contributions, as desired, in any of a variety of options held by Reliance Trust Company ("Reliance"), as provided by the Plan. Participants may change their investment options daily.

7. Vesting

Participants are vested in their contributions plus actual earnings thereon. If the Company decides to make contributions, then those contributions would vest based on years of service as follows:

<u>Years of Service</u>	<u>Percentage</u>
Less than 1	0%
At least 1, but less than 2	25%
At least 2, but less than 3	50%
At least 3, but less than 4	75%
4 or more	100%

8. Benefit Payments

At retirement, disability, or death, a participant automatically becomes one hundred percent (100%) vested, and may elect to receive either a lump-sum payment, substantially equal installments, partial withdrawals, or a rollover payment in an amount equal to the value of the participant's account as defined by the Plan. For termination of services for other reasons, a participant may receive the value of the vested interest in his or her account as defined by the Plan.

9. Forfeitures

Forfeitures attributable to matching contributions may be used to pay administrative expenses or reduce future discretionary Company contributions. As of December 31, 2024 and 2023, forfeiture balances were \$11,177 and \$10,298.

10. Notes Receivable from Participants

Subject to approval by the plan administrator, participants may borrow a minimum of \$500 up to a maximum of fifty percent (50%) of their vested balance, not to exceed \$50,000, less any outstanding loan balance. The interest rate is the prime rate as published in The Wall Street Journal, plus two (2) percentage points. Loans must be paid back through payroll deductions within five (5) years of the date of issuance, in accordance with terms established by the plan administrator. Loans for the purchase of a primary residence may be paid back within a period of no more than thirty (30) years as approved by the plan administrator. A participant may only have one (1) loan outstanding at any time.

11. Plan Termination

Although it has not expressed such intent, the Employer reserves the right under the Plan document to amend or terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts and funds will be distributed in accordance with the Plan terms and the IRC.

NOTE B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

2. Plan Administration

The Employer is the plan sponsor and the plan administrator. The administrator of the Plan is responsible for carrying out the duties imposed under ERISA.

3. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

4. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note D for further discussion of fair value measurements.

Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

5. Payment of Benefits

Benefits are recorded when paid.

6. Administrative and Other Expenses

Administrative expenses incurred by the trustee in performance of its duties are paid from the assets of the Plan. Fees related to the administration of notes receivable from participants and other participant specific fees are charged directly to the participant’s account and are included in administrative expenses. Other reasonable Plan expenses may be paid from the Plan’s forfeiture account (see Note A.9). Investment-related expenses are included in net appreciation of fair value of investments.

7. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

8. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

NOTE C. CERTIFIED INVESTMENTS

Certified information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

NOTE D. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three (3) levels of the fair value hierarchy under Financial Accounting Standard Board (“FASB”) Accounting Standard Codification (“ASC”) 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE D. FAIR VALUE MEASUREMENTS (Continued)

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at daily closing price as reported by the fund. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

During the year ended December 31, 2024, there were transactions involving participant loans and investment of Plan assets in investment funds maintained by the Plan's trustee or its affiliates. These transactions are considered parties-in-interest as defined in Section 3(14) of ERISA for which a statutory exemption exists.

NOTE F. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

The Plan invests, through mutual funds, in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments.

NOTE G. INCOME TAX STATUS

The Employer adopted a volume submitter document, which received a favorable opinion letter from the Internal Revenue Service ("IRS") on October 6, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator and the plan's advisors believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Administration errors, if any, which are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America ("U.S. GAAP") require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H. SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan changed its trustee from Reliance Trust Company to Principal Trust Company.

Plan management has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.
