Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of World Emblem International, Inc. 401(K) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements

1. Description of Plan:

The following description of the World Emblem International, Inc. 401(K) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, established on January 1, 2004, is a defined contribution plan covering employees of World Emblem International, Inc. and its subsidiaries (collectively the “Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan qualifies as a Qualified Automatic Contribution Arrangement (“QACA”) in accordance with Internal Revenue Service (“IRS”) Code Section 401(k)(13).

The Plan was restated effective May 1, 2022 to comply with IRS restatement requirements. The restatement of the Plan incorporated all prior amendments.

Eligibility

Employees who are age 21 or older and have completed 3 months of service are eligible to contribute to the Plan, except non-resident aliens and residents of Puerto Rico. Eligible employees can enter the Plan on the first day of the month coinciding with or following satisfaction of eligibility requirements. The Plan has an automatic enrollment provision providing for a 6% salary deferral, whereby employees must elect out of the Plan if they do not wish to participate.

Contributions

Participants may elect to contribute up to 90% of their annual compensation, as defined by the Plan and subject to certain limitations set by the Internal Revenue Code (“IRC”). In addition, employees who have attained age 50 by the end of the Plan year may make catch-up contributions up to limits defined by the IRS. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company makes a QACA safe harbor contribution each pay period and may make additional discretionary nonelective or profit-sharing contributions on an annual basis. The Company’s QACA safe harbor contribution is calculated at an amount equal to the sum of 100% of the participant’s elective deferrals up to 1% of the participant’s compensation, plus 50% of the participant’s elective deferral over 1% and up to 6% of the participant’s compensation. Employees who completed 1,000 hours of service during the Plan year and are employed on the last day of the Plan year will be eligible to receive an allocation of the annual discretionary nonelective or profit-sharing contribution, if any. The Company did not make any discretionary nonelective or profit-sharing contributions for the Plan year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, allocations of Company contributions, and participant earnings. Participant earnings are based on an allocation of Plan earnings respective to each participant’s account balances and investment selections. Any related administrative expenses based on participant earnings or account balances are deducted from the participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

1. Description of Plan (Continued):

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a selection of mutual funds and a common collective trust as investment options for participants.

Vesting

Participants are immediately 100% vested in their elective deferrals, including catch-up contributions and rollover contributions from other plans, plus actual earnings thereon.

Vesting in the Company's contributions plus actual earnings thereon is based on periods of continuous service. Participants are 100% vested in QACA safe harbor contributions after two years of credited service, and discretionary nonelective and profit-sharing contributions after three years of credited service. All employer contributions become fully vested in the event of participant death, disability, or after reaching normal retirement age while under the Company's employment.

Forfeited Accounts

Forfeited nonvested accounts may be used to pay Plan expenses or reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$226 and \$318, respectively. During the year ended December 31, 2024, forfeited non-vested accounts of \$11,952 were used to reduce employer contributions.

Notes Receivable from Participants

Participants may borrow a minimum of \$500, up to 50% of their vested contributions and related earnings, not to exceed \$50,000. Participants are permitted one outstanding loan at a time. Loans are secured by the balance in the participant's account and must be repaid in level payments through payroll deductions within a 5-year period, except for loans for the purchase of a principal residence which may be repaid over a reasonable period of time not to exceed a maximum of 30 years. The loans bear interest rate at the prime rate plus 2%.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in their account in accordance with Plan provisions. In-service withdrawals are allowed for participants who attain the age of 59 ½. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Account balances that are under \$5,000 may be automatically distributed upon termination of service as a lump sum without the consent of the participant.

Administrative Expenses

In accordance with Plan provisions, the Company or the Plan may pay administrative expenses of the Plan. Recordkeeping and other administrative services expenses are paid by the Plan and allocated to participant accounts. Plan expenses charged for transactions that are participant specific are deducted from the respective participant account.

2. Summary of Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan’s investments are recorded at fair value which represents the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date as described in Note 3.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported on the average cost method.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction in the investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributed based upon the terms of the Plan document. The loans are secured by the balance in the participants’ accounts.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in a combination of investment securities which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant’s account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

3. Fair Value Measurements:

Financial Accounting Standards Board, Statement of Accounting Standards Codification Topic 820 (“ASC 820”) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Common collective trusts: Stated at fair value as determined by the issuers of the funds on the fair market value of the underlying investments, which is valued at net asset value (“NAV”) as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV.

5. Parties-in-Interest Transactions:

ADP, LLC ("ADP") provides recordkeeping services to the Plan and is considered a party in-interest to the Plan. Accordingly, transactions with ADP qualify as party-in-interest transactions. During 2024, the Plan paid \$44,309 to ADP for recordkeeping services.

Included in the Plan assets are notes receivable from participants. At December 31, 2024 and 2023, notes receivable from participants amounted to \$248,475 and \$227,567, respectively. For the year ended December 31, 2024, interest income related to notes receivable from participants amounted to \$21,999. These transactions qualify as party-in-interest transactions permitted under provisions of ERISA.

6. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts.

7. Tax Status:

The Plan obtained a determination letter on October 6, 2020, in which the IRS stated that the Plan was designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and tax counsel believe the Plan is currently being operated in compliance with the applicable requirements of the IRS.

Management has evaluated the Plan's tax positions and concluded that as of December 31, 2024, the Plan had taken no uncertain tax positions that require recognition of liability (or asset) in the accompanying financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

8. Subsequent Events:

Management has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be filed, and has determined that there were no material events requiring recognition or disclosure.
