Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of Plan

The following description of the Hickory Foods, Inc. ("Company") 401(k) Plan & Trust ("Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all active employees of the Company who have three months of service and are age eighteen or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions:

Participants may elect to make salary deferral contributions to the Plan in an amount up to 100% of their salary with a total amount not to exceed \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Eligible participants age 50 may also elect to defer additional catch-up contributions. The maximum catch-up contribution for both 2024 and 2023 was \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a guaranteed investment contract as investment options for participants. Each year, the Company contributes an elective contribution as defined in the Plan document. For 2024, the Company matched 100% of the participant's elective deferral up to \$1,560.

Participants Accounts:

Each participant's account is credited with the participant's contribution and Company's elective contribution and allocations of Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

NOTES TO FINANCIAL STATEMENTS

Note 1. (Continued)

Payment of Benefits:

On termination of service, a participant (or beneficiary) may elect to receive a lump-sum amount equal to the value of the participant's account, periodic payments over a period not to exceed the life expectancy of the participant or his beneficiary, or in partial withdrawals. In-service distributions, as provided by the Plan, may be made after the participant has reached the age of 59.5 years, up to the amount of the vested balance, with a minimum requirement of \$500.

Forfeitures:

Forfeitures of non-vested company contributions may be used by the Plan as payment of Plan expenses. Any remaining forfeitures will be added to any employer discretionary matching contributions. At December 31, 2024 forfeited non-vested amounts totaled \$12,884. The Employer's contributions were reduced by \$29,979 for the year ending December 31, 2024.

Notes Receivable from Participants:

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested interest in the Plan, whichever is less. The loans are secured by the balance in the participant's account and bear reasonable interest rates. The interest rate is set at inception based on the prime lending rate as published in the Wall Street Journal on the 14th day of each month plus one percent. The rate of interest on the loan will be fixed and will not change for the duration of the loan repayment period, except as otherwise required by law. The terms for repayment may not be greater than five years.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates:

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition:

The Plan's investments are reported at fair value (except for fully benefit responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company.

NOTES TO FINANCIAL STATEMENTS

Note 2. (Continued)

Notes Receivable From Participants:

Notes receivable from participants are measured at their unpaid principal balance plus and accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits:

Benefits are recorded when paid.

Operating Expenses:

Plan expenses are partially paid by the Company and allocated ratably to the participant's accounts.

Subsequent Events:

In preparing these financial statements, the Plan has evaluated events and transactions for possible recognition or disclosure through October 2, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The Plan applies generally accepted accounting principles for fair value measurements of financial assets and liabilities. These accounting principles define fair value and establish a hierarchy that prioritizes fair value measurements based on the types of inputs used for the various valuation techniques. The three levels of inputs used to measure fair value are as follows:

- Level 1 - Values measured using quoted prices in active markets for identical investments.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value of shares held by the Plan at year end.

Note 4. Investments

During 2024, the Plan's investments, including gains and losses on investments bought and sold, as well as held during the year, appreciated in value by \$788,764.

Note 5. Investment Contract With Insurance Company

The Plan has a benefit-responsive investment contract with Reliance Trust for the years ended December 31, 2024 and 2023, respectively. The Plan maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at fair value with an adjustment to contract value in arriving at net assets available for benefits. Contract value, as reported to the Plan by Reliance Trust for the years ended December 31, 2024 and 2023, respectively, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTES TO FINANCIAL STATEMENTS

Note 5. (Continued)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract at December 31, 2024 and 2023 was \$261,991 and \$481,408 respectively. The crediting interest rate is based on a formula agreed upon with the issuer, and does not have a minimum limit. Such interest rates are reviewed on a quarterly basis for resetting.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6. Related Party Transactions

ADP is the Plan administrator for the year ended December 31, 2024, therefore certain transactions qualified as party-in-interest transactions. Fees paid by the Plan for the administrative services provided by ADP amounted to \$13,642 for the year ended December 31, 2024.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 8. Tax Status

The Internal Revenue Service has determined and informed the Plan by a letter dated October 6, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Note 9. Information Prepared and Certified by the Custodian

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by Reliance Trust, the Plan's Custodian for the years ended December 31, 2024 and 2023, respectively.
