We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan by Reliance Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan’s financial statements will not be prevented, or detected and corrected, on a timely basis.

Our consideration of internal control was for the limited purpose described in the first two paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses. Given these limitations, during our audit we did not identify any deficiencies in internal control that we consider to be material weaknesses. However, material weaknesses may exist that have not been identified.

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention.

This lack of reconciliation increases the risk that employee and employer contributions may not be accurately or timely remitted to the plan, potentially resulting in compliance issues with Department of Labor (DOL) regulations and misstated plan financial statements.</p> <p>We recommend that management implement a formal process to reconcile payroll records to trust statements on a regular basis. This process should include:</p> <ul style="list-style-type: none"> <li>- Reviewing payroll deduction reports for each pay period.</li> <li>- Comparing total contributions per payroll to amounts deposited in the plan trust.</li> <li>- Investigating and resolving any discrepancies promptly.</li> </ul> <p>Regular reconciliation will help ensure contributions are complete, accurate, and timely, and will strengthen internal controls over plan assets.</p>

<p><b>Forfeiture Balance Not Used Appropriately</b></p>	<p>During our audit, we noted that the Plan’s forfeiture balance was not utilized to reduce plan administrative expenses or future employer contributions, as permitted by the plan document. Instead, the forfeiture funds remained unallocated at year-end.</p> <p>We recommend that Plan management review the plan document and applicable regulations to ensure forfeitures are used in accordance with the established provisions. Proper allocation of forfeitures is necessary to maintain plan compliance and avoid potential operational defects. Management should establish procedures to monitor and timely apply forfeitures to reduce eligible plan expenses or employer contributions, as specified in the plan document.</p>
