NOTES TO FINANCIAL STATEMENTS**

1 – Description of Plan

General

The following description of La Chiquita Tortilla Manufacturing 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering eligible employees of Latino Enterprises, Inc. ("Plan Sponsor" or the "Company").

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility of Participants

Eligible employees, as defined, who have reached age 21 and who have completed one year of service, may contribute to the Plan upon meeting the entry date requirement. Entry dates are January 1, April 1, July 1, and October 1.

Contributions

Each pay period, participants may elect to make deferral contributions of their pretax and after-tax compensation, as defined, subject to limitations as to the amount under the provisions of the Internal Revenue Service ("IRS") (\$23,000 for 2024). Participants age 50 and older whose elective contributions have reached the IRS limit are permitted under the Plan to make catch-up contributions up to the IRS catch-up contribution limit (\$7,500 for 2024).

The Company provides a safe harbor matching contribution of 100% of the first 3% of a participant's eligible compensation and 50% of more than 3% but not more than 5% of a participant's eligible compensation. The safe harbor matching contribution was \$290,784 for the 2024 Plan year.

The Company may also make a discretionary non-elective contribution to the Plan. No such contribution was made during the 2024 Plan year.

Participant Accounts

Each participant's account is credited with the participant's contributions, any Company contributions, and the allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that the Plan pays. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined.

1 – Description of Plan (continued)

Vesting

Participants are immediately vested in their contributions and the Company's contributions plus actual earnings.

Distributions

Upon death, disability, termination of service, or attainment of retirement age, a participant or his/her beneficiary is paid the value of the participant's vested interest in his/her account in a lump sum. An active participant is not entitled to make a withdrawal from his/her account until age 59 ½ or separation from service, unless the participant qualifies for a hardship withdrawal.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or 50% of the vested portion of their account balances, subject to certain restrictions, in accordance with interest rates established by the plan document. The loans are secured by the balances in the participants' accounts and bear interest at a rate commensurate with market rates for similar loans. Loan terms generally do not exceed 5 years. A participant may select a repayment term up to 30 years for loans used to purchase his/her principal residence.

2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Cash and Cash Equivalents

The Company considers all highly liquid investments purchased with maturity dates of three months or less to be cash equivalents.

Accounting Pronouncements

As of December 31, 2024, there were no new accounting pronouncements that had or were expected to have, including those not yet adopted, a significant impact on the financial statements or disclosures of the Plan.

The Plan assessed recent accounting pronouncements, noting none that would impact the financial statements or notes to the financial statements.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Administrative Expenses

Pursuant to provisions of the Plan, the Plan's expenses are paid either by the Plan or the Company. Certain expenses incurred in connection with the general administration of the Plan that the Plan pays are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Expenses that are paid directly by the Company are excluded from these financial statements. Participant loan fees and investment-related expenses are paid from the Plan from participant accounts.

3 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2—Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of an asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodology used as of December 31, 2024 and 2023:

Mutual Funds—These investments are public investment vehicles valued using the Net Asset Value ("NAV") provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

4 – Information Certified by the Qualified Institution

All investment information disclosed in the accompanying financial statements and supplemental schedule of assets (held at the end of the year), including investments held at December 31, 2024 and 2023, net appreciation in fair value of investment, interest, and dividends income for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, LLC, as agent for Ascensus Trust Company, the trustee of the Plan.

5 – Party-in-Interest Transactions

Notes receivable from participants qualify as party-in-interest transactions. These transactions are not considered "prohibited transactions" under the Internal Revenue Code ("Code") and are not prohibited by ERISA.

6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Company contributions portion of their account.

7 – Late Remittances

During 2024, the Plan Sponsor identified that the employer matching contributions for two payroll periods were understated due to an administrative error. The Plan Sponsor contributed the missed matching amounts, plus related investment earnings, to the affected participant's account within the 2024 plan year. These corrective contributions are included in the “Employer contributions” in the accompanying financial statements and are not deemed a prohibited transaction.

8 – Income Tax Status

On June 30, 2020, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under Section 401(a) of the Code. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that is more likely than not to be sustained upon examination by taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audits by taxing jurisdictions; however, there are currently no such audits in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

10 – Subsequent Events

The Plan has evaluated events subsequent to December 31, 2024, and through September 18, 2025, the date the financial statements were available to be issued and determined that there were no events that require adjustments to these financial statements.
