## REPORT OF INDEPENDENT AUDITORS

To the Retirement Benefits Committee  
Retirement Savings Plan of Hoosier Energy Rural Electric Cooperative, Inc.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Retirement Savings Plan of Hoosier Energy Rural Electric Cooperative, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**1. DESCRIPTION OF THE PLAN**

The following description of the Retirement Savings Plan of Hoosier Energy Rural Electric Cooperative, Inc. (the "Plan") provides general information. Participants should refer to the Plan document for a more complete description of the Plan's information. The Plan is a defined contribution employee benefit plan established as of January 1, 1986 covering substantially all employees of Hoosier Energy Rural Electric Cooperative, Inc. (the "Company" or "Hoosier").

**General**—The Plan is administered by the Company's Retirement Benefits Committee ("Plan administrator"), which is appointed by the Company, and Fidelity Management Trust Company ("Fidelity" or "Trustee"). An employee becomes eligible to participate on the first day of employment. The Plan is available to full or part-time employees who are 18 years of age.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions**—Employee contributions are determined based on eligible compensation not to exceed the maximum elective deferral established by the Internal Revenue Code (IRC). The Company makes matching contributions in accordance with plan provisions and applicable collective bargaining agreements.

*Non-union employees* – For the year ended December 31, 2023, the Company provided a safe harbor matching contribution for eligible non-union employees equal to 100% of the first 3% of elective deferrals and 50% of the next 2% of elective deferrals.

*Union employees* – For the year ended December 31, 2023, union employees were eligible for a Company matching contribution equal to 100% of the first 3% of elective deferrals and 50% of the next 2% of elective deferrals. Under the terms of the collective bargaining agreement in effect during 2023, certain types of compensation – specifically, overtime, shift differentials, per diems, and bonus earnings – were excluded from the definition of eligible compensation for purposes of calculating the Company match.

*Change in Matching Formula – Effective January 1, 2024* – On September 16, 2024, the International Brotherhood of Electrical Workers (IBEW) ratified a new union contract with Hoosier. In connection with the new agreement, the Company adopted a revised matching formula, effective January 1, 2024, beginning with the pay period that began September 23, 2024, for both union and non-union employees. Under the revised formula, Hoosier matches 100% of the first 5% of elective deferrals. Consistent with prior practice, the revised formula excludes overtime, shift differentials, per diems, and bonus earnings from the definition of eligible compensation when calculating the company match.

As part of the transition to the revised formula, the retroactive matching contribution for the period January 1, 2024 through September 22, 2024 was calculated and included in the annual true-up process. The annual true-up contribution of \$255,856 was posted on January 28, 2025, and is included in the Plan's contributions receivable as of December 31, 2024.

**Participant Accounts**—Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution, and an allocation of Plan earnings. Participant accounts are also charged with withdrawals, administrative expenses, and an allocation of Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investments**—Participants may direct the investment of their contributions and Company contributions, and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan offers mutual funds, money market funds, collective trust funds, and a self-directed brokerage account.

**Vesting**—A participant's account is 100% vested and is non-forfeitable at all times.

**Payment of Benefits**—Upon termination of service, a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments.

Participants are also eligible to make hardship withdrawals from their deferred contributions and Company matching contribution balances in the event of certain financial hardships, as well as partial distributions at age 59 ½.

**Notes Receivable from Participants**—Plan participants may borrow the lesser of \$50,000 or one-half of their vested interest from the Plan. Loans bear interest at prime plus 1% (as determined one day prior to the approval date) and are repaid in equal monthly installments of principal and interest over the term of the loan, not to exceed five years, except when the loan is obtained for the purpose of purchasing a home. Principal and interest are paid ratably through payroll deductions or as a lump sum for the outstanding loan balance. The loans are secured by the vested benefits balance in the participant's account under the Plan. As of December 31, 2024, participant loans have maturities through 2030 at interest rates ranging from 4.25% to 9.50%.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**—The Plan’s investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants**—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

**Payment of Benefits**—Benefit payments to participants are recorded upon distribution.

**Risks and Uncertainties**—The Plan provides for various investment options. The underlying investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants’ account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

### **3. ADMINISTRATIVE EXPENSES**

Administrative expenses of the Plan are paid by Hoosier or from the assets of the Plan. Participants also pay administrative costs for loans, distributions and qualified domestic relation orders. The remaining expense is paid by the Company and through credits provided by the recordkeeper for Plan investments.

### **4. FEDERAL INCOME TAX STATUS**

The Plan uses a preapproved plan document sponsored by Fidelity Management & Research Co, LLC (“Fidelity”). Fidelity received an opinion letter from the Internal Revenue Service (“IRS”), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan’s management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan’s financial statements.

GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 5. PLAN TERMINATION

Although Hoosier has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

## 6. FAIR VALUE MEASUREMENTS

ASC 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**Asset Valuation Techniques**—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds*—Mutual funds are categorized at Level 1 and are valued at the daily quoted closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Account*—The accounts are comprised of cash equivalents, mutual funds, exchange traded funds, and common stock. Cash equivalents consist of the Fidelity Cash Reserve Fund, which is valued at cost plus accrued interest. Common stock and exchange traded funds are valued at the quoted closing price reported on the active market on which the individual securities are traded. These investments are categorized as Level 1.

*Collective Trust Fund*—A collective trust fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value (“NAV”) of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to confirm that securities liquidations will be carried out in an orderly business manner.

## 7. COLLECTIVE TRUST FUND

The Fidelity Managed Income Portfolio II Fund (MIP CL 2 Fund) is a collective trust fund sponsored by Fidelity (the "Fund"). The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Fund's constant net asset value (NAV) of \$1 per unit. Distribution to the Fund's unit holders is declared daily from the net investment income and automatically reinvested in the Fund on a monthly basis, when paid. It is the policy of the Fund to use its best efforts

to maintain a stable net asset value of \$1 per unit, although there is no guarantee that the Fund will be able to maintain this value.

Participant-initiated transactions are those transactions allowed by the Plan, including withdrawals for benefits, loans, or transfers to noncompeting funds within a plan, but excluding withdrawals that are deemed to be caused by the actions of the Plan Sponsor. The following employer-initiated events may limit the ability of the Fund to transact at net asset value:

- A failure of the Plan or its trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
- Any communication given to Plan participants designed to influence a participant not to invest in the Funds or to transfer assets out of the Fund.
- Any transfer of assets from the Fund directly into a competing investment option.
- The establishment of a defined contribution plan that competes with the Plan for employee contributions.
- Complete or partial termination of the Plan or its merger with another plan.

## 8. INFORMATION CERTIFIED BY THE TRUSTEE

The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedules, that were prepared by or derived from information prepared by Fidelity, the Trustee of the plan, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Trustee that such information is complete and accurate.

Hoosier provides certain accounting, recordkeeping and administrative services to the Plan for which it receives no compensation. Certain Plan investments are managed by Fidelity, \$60,312,047 and \$51,900,788 at December 31, 2024 and 2023, respectively. Fidelity is the trustee as defined by the Plan, and therefore, these transactions qualify as exempt party-in-interest transactions. The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts.

## **10. SUBSEQUENT EVENTS**

For the year ended December 31, 2024, subsequent events were evaluated through September 30, 2025, the date the financial statements were available to be issued.
