Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Design Systems Profit Sharing and Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF THE PLAN

The following description of Design Systems Profit Sharing and Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General

The Plan is a defined contribution profit sharing plan and trust with a qualified cash or deferred 401(k) arrangement covering all eligible employees, as defined in the plan document. The Plan was established by Design Systems, Inc. (the “Company”, “Employer” or “Plan Sponsor”) on January 1, 1994. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Participation in the Plan is discretionary for all eligible employees who have attained the age of 18 and completed one month of service (“participant”). To participate in the Plan’s discretionary matching contribution, an employee must have 1 month of service, have attained the age of 18 and work 1,000 or more hours during the plan year and be employed on December 31st. For participation in the profit sharing portion of the Plan an employee must have 1 year of service, have attained the age of 18 and work 1,000 or more hours during the plan year and be employed on December 31st.

Contributions

Starting in October 2013, the Plan allows participants to make elective deferral contributions up to 75% of their compensation, including catchup contributions for participants who have attained age 50, not to exceed the maximum amounts allowed for by the Internal Revenue Code and the Plan document. The Plan does allow participants to contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions under the investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all new eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6%, with 1% increases each Plan year until the rate is 20% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The amount of the participant’s deferred compensation is treated as a participant elective contribution, allocated to the participant’s elective account, and is 100% vested at the time of each contribution. Any portion of each contribution can be elected by the participant as a Roth contribution.

Beginning on July 15, 2024, participants may elect to make after-tax elective deferral contributions, which can be utilized after the participant has reached the annual pre-tax deferral limit, not to exceed 75% of their compensation. The plan does not match after-tax contributions.

Employer discretionary matching contributions and employer profit sharing discretionary contributions made to the Plan are at the discretion of the employer as approved by resolution of its Board of Directors. The Board of Directors elected to make a total employer discretionary matching contributions of \$372,861 as of December 31, 2024. The 2024 employer retirement savings plan matching contribution is calculated by taking 50% of the participant’s deferrals but cannot exceed 6% of their W-2 wages. There were no discretionary profit sharing contributions for 2024.

Participant Accounts

Each participant's account is credited with an allocation of (a) the employer's discretionary contributions, if any; (b) the participants' voluntary contributions; (c) forfeitures of terminated participants' non-vested accounts; and (d) plan earnings (losses). The accounts are charged for any withdrawals, distributions, and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Effective December 1, 2023, participants were vested in the employer discretionary contributions portion of their account balance in accordance with the Plan document, based on the following schedule:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the participants' vested balance in the Plan's assets. These loans are generally due in bi-weekly payments of principal plus interest at the rate established at the issuance of the loan (ranging from 4.25% to 9.50%). The interest rate is fixed and based on the prime rate of interest as of the loan date plus 1.00%.

Benefits Paid to Participants or Beneficiaries

Participants, or their beneficiaries, are entitled to receive the entire amount of their vested interests in the Plan upon retirement, death, total or permanent disability, employment termination or reaching the age of 59½, as defined in the Plan. Upon termination of service, a participant, or their beneficiaries, may elect to receive a lump-sum distribution or direct rollover equal to the value of the participant's vested interest in their account. In-service withdrawals are also permitted under the Plan. Hardship distributions are not permitted under the Plan.

Forfeitures

Forfeitures of non-vested account balances in the Profit Sharing Fund are allocated to remaining eligible participants. Forfeitures of non-vested 401(k) match account balances from participant directed accounts are used to reduce subsequent employer's contributions to the Plan. During 2024, forfeitures in the amount of \$29,536 were utilized to reduce the 2023 employer matching contributions. At December 31, 2024 forfeitures in the amount of \$10,777 were available to be reallocated to the Profit Sharing Fund.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to various provisions of ERISA.

In the event of plan termination, participants will become 100% vested in their accounts, and all unallocated amounts shall be allocated to the accounts of all participants.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents in the statement of changes in net assets available for benefits the net appreciation or depreciation in the fair value of investments, which consists of realized gains or losses and the unrealized appreciation or depreciation on those investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced entirely and a benefit payment is recorded.

Benefits Paid to Participants or Beneficiaries

Distributions to plan participants or beneficiaries are recorded in the statement of changes in net assets available for benefits when paid. At December 31, 2024 and 2023 there were no unpaid amounts due to participants who had elected to withdraw from the Plan.

Operating Expenses

Administrative expenses of \$86,755 consist of loan fees and other service fees of \$32,181 charged to the participant's accounts, investment consulting fees of \$40,324, and accounting fees of \$14,250 paid directly from the Plan. The Plan allocates a portion of the mutual fund's operating expenses into an administrative budget account. This account was used to primarily pay the consulting fees. At December 31, 2024, the balance in the administrative budget account was \$43,392. Investment related fees are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued and has determined that there were no transactions or events that required disclosure through the evaluation date.

4. FAIR VALUE MEASUREMENTS

Accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, and Level 3 inputs consist of significant unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;

- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. TAX STATUS

The Plan uses a prototype plan sponsored by T Rowe Price Retirement Plan Services Inc. which obtained its latest determination letter on August 19, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan itself is not required to and has not received a determination letter from the IRS. Although the Plan has been amended since receiving this letter, the Plan Sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has considered the tax positions taken by the Plan and has concluded there are no uncertain tax positions taken that would require recognition of a tax liability (or asset) as of December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PARTIES-IN-INTEREST

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. During the year ended December 31, 2024, there were direct fees of \$40,324 paid to LPL Financial for investment consulting fees services. Also, during 2024 the Plan paid \$30,342 in recordkeeping fees to an affiliate of T. Rowe Price. During the year ended December 31, 2024, there were transactions involving the investment of plan assets in investment funds maintained by affiliates of the T. Rowe Price Trust Company. Indirect fees paid by the Plan for investment management services are included in the net appreciation of the fair value of investments. The Plan also received a refund of fees from mutual funds in the amount of \$36,393 for the year ended December 31, 2024. These transactions are party-in-interest transactions, which are exempt under ERISA.

Certain Plan investments are shares of mutual funds managed by T. Rowe Price, an affiliate of the Plan's trustee, and the Plan makes loans to participants and charges the participants a loan initiation fee of \$50 and a \$25 annual maintenance fee for each loan. These transactions qualify as party-in-interest transactions. The Trustee and affiliates of T. Rowe Price maintain and manage the mutual funds in the plan for which they receive management fees. These management fees, which are part of the annual operating expenses of each fund, result in a reduction of earnings from investments.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
