**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Budweiser Distributing Company of Borger 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan which provides for the participation of all employees of Budweiser Distributing Company of Borger (the Company) who have three months of service and are age 21 or older. Under the Plan, each participant has an account for his/her salary deferral contributions, any rollover contributions and employer matching and discretionary contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended, and is intended to qualify under Section 401(k) of the Internal Revenue Code (IRC).

**Transamerica Trust Company** and **Reliance Trust Company** serves/(served) as the Plan's investment custodian and is responsible for executing all investment transactions. **Transamerica Retirement Solutions, LLC** serves as the recordkeeper.

**Contributions**

Participants may make salary deferral contributions in whole percentages or fixed dollar amounts on a tax-deferred basis through payroll deductions of no more than 90% of their compensation, as defined by the Plan (limited to certain amounts allowed under the IRC). Participants may also rollover balances distributed from other qualified defined contribution or benefit plans. Participants who attain age 50 or older are allowed to make additional catch-up deferral contributions. The Plan has elected Safe-Harbor and the Company matches 100% of each employee's contribution up to 3% of compensation earned for the first level, and up to 50% of each employee's contribution up to a maximum of 5% of compensation earned for the second level. Participant and Company contributions are subject to the provisions of the IRC and related regulations.

**Vesting**

Participants are immediately vested in their salary deferral contributions and the Company safe-harbor matching contributions, plus actual earnings thereon.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, and allocations of (a) Company contributions and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on account balances or compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Loans to Participants**

A participant may apply for a loan from his/her vested account under the Plan. The Plan Administrator establishes rules and regulations with respect to the amount of loans and interest rates. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and are repaid through payroll deductions. Interest rates on the participant loans shall bear a rate of interest equal to Prime plus 2%. Rates ranged from 5.25% to 10.50% as of December 31, 2024.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$38, respectively. These accounts may be utilized to reduce the Plan's ordinary and necessary administrative expenses or to reduce Company discretionary matching contributions to participants. During 2024, forfeitures in the amount of \$456 were used to reduce employer contributions.

**Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his/her account. Distributions may be deferred until the participant reaches the age of 70½ or retires. Current Plan provisions do allow for withdrawals by active employees for certain hardship occurrences as allowed under the Internal Revenue Code.

**Investment Options**

Upon enrollment, a participant may direct their contributions to any of the investments selected by the Company's Trustee and investment advisor. Participants have the option to change their investment allocations daily via phone or internet access to Transamerica Retirement Solutions, LLC.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The accompanying financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosures of contingent assets and liabilities at the date of the financial statements and the changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment custodian.

**Investment Valuation and Income Recognition (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. See Note 7 for disclosure of fair value measurements.

**Administrative Fees**

The Plan pays asset custody and investment management fees from Plan assets. All other costs of operating the Plan are paid by the Plan's sponsor and are not reflected in these financial statements.

**Benefit Payments**

Benefits are recorded when paid.

**Contributions**

Participant contributions and employer matching contributions are recognized during the period in which the respective payroll deductions are made.

**Subsequent Events**

The Plan Administrator has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

**NOTE 3 - INFORMATION CERTIFIED BY INVESTMENT CUSTODIAN**

The following is a summary of the Plan's investment information as of December 31, 2024 and 2023, included in the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by the custodians, Reliance Trust Company and/or Transamerica Trust Company and Transamerica Life Insurance Company, Inc., and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that the information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following assets:

The custodian also certified to the completeness and accuracy of \$2,486,625 of net appreciation in fair value of investments, \$21,641 of interest and dividends, and \$23,242 of participant loan interest related to the aforementioned plan assets for the year ended December 31, 2024.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants will become 100% vested in their accounts and the Plan assets will be distributed in a manner approved by the Internal Revenue Service.

**NOTE 5 - INVESTMENT CONTRACT WITH TRANSAMERICA LIFE INSURANCE COMPANY**

The Plan provides as an investment option, a traditional fully benefit-responsive investment contract with Transamerica Life Insurance Company (Transamerica). The outstanding balance was \$207,787 and \$205,159 as of December 31, 2024 and 2023, respectively. Transamerica maintains the contributions in a general account. The account is credited with earnings based on a published rate established by Transamerica and charged for participant withdrawals and administrative expenses.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The contract with Transamerica has no maturity date and continues until all assets have been distributed, or no further payments are due.

**NOTE 6 - INCOME TAX STATUS**

The Plan has not received a determination letter on their adoption of the Pre-approved plan. In accordance with Revenue Procedure 2003-06, the Plan Administrator has chosen to rely on the opinion letter, dated June 30, 2020, that has been issued to the Pre-approved plan. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code (the Code) to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with applicable requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for fiscal years before 2021.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Stable Value Fund:* Valued at contract value. This fund is a depository liability with no formal underlying maturities, and it is considered fairly valued at contract value based on this specific distinction. The stable value fund is considered a level 2 investment.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Investment Trusts:* Value based on the NAV of units of the collective investment trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets and liabilities that are subject to fair value measurement. The following table summarizes the financial investments measured at fair value on a recurring basis at December 31:

**Changes in Fair Value and Related Gains and Losses**

During 2024, the Plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$2,486,625. During 2024, dividends earned totaled \$21,641.

**NOTE 8 - TRANSACTIONS WITH PARTIES IN INTEREST**

At December 31, 2024 and 2023, the Plan held investments in an investment contract, collective investment trusts, and participant loans with current value of \$12,635,093 and \$12,787,981, respectively, which are managed by Transamerica and Plan participants. Thus, transactions within these investment funds qualify as party-in-interest transactions as defined by ERISA.

The Plan paid \$85,354 in administrative fees during 2024 to Carson Wealth Management, Transamerica, and Reliance Trust Company, whom served as the investment advisor, recordkeeper, and investment custodian of the Plan, respectively. All parties are considered parties-in-interest to the Plan.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.
