## **Independent Auditor's Report**

To the Board of Trustees  
The Cersosimo Companies 401(k) Savings & Investment Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of The Cersosimo Companies 401(k) Savings & Investment Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audits). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

- The information in the accompanying financial statements related to assets held by and certified to by the qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal-control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to, or derived from, the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to, or is derived from, the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to, or derived from, the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

#### Note 1. Description of Plan

The following brief description of The Cersosimo Companies 401(k) Savings & Investment Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General:** The Plan is a defined contribution 401(k) plan formed on January 1, 1995, restated effective January 1, 2022, and most recently amended effective November 13, 2024. The Plan covers substantially all employees of Cersosimo Lumber Co., Inc. and Cersosimo Industries, Inc. (the Companies) who have completed at least 166 hours of service within the first two months of employment or one year of service, except leased employees and employees who were obtained as a result of an Internal Revenue Code (IRC) 410(b)(6)(c) transaction. The Plan was most recently amended to make eligible long-term, part-time employees who complete at least 500 hours of service with the employer during three consecutive years. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Participants may contribute up to 100% of pretax annual eligible compensation. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, the Plan allows rollover contributions from other qualified plans.

The Companies may make discretionary matching contributions, as defined by the Plan. In 2024, the Companies matched 100% of employee deferrals up to \$1,000.

The Companies may make other discretionary contributions at the option of the Board of Directors. Participants must have completed at least one year of service and been credited with at least 1,000 hours of service to be eligible for an allocation of the Companies' other discretionary contributions, except upon death, disability or termination after reaching the normal retirement age (65), or on an authorized leave of absence. The Companies did not make other discretionary contributions for 2024.

Contributions and eligible compensation are subject to certain limitations.

**Participant accounts:** Each participant's account includes the participant's contributions, the Companies' matching contributions, and allocations of Plan expenses and earnings. Allocations of Plan expenses and earnings are based on a participant's account balance relative to the total account balances of all participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service. A participant is 50% vested after two years of credited service and 100% after three years of credited service. Participants automatically become fully vested upon death or termination due to becoming disabled while under the employment of the Companies or upon reaching the normal retirement age, as defined by the Plan.

#### Note 1. Description of Plan (continued)

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are permitted one outstanding loan. Loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Interest rates range from 5.25% to 10.50% as of December 31, 2024. All loans must be repaid within five years. Principal and interest are generally paid ratably through payroll deductions.

**Payment of benefits:** Benefits may be distributed to participants upon the termination of employment by reason of retirement, disability, death or other separation from service. Distributions under the Plan may be made in lump sums or partial withdrawals. A participant may also request a withdrawal upon reaching age 59½; upon demonstration by the participant to the Plan Administrator that the participant is suffering from hardship (as defined in the Plan document); or upon deemed separation of employment if on active duty. Participants may withdraw from their rollover account at any time.

**Forfeitures:** As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$33,000 and \$6,000, respectively. These amounts will be used to reduce future employer contributions and pay Plan expenses. During 2024, forfeitures of \$9,000 were used to reduce employer contributions.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) using the accrual basis of accounting.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Contributions:** Contributions from Plan participants and the related matching contributions from the employer are recorded in the year the employee contributions are withheld from compensation.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

**Payment of benefits:** Benefits are recorded when paid.

**Expenses of the Plan:** Substantially all expenses of maintaining the Plan are paid by the Companies. Certain administrative fees are paid by the Plan. Certain transaction fees are paid by Plan participants.

**Use of estimates:** The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and uncertainties:** The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent events:** The Plan has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified by Capital Bank and Trust Company

The following is a summary of the Plan's information as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to, or derived from, information certified as complete and accurate by Capital Bank and Trust Company, a qualified institution:

- All investments and notes receivable from participants;
- All investment income and interest income on notes receivable from participants;
- Information regarding investments in Note 4; and
- Information included on Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year).

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

**Level 1:** Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

**Level 2:** Observable market-based inputs or observable inputs that are corroborated by market data.

**Level 3:** Unobservable inputs for the assets or liabilities that are not corroborated by market data.

#### **Note 4. Fair Value Measurements (continued)**

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used in the current or prior year.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and, therefore, are considered Level 1 investments.

#### **Note 5. Tax Status**

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS), stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the pre-approved plan document; however, the Plan Administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all of their accounts.

#### **Note 7. Related-Party Transactions**

ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and the management of investments held by the qualified institution or its affiliates are considered party-in-interest transactions. Additionally, the Companies pay certain administrative fees for the Plan, as described in Note 2.
