NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Hurco Companies, Inc. 401(k) Retirement Plan (the Plan) provides only general information about the Plan's provisions. Hurco Companies, Inc. (the Company) is the plan sponsor. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General—The Plan is a defined contribution, profit-sharing plan covering substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Vanguard Fiduciary Trust Company serves as trustee of the Plan and administers the Plan's assets, as well as all recordkeeping of the Plan.

Contributions—Each year, participants may contribute to the Plan an amount equal to a percentage of the participants' compensation not to exceed certain limitations of the Internal Revenue Code (the Code), as defined in the Plan. Participants may contribute amounts representing rollovers from other qualified plans, and eligible participants may make catch-up contributions in accordance with Internal Revenue Service (IRS) regulations. The Company may make discretionary matching contributions to the Plan at the option of the Company's Board of Directors. The Company contributed 100% of the first 6% of a participant's deferred contributions of his or her compensation through May 5, 2024. Effective May 6, 2024, the discretionary employer matching contribution made by the Company to the Plan changed from 100% to 50% match for the first 6% contributed by the employee and effective December 16, 2024, the discretionary employer matching contribution made by the Company to the Plan changed from 50% to 100% match for the first 6% contributed by the employee. No discretionary matching contributions were contributed for 2024. Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the contributions are earned.

Administrative Expenses—The Plan incurs certain administrative expenses. These expenses are reported on the statement of changes in net assets available for benefits. Expenses related to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. All other administrative expenses are paid by the Company on behalf of the Plan.

Participant Accounts—Each participant's account is credited with the participant's contribution, and an allocation of the Company's contribution and the Plan's earnings and charged with an allocation of administrative expenses. Allocations are based on participant contributions, earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's own account.

Vesting—Participants are immediately vested in their own contributions and the Company's contributions plus actual earnings thereon.

Investments—Participants may direct the investment of their contributions and any employer contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. Investment options include a variety of publicly traded mutual funds and common/collective trusts.

Payment of Benefits—Upon termination of service with the Company, a participant is eligible to receive an amount equal to the value of the participant’s interest in his or her account. Participants may elect to receive payment in the form of a lump-sum amount or in installment payments. Active participants who have reached age 59½ are also eligible to receive benefits from the Plan. In certain circumstances, participants may make “hardship withdrawals,” as defined in the Plan. Hardship withdrawals are strictly regulated by the IRS and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal.

Notes Receivable—Participants may borrow from their fund accounts the lesser of 50% of the participant’s vested account balances or \$50,000, reduced by excess, if any, of the highest outstanding balance of loans during the one-year period ending on the day before the loan is made, over the outstanding balance of loans from the Plan on the date the loan is made. Loan transactions are treated as a transfer from (to) the investment fund to (from) the loan fund. The loans are secured by the balance in the participant’s account. Principal and interest are paid ratably through payroll deductions.

Plan Termination—Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Payment of Benefits—Benefits are recorded when paid.

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results may differ from those estimates.

Contributions—Employee contributions and employer contributions are recorded when earned.

Contributions Receivable from Participants and Employer—The Plan reviews contributions receivable to determine if any receivables will potentially be uncollectible. Factors used in assessing collectability include primarily timeliness of payment. Since the receivables were all collected and there is no history of uncollectability, there is no allowance for credit losses.

Notes Receivable from Participants—Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Investment Valuation and Income Recognition—Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 5 for further discussion and disclosures related to fair value measurements. Mutual funds are stated at fair value as determined by quoted market prices.

The Vanguard Retirement Savings Trust VIII, the Putnam Large Cap Value Trust, II and the AB US Large Cap Growth CIT (W Series); P-1 are collective trust funds valued at the net asset value of units of a bank collective trust. The Net Asset Value (NAV) as provided by the trustee is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to confirm that securities liquidations will be carried out in an orderly business manner. See Note 5 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses—Administrative expenses of the Plan are paid by the Plan or the Plan sponsor, as provided in the Plan document. Participants pay administrative costs for loans, distributions and qualified domestic relation orders.

All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

Subsequent Events—Management evaluated subsequent events for the Plan through September 8, 2025, the date the financial statements were available to be issued. No events occurred that require additional disclosure or adjustments to the Plan's financial statements.

3. INFORMATION CERTIFIED BY VANGUARD FIDUCIARY TRUST COMPANY

All investment balances and information disclosed in the accompanying financial statements and supplemental schedule were obtained or derived from information provided to the Plan and certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee of the Plan, including participant-directed investments at fair value and notes receivable from participants as of December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividend income, and interest income, participant notes receivable for the year ended December 31, 2024, the supplemental schedule of assets (held at end of year), excluding the level of investments and redemption periods in Note 5, Fair Value Measurements.

4. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. The underlying investment securities are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, and the level of uncertainty related to changes in the value of

investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

5. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price).

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows: Level 1, defined as observable inputs, such as quoted prices in active markets for identical assets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exist, therefore requiring management's judgment about assumptions for market pricing based upon available information, some of which may be internally developed.

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

The following tables present the hierarchy level for each of the Plan's assets and liabilities that are measured at fair value on a recurring basis as of December 31, 2024 and 2023.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan holds units of common/collective trust funds and certain mutual funds managed by the trustee. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

The Plan issues loans to participants, which are secured by the vested balances in the participants’ accounts. These transactions are considered exempt parties-in-interest transactions.

7. TAX STATUS

The underlying nonstandardized prototype plan has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the Plan is qualified under Section 401(a) of the Code and, therefore, the related trust is exempt from taxation. In accordance with Revenue Procedures 2012-6 and 2011-49, the plan administrator has determined that it is eligible to and has chosen to rely on the current IRS prototype plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan has been amended since receiving the opinion letter. However, plan management believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.
