## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Buffalo Hearing & Speech Center, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Notes to Financial Statements**

---

**1. Description of Plan:**

The following brief description of Buffalo Hearing & Speech Center, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. For more complete information, participants should refer to the text of the Plan document.

**General:**

The Plan is a defined contribution plan covering substantially all employees of Buffalo Hearing & Speech Center, Inc. (the Organization). An employee must attain age 21 and have at least 500 hours within the first six months of employment or 1,000 hours of service within a Plan year to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:**

Each year, participants may contribute up to 100% of pretax annual compensation, subject to maximum contribution amounts permitted by law. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Organization provides a discretionary matching contribution equal to 33% of the first 6% of compensation that a participant contributes to the Plan. The Organization may also provide a discretionary profit sharing contribution.

**Participant Accounts:**

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is based on years of continuous employment. A participant is 100% vested in Organization contributions after five years of credited service. Participants are credited for a year of service if they work at least 1,000 hours during the year.

**Investment Options:**

Plan participants direct contributions to any number of investment options offered through Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC (Empower). Participants may change investment options at any time.

**Notes Receivable From Participants:**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. Loan terms range from 1 year to 5 years. Loans for purposes of purchasing a primary residence may be repaid over 30 years. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the local bank prime rate. Principal and interest is paid ratably through bi-weekly payroll deductions.

**Payment of Benefits:**

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution equal to the participant's vested account balance. Additionally, hardship distributions are permitted if certain criteria are met.

**Forfeited Accounts:**

Forfeited non-vested accounts are used to reduce employer contributions. In 2024, employer contributions were reduced by \$46,635 from forfeited non-vested accounts.

## **2. Summary of Significant Accounting Policies:**

### **Basis of Accounting:**

The financial statements of the Plan are prepared under the accrual method of accounting.

### **Use of Estimates:**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### **Investment Valuation:**

The Plan's investments are stated at fair value. Shares of mutual fund investments are valued based on quoted prices in active markets that represent the net asset value of shares held by the Plan at year end. The common collective trust is valued based on the net asset value per share without further adjustment, as a practical expedient to determine fair value. Net asset value is based on the aggregate fair values of the underlying investments. Participants may redeem shares at net asset value daily, without restriction.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable From Participants:**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

### **Payment of Benefits:**

Benefits are recorded when paid.

### **Administrative Expenses:**

Certain administrative expenses for the Plan are borne by the Organization.

## **Subsequent Events:**

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 2, 2025 (the date the financial statements were available to be issued).

## **3. Information Prepared and Certified by Trustee:**

In accordance with Department of Labor Regulation 2520.103-8, the plan administrator has obtained certified "Statements of Account" from Empower as of December 31, 2024 and 2023 and for the year ended December 31, 2024, that the information below is complete and accurate:

- Statements of Net Assets Available for Benefits – Investments and notes receivable from participants.
- Statement of Changes in Net Assets Available for Benefits – Investment income and interest income on notes receivable from participants.
- Schedule of Assets (Held at End of Year) – all items and amounts.

## **4. Income Taxes:**

The Internal Revenue Service has issued a favorable opinion letter regarding the tax-exempt status of the Plan. Accordingly, no provision has been made for income taxes.

## **5. Plan Termination:**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **6. Risks and Uncertainties:**

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in investment values will occur in the near term and could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
