Note 1 - Plan Description

The following description of the Cascade Public Media 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document or summary plan description for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all employees who are employed by Cascade Public Media and Piranha Partners, Inc. (collectively, the Sponsor) other than individuals classified by the Sponsor as nonresident aliens or leased employees. All employers are members of a controlled group as defined by the Internal Revenue Code (IRC). The Plan provides for retirement benefits to employees who are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility - There is no age or service requirement for employees to participate in the elective deferral portion or matching contribution portion of the Plan. Employees are eligible for employer nonelective discretionary contributions if they are age 21 or older and have completed a year of service. A year of service is a consecutive 12-month period during which an employee completes at least 1,000 hours of service.

Contributions - Participants may elect to defer up to 100% of their eligible compensation as pre-tax or Roth contributions. New employees are automatically enrolled into the Plan to make deferral contributions equal to 3% of their eligible compensation unless the employee specifically waives enrollment or elects a different deferral percentage or amount. The deemed election shall automatically increase by 1% for each plan year for which the participant is participating to a maximum of 6%. Participants who are age 50 or older on or before the last day of the year are allowed to make additional contributions (catch-up contributions). Participants may also rollover amounts representing distributions from other eligible retirement plans.

The Sponsor makes matching contributions in an amount equal to 25% of deferrals up to the first 6% of employees' eligible compensation contributed to the Plan. In addition, the Sponsor may make discretionary nonelective contributions. The Board of Directors determined that the discretionary nonelective contribution for the plan year ended December 31, 2024 would equal 5% of eligible compensation plus 5% of eligible compensation in excess of the social security wage base (\$168,600 for the year ended December 31, 2024). Eligible employees will receive an allocation of nonelective contributions if they have completed at least 1,000 hours of service during the plan year and are employed by the Sponsor on the last day of the plan year.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions and Sponsor matching contributions, as well as allocations of the Sponsor's nonelective contribution and Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested portion of the participant's account balance. Participants direct the investment of their account into various investment options offered by the Plan.

Benefits Paid to Participants - Upon termination of service, retirement, or disability a participant may elect to receive a lump sum payment or installment payments equal to the value of their vested account balance. A deceased participant's vested account will be distributed to a beneficiary in accordance with the provisions specified in the plan document. The Plan also allows for in-service withdrawals due to hardship or when participants reach age 59½. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Note 1 - Continued

Vesting - Participants are 100% vested in elective contributions and matching contributions. Participants will vest in nonelective contributions as follows:

Participants will also be 100% vested upon reaching normal or early retirement age as defined by the Plan and upon death or disability.

Forfeitures - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,986 and \$0, respectively. During the 2024 plan year, approximately \$2,100 in forfeited accounts were used in accordance with provisions specified in the Plan document.

Notes Receivable From Participants - The Plan allows participants to borrow from their accounts using their vested balance as collateral for the loans. The maximum amount that a participant may borrow is equal to the lesser of 50% of their entire vested account balance or \$50,000. The minimum amount required to be borrowed is \$1,000. Loan terms range from one to five years unless the loan is used to acquire a principal residence. Principal and interest are paid ratably through semi-monthly payroll deductions. The interest rate are based on the prime rate plus 1%.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements have been prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates - The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2 - Continued

Benefits Paid to Participants - Benefits paid to participants are recognized when paid.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Investment Management and Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Transaction based fees for note receivable and benefit payments are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through September 24, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under this guidance are described as follows:

Level 1 - Unadjusted quoted prices available in active markets for identical assets or liabilities;

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 3 - Continued

Stable Value Collective Trust Fund - Valued at the NAV provided by the funds' trustee. The fund trades on a regular basis, has a published price that the Plan can obtain at any time and is valued based on this published price. Participant initiated withdrawals for benefit payments and transfers to other investment options may occur daily and are transacted at the fund's NAV. Sponsor initiated withdrawals may be subject to a fair market value adjustment. A written notice of intention to make such withdrawal must be provided to the fund's trustee within such time period as the trustee may establish from time to time.

The stable value collective trust fund was previously excluded from the fair value hierarchy following ASU 2015-07 guidance. During the current year, management reexamined the nature and characteristics of this investment and determined that such investment would meet the criteria for a readily determinable fair value measurement and should be presented within the fair value hierarchy. This presentation has been retrospectively applied.

Note 4 - Certified Investments

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank, a qualified institution. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 5 - Tax Status

The Company adopted a Randall & Hurley Inc pre-approved plan document. Randall & Hurley Inc received an approval letter from the IRS dated June 30, 2020, which states that the form of the plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 6 - Party-in-Interest Transactions

The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their discretionary nonelective contributions.

Note 8 - Risks and Uncertainties

The Plan's investments are invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


