**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed an audit of the financial statements of Equinor US Holdings Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

## 1 Description of Plan

The following description of the Equinor US Holdings Inc. 401(k) Retirement Plan (the Plan) provides general information about the Plan's provisions. Equinor US Holdings Inc. is the "Plan Sponsor". Equinor US Operations LLC is an affiliated company of the Plan. Equinor US Holdings Inc. and the affiliated company are heretofore referred to as the "Company". Participants should refer to the plan document and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the Plan Sponsor.

### 1.1 General

The Plan is a defined contribution plan covering all eligible and participating employees of the Company. Eligible employees have the option to enroll in the Plan once they have attained 21 years of age and have met all other eligibility requirements set forth in the Plan.

The Equinor US Holdings Inc. Fiduciary Committee (the Committee) is responsible for the general administration of the Plan. T. Rowe Price Trust Company (TRP) is the trustee of the Plan. T. Rowe Price Retirement Plan Services Inc. is the recordkeeper for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

### 1.2 Contributions

Participants may elect to make pretax deferral contributions of up to 75% of their eligible annual compensation as defined in the Plan. The Plan also allows employees to elect to make Roth contributions on an after-tax basis. If an eligible employee has not executed a deferral agreement or an affirmative election not to make deferral contributions within 30 days from first entry date into the Plan, the employee will be automatically enrolled at a 6% pretax contribution.

Automatic escalation of participant deferral percentages is applied on an annual basis in 1% increments capped at a maximum of 15%. Participants have the option to opt-out of the escalation. Participants who have attained age 50 or older prior to the end of the calendar year are eligible to make catch-up contributions. Participants may also make rollover contributions representing distributions from other qualified plans. The Company makes matching contributions for eligible participants equal to 100% of his or her elective deferrals, not to exceed 6% of his or her compensation. All contributions are subject to certain limitations of the Internal Revenue Code of 1986, as amended (IRC).

Participants direct all contributions into various investment options offered by the Plan. If a participant does not affirmatively elect an investment allocation, his or her contributions are invested in the T. Rowe Price Retirement Trust Fund with a target date that is closest to the year the employee turns 65. The allocation will remain in place until the participant changes his or her election.

### 1.3 Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and allocations of Plan earnings or losses. Plan earnings or losses are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options.

## 1.4 Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contributions and related earnings or losses is based on years of credited service as defined by the Plan. A participant is immediately vested 40% upon completion of 1 year of service. A participant continues to vest 20% per year, becoming fully vested after four years of service.

If the participant terminates employment with the Company as a result of death, disability or early retirement, as defined by the Plan, the matching contributions plus related earnings or losses credited to the participant's account will immediately become fully vested.

## 1.5 Participant Loans

Participants may borrow from their accounts up to the lesser of \$50 or 50% of their vested account balance, but not less than \$1. Loan terms range from one to five years or more than five years for the purchase of a primary residence. The \$50 limit is reduced by the participant's highest outstanding loan balance during the preceding 12-month period. A participant may not have more than two loans outstanding at any point in time. The loans bear interest at a rate commensurate with the Prime rate at date of issuance, as published by the Wall Street Journal, plus 2%. Principal and interest are paid ratably through biweekly payroll deductions. All loan originations are subject to a \$50 (in dollars) fee that will be withdrawn from the participant's account at the time the loan is initiated. Additionally, as part of the Committee's annual renegotiation of plan administrative fees, the new fee structure includes a \$25 (in dollars) annual loan maintenance fee for new loans.

## 1.6 Benefit Payments

Upon separation from service with the Company due to death, disability, retirement or termination, a participant whose vested account balance exceeds \$5,000 (in dollars) may elect to receive a lump-sum distribution or maintain his or her holdings within the Plan. A participant whose vested account balance is \$5,000 (in dollars) or less will automatically receive an immediate lump-sum distribution equal to his or her vested account balance.

In-service withdrawals are available in certain limited circumstances as defined by the Plan. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial burden as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Services (IRS), and a participant must exhaust all available loan options and available distributions prior to requesting a hardship withdrawal. Annually, the plan will pay required minimum distributions to all participants over age 73.

## 1.7 Forfeitures

At December 31, 2024 and 2023, total forfeited nonvested account balances are \$0 and \$112, respectively. These amounts will generally be used to reduce employer contributions and/or pay plan expenses. In 2024, \$240 of the forfeited nonvested account balances were used to fund employer contributions.

## 1.8 Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which the

expenses relate. For participants with a self-directed brokerage account, any related administrative fees will be paid directly from the participant's account.

Certain investment-related expenses are presented as a reduction of net appreciation/ (depreciation) in fair value of investments.

TRP will deduct a flat administrative fee from each participant on a quarterly basis. These administrative fees are recorded as administrative expenses.

TRP will also credit back any investment- related expenses paid to TRP to participants who incurred these expenses.

As part of the Committee's annual renegotiation of plan administrative fees, the fee structure includes a \$25 (in dollars) distribution fee applicable to lump sum and partial distributions. The distribution fee does not apply to installments, required minimum distributions and hardship withdrawals.

## 1.9 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in their accounts.

## 2 Summary of Significant Accounting Policies

### 2.1 Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (US GAAP).

### 2.2 Payment of Benefits

Benefits are recorded when paid.

### 2.3 Use of Estimates

The preparation of the financial statements in conformity with US GAAP requires management to make estimates that affect the reported amounts in the financial statements and accompanying notes to financial statements. Actual results could differ from those estimates.

### 2.4 Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## 2.5 Risks and Uncertainties

The Plan provides for investments in various securities that, in general, are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

## 2.6 Notes Receivable from Participants

Participant loans are recorded on the financial statements as notes receivable from participants at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Loan processing fees are paid out of participants' loan proceeds. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan is reduced and a benefit payment is recorded.

## 3 Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets or liabilities in markets that are not active
- observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety. The following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan.

Self-directed brokerage account: Plan participants have access to common stock, and preferred stocks, limited partnerships, and cash equivalents that are valued at the closing price reported on the active market on which the individual securities are traded. The limited partnerships included in the self-directed brokerage account are publicly held and thus are Level 1 in the fair value hierarchy.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are valued at the NAV of shares held by the Plan at year-end.

Common collective trust funds (CCTs): Valued at readily determinable fair value of shares held by the Plan at year-end. The CCTs publish a daily NAV which is available to the Plan and its participants. The Plan determined that the investments in CCTs have a readily determinable fair value because the investments are equity securities in a structure similar to a mutual fund in which the fair values per unit are determined and published and are the basis for current transactions. The Plan measures the investments at the published NAV because it concludes that it represents the price at which the investments would be sold in transactions between independent market participants. Therefore, the Plan includes the CCTs in its fair value measurement disclosures, including the fair value hierarchy table.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Company believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used or transfers between levels at December 31, 2024 and 2023.

## 4 Investments

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103 8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments, at fair value and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation and interest on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

## 5 Related Party and Party-In-Interest Transactions

Certain investments in the Plan are managed by the Trustee. These transactions qualify as party-in-interest transactions. The Plan also has notes receivable from participants. Such transactions are permitted under the provisions of the Plan are exempt from the prohibited transactions rules under ERISA.

## 6 Income Tax Status

The underlying volume pre-approved plan has received an opinion letter from the IRS dated August 19, 2020 stating that the written form of the underlying pre-approved document is qualified under Section 401 of the IRC. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the IRC, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. Though the Plan Document has been amended since the date of the opinion letter, the plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

US GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 7 Subsequent Events

Plan management has evaluated subsequent events through October 02, 2025, the date the financial statements were available to be issued.
