In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about New York Daily News Defined Contribution Retirement Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the New York Daily News Defined Contribution Retirement Plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the New York Daily News Defined Contribution Retirement Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the New York Daily News Defined Contribution Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Schedule Required by ERISA

The supplemental schedule of assets listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1. Description of Plan

The following is a brief description of New York Daily News Defined Contribution Retirement Plan (the “Plan”). Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established on February 15, 2018, as a result of the purchase of the Daily News, LP. (the “Daily News”, “Plan Sponsor”, “Employer”) by the Tribune Publishing Company (the “Company”, “Plan Sponsor”, or “Employer”) on February 3, 2018. The Plan is a defined contribution plan subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). Eligible employees are employees of the Daily News who are covered by collective bargaining agreements that provided for his or her participation in the Plan.

The Tribune Publishing Company was acquired by Alden Global Capital in a stock purchase transaction on May 25, 2021. On the same date, the Daily News was acquired by a separate standalone Company, NY Daily News Enterprises, LLC.

Employees at the Daily News terminated employment with the Tribune Publishing Company controlled group of companies effective May 24, 2021 and became employees of the NY Daily News Enterprises, LLC controlled group of companies effective May 25, 2021. Participants in the Plan remained in the Plan.

Effective March 30, 2022, the printing of the Daily News was outsourced and certain plant workers were laid off. Subsequent to the outsourcing of production on March 20, 2022, only union represented Drivers remain as employees eligible to participate in the Plan.

Eligibility and Contributions

A covered union employee who is not classified by the Daily News as either a leased employee, non-resident alien with no U.S. source income, self-employed, or any employee who is classified as an intern, editorial extra or temporary becomes eligible to participate in the Plan the first payroll period after which he or she has both attained the age of 21 and completed one year of eligible service defined as completion of 750 hours of service during a 12-month period. Participants may make both pre-tax and Roth contributions in a combined amount ranging from 1% to 50% of their eligible compensation, as defined by the Plan, subject to the statutory limitations of the Internal Revenue Code (“IRC”). Participants may make after-tax contributions ranging from 1% to 10% of eligible compensation, as defined by the Plan. Additionally, participants who are at least 50 years old may make additional catch-up contributions as defined by the IRC.

The Daily News may make discretionary contributions to the Plan. For certain covered union employees, the Daily News is required to make contributions as provided for in the applicable collective bargaining agreements. The Daily News made such required contributions to the Plan amounting to \$14,000 for the year ended December 31, 2024.

Vesting

Participants are always fully vested in their own contributions, discretionary profit-sharing contributions and employer contributions required by collective bargaining agreement. Participants are not vested in employer matching contributions until they complete three years of vesting service at which time they become fully vested in their matching contributions.

Forfeitures

The portion of a participant's account balance, which is not vested upon termination of employment, is forfeited and remains in the Plan. Forfeitures can be used to reduce employer contributions, or to pay allowable Plan expenses. There were no forfeitures during the year ended December 31, 2024. Forfeitures used to pay plan expenses totaled \$1,589 during the year ending December 31, 2024. As of December 31, 2024 and 2023, the forfeiture balance in the Plan totaled \$10,613 and \$11,606, respectively.

Benefit Payments

Upon attaining the age of 59½, a participant is entitled to a lump-sum distribution from the Plan or may elect periodic distributions as described in the Plan. In addition, participants may withdraw funds from the Plan upon termination of employment. Participants may elect to withdraw all or any portion of their account attributable to any after-tax and rollover contributions that have been made to the plan at any time regardless of the reason. Participants may request a withdrawal of a portion of their balances in the case of financial hardship. In the event of death while employed, the non-vested benefit becomes vested and can be distributed to beneficiaries as described in the Plan.

Notes Receivable from Participants

Loans may be available to the participants subject to the approval of the Plan administrator. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Their vested account balances also serve as collateral for the loan. A participant can have no more than two loans outstanding at any time. Interest rates ranged from 4.25% to 9.50% at December 31, 2024. Loans that are in defaults are accounted for as a distribution in the year the default occurs.

Participant Accounts

Each participant's account is credited with their contributions plus the Daily News contributions, and earnings thereon. Contributions are invested by Vanguard Fiduciary Trust Company ("Vanguard") according to the options elected by the participants. The investment options include various mutual funds.

Administrative Expenses

Distribution and loan fees are charged directly to the requesting participant's account. Substantially all other administrative expenses are paid by the Plan.

Note 2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Benefits Paid to Participants

Benefits paid to participants are recorded when paid.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amount of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

Note 3. Investment Information Certified by the Plan's Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at unadjusted quoted market prices in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are mutual funds managed by Vanguard. Vanguard is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid to Vanguard by the Plan for management services amounted to approximately \$21,500 for the year ended December 31, 2024. Fees paid for financial advisory services were approximately \$6,300 for the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

Note 6. Plan Termination

Although it has not expressed any intention to do so, Daily News has the right to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants would become 100% vested. Subsequent to the year end the Company terminated certain employees, resulting in a partial termination of the plan. As a result of the partial termination, the employees became 100% vested in all contributions.

Note 7. Tax Status

The Plan is in the process of applying for, but has not yet received, a tax exemption letter from the Internal Revenue Service. The Plan sponsor believes that the Plan and Trust are currently designed and operated in compliance with the applicable provisions of the IRC and the Plan document. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the DOL or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan provides for various investment options to the participants in any combination of mutual funds. These investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.
