## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of ACRT Services, Inc. 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, T. Rowe Price Trust Company, as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audit and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

## NOTES TO FINANCIAL STATEMENTS

### ACRT Services, Inc. 401(k) Plan

#### **1 Description of Plan**

The following description of ACRT Services, Inc. 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions.

##### ***General:***

The Plan is a defined contribution plan covering all employees of ACRT Services, Inc. and Subsidiaries (“Company”) who meet the hour and age requirements. Effective April 1, 2016, this includes all employees of Bermex, Inc., the wholly-owned subsidiary of ACRT Services, Inc. The Plan is subject to Section 401(k) of the Internal Revenue Code and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan was restated on February 17, 2022, to incorporate previous plan amendments and to change the Plan year-end from September 30 to December 31.

Effective January 1, 2023, the Plan Trustee and recordkeeper is T. Rowe Price Trust Company. In addition, assets totaling \$2,349,767 from the ACRT Services, Inc. Plan 005 merged into the Plan.

Effective June 1, 2024, the Plan was amended to make Local Union 1049, IBEW employees eligible for employer matching contributions.

Effective January 1, 2025, the Plan was amended and restated to add prior Safe Harbor contributions, allow in-plan Roth rollovers, change the vesting schedule to 5-year graded, add repayment options for loans and change the eligibility requirement and groups of non-Union employees.

##### ***Eligibility:***

All non-union employees of the Company age twenty-one and older, who are employed for 60 days, and are not independent contractors, nonresident aliens or residents of Puerto Rico, are eligible to participate in the Plan.

All union employees of the Company who are not covered under any other retirement plan to which the Company contributes, are eligible to participate in the Plan upon hire. Prior to June 1, 2024, Union employees are not eligible to receive employer matching contributions.

NOTES TO FINANCIAL STATEMENTS

ACRT Services, Inc. 401(k) Plan

**1 Description of Plan, Continued**

***Contributions:***

Employee Contributions – Newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect to not participate at a rate of 6% of eligible compensation. Contributions are invested in a designated balanced fund until the participant changes the election. On January 1 of each year, participant deferrals will be increased 1% up to 10% of pay unless they elect to not have the increase. Participants may elect to contribute the maximum allowed by the Internal Revenue Service (IRS). In addition, eligible participants may contribute catch up contributions.

Employer Contributions - The Company may make discretionary match contributions to each eligible participant's account by matching a percentage of the Participant's elective deferral for the plan year. The Company matches the first 25% of employee contributions up to 6%. Employer matching contributions for the years ended December 31, 2024 and 2023 were \$488,720 and \$587,828, respectively.

Rollover contributions from other plans are also accepted, providing certain specified conditions are met.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

***Participants' Accounts:***

Each participant's account is credited with the participant's elective contributions, employer matching contributions, participant rollovers and earnings and losses thereon.

***Vesting:***

All participants are 100% vested in elective deferrals and rollover contributions made to the Plan. Employer matching contributions are vested as follows:

***Forfeitures:***

Forfeitures used for the years ended December 31, 2024 and 2023 were \$202,731 and \$174,247, respectively. Forfeited non-vested accounts totaled \$17,095 and \$5,731 as of December 31, 2024 and 2023, respectively. Forfeitures may be used to pay allowable administrative expenses and reduce future employer contributions.

## NOTES TO FINANCIAL STATEMENTS

### ACRT Services, Inc. 401(k) Plan

#### **1 Description of Plan, Continued**

##### ***Notes Receivable from Participants:***

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed 5 years with exceptions for the purchase of a primary residence. Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

The loans are secured by the balance in the participant's account and bear interest at Prime plus 100 basis points. Principal and interest are paid ratably through payroll deductions.

##### ***Other Plan Provisions:***

Normal retirement age is 65, however, a participant may elect early retirement on or after age 55. The Plan also provides for early payment of benefits after reaching age 59-1/2.

##### ***Distributions:***

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account.

##### ***Hardship Withdrawals:***

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

##### ***Investment Options:***

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

#### **2 Summary of Significant Accounting Policies**

##### ***Basis of Accounting:***

The Plan's transactions are reported on the accrual basis of accounting.

##### ***Valuation of Investments:***

Investments are stated at fair value. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker.

## NOTES TO FINANCIAL STATEMENTS

#### **2 Summary of Significant Accounting Policies, Continued**

##### ***Valuation of Investments, Continued:***

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as held during the year.

##### ***Use of Estimates:***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

##### ***Administrative Fees:***

Substantially all administrative fees are paid by the Company.

##### ***Plan Termination:***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

##### ***Risks and Uncertainties:***

The Plan's investments include investments in mutual funds, pooled separate accounts, guaranteed income contract, and collective funds holding investment contracts with varying degrees of risk, such as interest rate, credit, and overall market volatility risks.

Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statement of net assets available for plan benefits.

##### ***Payment of Benefits:***

Benefits are recorded when paid.

##### ***Contributions:***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### **2 Summary of Significant Accounting Policies, Continued**

##### *Subsequent Events:*

Management evaluates subsequent events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

#### **3 Tax Status**

On August 19, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

#### **4 Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets
- \* Quoted prices for identical or similar assets or liabilities in inactive markets
- \* Inputs other than quoted prices that are observable for the asset or liability
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

***Mutual Funds:***

The fair value of the mutual funds is based on quoted market prices. These investments are classified in the Level 1 category of the valuation hierarchy.

***Common Collective Trusts:***

The fair value of the Common Collective Trust fund held by the Plan as of December 31, 2024 and 2023 is based on the net fair value of the underlying assets. The underlying investments are valued at fair value based on commercial quotation services. The fair value is allocated among the contract holders based on a unit value. Short-term securities with remaining securities of 60 days or less, are valued at amortized cost. This falls into the Level 2 category of the valuation hierarchy.
