Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Alto Ingredients Pekin Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1. Description of the Plan

The following description of Alto Ingredients Pekin Pension Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined-benefit plan established November 1, 1981, covering certain employees of Alto Pekin, LLC (the Company). The Plan is maintained pursuant to the terms of a collective bargaining agreement. The most recent collective bargaining agreement will expire on October 31, 2026. Eligible participants in the Plan are all union employees of the Company hired prior to November 1, 2010, and who are compensated on an hourly basis. Participation in the Plan began automatically for qualifying union employees hired prior to November 1, 2010. Independent contractors, leased employees, highly compensated employees and employees of affiliated employers who have not adopted the Plan were excluded from participation in the Plan.

The Plan was amended, effective November 1, 2010, to preclude new entry into the Plan by employees hired on or after the effective date. Furthermore, no inactive or former participants may reenter into the Plan. All employees covered under the Plan on December 31, 2010, shall continue to be covered under the restated Plan with no loss of benefits and will continue to accrue benefits and vest as long as they are active employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan is administered by the Company's Investment Committee (the Committee), which is assigned by Company management. The Committee has overall responsibility for the operation and administration of the Plan. The Committee determines the appropriateness of the Plan's investments and monitors investment performance. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and its affiliate, Principal Life Insurance Company (collectively, Principal) is the trustee of the Plan and handles all record keeping and custodial responsibilities as well as prepares the Form 5500 and regulatory compliance testing.

Contributions: The Plan is noncontributory on the part of participants. Contributions from the Company are actuarially determined and accrued annually. Contributions are invested in accordance with the Plan document. Interest, dividends, and net realized and unrealized gains/losses on investments serve to reduce future contributions that would have otherwise been required to provide the defined level of benefits under the Plan.

Funding policy: The Plan's funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. During 2024, the Company met the minimum funding requirements of ERISA.

Vesting: A participant's interest in the benefits to be received by the Company is vested based on years of continuous service. A participant is 100% vested after five years of credited service. Prior to five years of credited service, a participant is not vested in the Plan.

Benefits: Participants are eligible for normal retirement benefits at age 65. The normal retirement benefit is based on the participant's years of credited service prior to the date of retirement. Under the normal form of retirement benefit, as defined in the Plan, a monthly benefit, as defined in the collective bargaining agreement, multiplied by the number of years of credited service is paid to eligible participants. If the accumulated value of the pension benefit is \$7,000 or less, the benefit will be distributed in the form of a lump-sum distribution.

Note 1. Description of the Plan (Continued)

The Plan also provides for early retirement, disability, and death benefits as follows:

- **Early retirement:** Early retirement benefits may start at the later of the participant reaching age 55 or completing 10 years of credited service. The early retirement benefit is reduced by one-third of 1% per month for each month that benefits are paid prior to the participant's attainment of age 62.
- **Disability:** A participant with 15 or more years of service who, while an employee, becomes totally disabled as defined in the Plan document or has been disabled for six consecutive months shall be entitled upon proper application to retire on a disability retirement date and receive normal retirement benefits based on years of credited service as of the participant's disability retirement date.
- **Death:** Survivor benefits are payable to a participant's spouse, provided the participant has five or more years of service. Benefits at a reduced amount commence no earlier than the date on which the participant would have been eligible to take early retirement.

In most cases, participants have the option of receiving benefits in the form of a single-life annuity, joint and survivor benefit, or 10-year certain and life annuity.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the Plan Administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. The Plan uses an actuary to determine the actuarial present value of accumulated Plan benefits. A change in the actuarial assumptions used could significantly change the amount of the actuarial present value of accumulated Plan benefits reported in Note 3.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Benefit payments: Benefit payments are recorded when paid.

Actuarial present value of accumulated plan benefits: Accumulated plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions for the service employees have rendered. Accumulated plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries and (b) present employees or their beneficiaries. Benefits payable under all circumstances—retirement, death, total disability, and termination of employment—are included, to the extent they are deemed attributable to employee service rendered to the valuation date. See Note 3 for further information.

Note 2. Summary of Significant Accounting Policies (Continued)

Administrative expenses: Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Certain administrative costs of the Plan are paid by the Company and are excluded from these financial statements. All other costs are paid by the Plan.

Subsequent events: The Plan Administrator has evaluated subsequent events for potential recognition and disclosure through October 3, 2025, which is the date the financial statements were available to be issued.

Note 3. Actuarial Present Value of Accumulated Plan Benefits

The actuarial present value of accumulated plan benefits is determined by consulting actuaries and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death, permanent disability, withdrawal or retirement) between the valuation date and the expected date of payment. The more significant assumptions underlying the actuarial computations for 2024 and 2023 are as follows:

The Plan Administrator has obtained certifications from the trustee that information provided to the Plan Administrator by the trustee related to the following investments is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedules related to the following assets:

Note 5. Fair Value Measurements

Accounting standards establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value.

Mutual funds: Shares of mutual funds are valued at the quoted market price of shares held by the Plan as of year-end determined in active markets.

Pooled separate accounts: Pooled separate accounts (other than Principal Real Estate Securities Account) invest primarily in domestic and international stocks, commercial paper and mutual funds. The Principal Real Estate Securities Account invests primarily in commercial real estate and includes mortgage loans, which are backed by the associated properties. The net asset value (NAV) is used as a practical expedient to determine fair value for these accounts.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Plan Termination

In the event of Plan termination, the Plan will be liquidated and the assets will be distributed (after provision has been made for the expenses of administration, termination and benefits accrued prior to the date of termination) in the following order of precedence:

1. Benefits to participants or beneficiaries who began receiving benefits at least three years before the Plan termination date (including those benefits that would have been payable for at least three years had the participant retired) based on plan provisions in effect during the five years prior to termination, which provisions produce the least benefits.
2. All other benefits insured by the Pension Benefit Guaranty Corporation (PBGC).
3. All other nonforfeitable benefits under the Plan.
4. All other benefits under the Plan.

Note 6. Plan Termination (Continued)

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations and may also depend on the financial condition of the Company and the level of benefits guaranteed by the PBGC.

Note 7. Income Tax Status

The Plan has adopted a non-standardized pre-approved defined benefit plan document sponsored by Principal. Principal received an opinion letter from the Internal Revenue Service (IRS), dated February 28, 2023, which states that the non-standardized pre-approved defined benefit plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since then, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Management evaluated the Plan's income tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require adjustments to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Related-Party and Party-In-Interest Transactions

Certain Plan assets are shares of pooled separate accounts managed by Principal, the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the 2024 statement of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Vested benefits

A benefit is included in vested benefits if it meets the requirements under PBGC. The benefit is multiplied by the participant’s vesting percentage applicable to each benefit on the valuation date.

The following ancillary benefits are always treated as nonvested: disability benefits payable to retirement age unless in pay status, pre-retirement death benefits in excess of the survivor annuity death benefit and post retirement death benefits for non-retired participants except as noted in the Plan provisions.

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. In October 2019, the SOA released the Pri-2012 Mortality Tables for private-sector retirement plans in the U.S. The Pri-2012 report contains different sets of mortality tables based on complete dataset or various subsets. The Blue collar base rate table was selected based on information provided by the plan sponsor.

Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe “Approach 1” is reasonable for this plan.

Interest rate used to value liabilities

The interest rate used to value ASC 960 liabilities is developed as long-term expected geometric return on plan assets. Arithmetic expected return is calculated as the weighted average of broad asset classes’ arithmetic returns of the plan’s target asset allocation, and then converted to the geometric under lognormal distribution assumption. For details, see Long-Term Capital Market Assumptions link.

Treatment of administrative expenses

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.
