We have performed audits of the accompanying financial statements of ATX Networks 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Notes to Financial Statements

1. Description of Plan

The following description of the ATX Networks 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan was adopted on April 1, 2011 as a defined-contribution and profit-sharing plan covering all employees at InnoTrans Communications, Inc. (“InnoTrans”) and Pico Digital, Inc., which are subsidiaries of ATX Networks, Inc. (the “Plan Sponsor”, “Plan Administrator” or the “Company”), except for any employees covered by a collective bargaining agreement, leased employees, or non-resident aliens. The Plan was previously named the Pico Digital 401(k) Plan. The Plan has been amended and restated effectively on March 18, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Fidelity Management Trust Company is the trustee of the Plan and Fidelity Workplace Services, LLC is the asset custodian (“Fidelity”).

Eligibility

Employees of the Company who are over 18 years of age are eligible to participate in the Plan on the first day of the subsequent month following the hire date, with no minimum hours requirement.

Contributions

Participants may contribute up to 75% of eligible compensation. In addition, if the participant’s age is 50 or over during the calendar year, then the employee may be permitted to make an additional catch-up contribution subject to limitations from the Internal Revenue Service. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in an age-appropriate target date fund until changed by the participant. Automatically enrolled participants will have an annual increase of 1% to their contributions until they reach a deferral rate of 6%. Participants may also designate all or part of their contributions as Roth 401(k) contributions, which are maintained separately. During each pay period, the Company contributes a safe harbor matching contribution of 100% up to the first 3% plus 50% of the next 2% of a participant’s compensation, which is contributed as a qualified automatic contribution arrangement safe harbor match. The Plan Sponsor also can make additional discretionary matching contributions; however, the additional match may not exceed 4% of the participants eligible compensation for the year.

Contributions (continued)

The Plan accepts rollover contributions from other qualified retirement plans, except for after-tax accounts.

Participant Investment Options

Participants must direct their contributions from salary deferrals and their allocated share of employer contributions into investment options as made available and determined by the Plan Administrator.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution, investment earnings thereon and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are 100% vested in any additional discretionary matching contributions, any qualified automatic contribution arrangement (QACA), safe harbor matching contributions and any discretionary matching contributions made by the Company.

Forfeitures

In the event participant benefits are forfeited, those amounts may be used to pay Plan expenses or to reduce Company contributions. The ending forfeiture account balances were \$1,156 and \$3,554 as of December 31, 2024 and 2023, respectively. No forfeitures were used to reduce administrative expenses during 2024. Forfeitures of \$3,541 were used to reduce employer contributions for the year ended December 31, 2024.

Notes Receivable from Participants

Participants may borrow from their fund accounts in amounts ranging from \$1,000 to \$50,000, but not in excess of 50% of the vested account balance. Notes are repaid at a reasonable rate of interest through payroll deductions within five years or, in the event the note is used to acquire a principal residence, the Plan Administrator may permit a longer repayment term. Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Payment of Benefits

Upon termination of service, a participant may elect to receive benefits in a lump-sum distribution, on an installment basis, receive a rollover of the vested account balance into another qualified plan, or defer receipt to a date no later than that prescribed by government regulation. Account withdrawals are permitted by participants who suffer certain financial hardships and meet criteria established by the Internal Revenue Code (“IRC”). Terminated participants with vested account balances of \$5,000 or less can be paid in a lump-sum cash amount.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States (“GAAP”).

Investments and Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lower priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (“ASC”) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Investments and Fair Value Measurements (continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the methodologies used to value the Plan's investments:

Mutual funds: Such investments are valued at the daily closing price as reported by the respective fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: The Plan's indirect investments in the common/collective trusts are valued at the net unit value ("NUV") of units held by the Plan at year-end based on information reported in the common/collective trusts audited financial statements at year-end. The NUV is determined by the total fair value of fund's net assets divided by the total number of units outstanding. The Plan uses a practical expedient permitting a reporting entity to measure the value of certain investments using the NUV per share (or its equivalent) of the investment. Because the Plan has an indirect investment in the contracts held by the common/collective trusts, they are not considered fully benefit responsive.

The methods described above may produce a value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the value of certain financial instruments could result in a different value measurement at the reporting date.

Income Recognition

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued daily. Dividends are recorded on the ex-dividend date. Realized gains and losses from investment transactions are reported on the average cost method. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market conditions and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

3. Information Certified or Provided by Fidelity

The Plan's investments were held by Fidelity at December 31, 2024 and 2023 and the following investment information was certified to be complete and accurate within the meaning of 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Interest and dividend income from investments and net appreciation in the fair value of investments reflected on the accompanying Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

4. Tax Status

Effective March 18, 2022, the Plan amended and restated their non-standardized form of a prototype plan sponsored by Fidelity. The prototype plan has received an opinion letter from the Internal Revenue Service, dated June 30, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is currently designed and is being operated in compliance with the applicable provisions of the IRC. Therefore, the Plan Administrator believes the Plan is qualified and the related trust is tax-exempt.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan Administrator believes that the Plan has taken no uncertain tax positions that require adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. Party-In-Interest Activity

Certain administrative functions are performed by employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the Plan Sponsor. The Plan offers investments managed by Fidelity Workplace Services Investments, an affiliated entity with Fidelity. Such activity qualifies as permitted party-in-interest transactions. Notes receivable from participants are also considered permitted party-in-interest activities.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA and discontinue its contributions at any time. In the event of Plan termination, participants would become 100% vested in their employer matching and profit-sharing accounts.

7. Prohibited Transactions and Contingencies

Late Remittances

For the years ended December 31, 2024 and 2023, the Company transferred employee contributions of \$2,008 and \$79,050, respectively, into the Plan after what was considered a reasonable period of time. The estimated lost earnings were \$2 and \$46 for the years ended December 31, 2024 and 2023, respectively. Management intends to fully self-correct these prohibited transactions as they relate to the 2024 and 2023 Plan year,

respectively. The Plan and/or the Plan sponsor may be subject to various fines, penalties and interest. The accompany financial statements do not include any accruals or provisions related to the outcome of this uncertainty.

8. Subsequent Events
