Note A

Description of Plan

The following description of the Horizon IQ 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan established on January 1, 1998, and has been amended and restated throughout the years to comply with tax regulations. The Plan was restated effective September 22, 2021, to comply with the IRS Cycle 3 restatement remedial amendment period. The plan provisions cover all employees of Internap Holdings, LLC (the "Company" or "Sponsor") who are at least 21 years of age, except certain groups of employees that are excluded per the Plan document. Employees are eligible to contribute the first pay period immediately following the date that the eligibility requirements have been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective May 2, 2024, the Plan was amended to modify the Plan name to Horizon IQ 401(k) Savings Plan.

Contributions:

Participants may elect to contribute up to 92% of compensation up to a maximum dollar amount as established by the Internal Revenue Service ("IRS"). These contributions may include elective deferrals, Roth deferrals, and non-matching after tax deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Effective January 1, 2021, all currently eligible employees without a deferral election on file and newly eligible employees will be automatically enrolled into the plan after a 35 days notice period. The participant will automatically have compensation deferred at a rate starting at 3% and increased automatically in April of each year until their deferral equals at least 10% or they opt out of the increase (annually).

Each year the Sponsor may make discretionary matching contributions, to be determined by the Sponsor, of the participant's elective deferrals. This amount may be adjusted up or down each year. For the year ended December 31, 2024, the Sponsor elected to make matching contributions of 50% of the employees' elected deferral up to a maximum of 6%. An employee is eligible to participate in the employer matching contribution after achieving six months of service. The Sponsor may also make additional discretionary profit sharing contributions and qualified nonelective contributions. For the year ended December 31, 2024, the Sponsor elected not to make profit sharing contributions and there were no qualified nonelective contributions. An employee may terminate his or her election to participate at any time. An employee may change his or her contribution levels each payroll period during the year. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Description of Plan (Continued)

An employee may roll over into this Plan a distribution that qualifies as an "eligible rollover distribution" under Internal Revenue Code ("IRC") Section 402(c)(4). An "eligible rollover distribution" can only be made from a 401(a) plan, 403(a) plan, 403(b) annuity, 457(b) plan, IRA, or annuity (IRA). The rollover must be made within 60 days for a distribution made directly to the participant.

Participant Accounts:

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and is reduced for loans and benefit payments. Participant accounts are further credited or charged with their pro rata share of earnings, gains, or losses on the total investments in each investment account and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or set fees as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting for Sponsor profit sharing and matching contributions are as follows:

Payment of Benefits:

Benefits are payable upon retirement at age 65, or early retirement at age 55 with five years of service. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at any time. Benefits are payable in lump sum or installment payments.

Forfeited Accounts:

Forfeited accounts are first made available to reinstate previously forfeited account balances of former participants, provided that the former participant is re-employed within five years from the date of termination of employment. Forfeited accounts will be used to reduce Company contributions or to pay reasonable plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,336 and \$5,571, respectively. During 2024, no forfeitures were used.

Revenue Credit Account:

In situations where recordkeeping revenue received in connection with plan services exceeds agreed-upon compensation, Fidelity Investments ("Fidelity") can deposit amounts equal to such excess revenue in a suspense account in the plan. The Administrator may direct Fidelity to use amounts held in the Revenue Credit Account to reimburse the Employer for fees and expenses associated with services provided to the Plan, or to pay vendors, including Fidelity or third parties, directly. As of December 31, 2024 and 2023, the Revenue Credit Account totaled \$20,319 and \$81,443, respectively. During the year ended December 31, 2024, administrative expenses of \$21,368 were paid through the Revenue Credit Account and \$40,899 of credits were allocated to participants.

Plan Administration:

Contributions to participants' accounts are held by the plan trustee, although participants direct the investment of the funds in their accounts under the available investment options. The plan fees associated with administering the Plan in 2024 were paid for by the Plan and amounted to \$84,683. Transaction fees charged by the plan trustee are paid out of the Plan and netted against net appreciation (depreciation) in fair value of investments.

Notes Receivable from Participants:

Participants may borrow against their investment account balances a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested balance, whichever is less. Generally, loans can be made for a period not exceeding five years; however, in certain circumstances, terms can be extended beyond five years, as defined by the Plan. The loans are collateralized by the vested balance in the participant's account and bear interest at rates commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions.

Note B

Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investment Valuation and Income Recognition:

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note I for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Operating Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain administrative and advisory fees are paid by the Plan and included in administrative expenses.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan payments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and the participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions:

Participant contributions and the related Company matching contributions are recognized in the period the participant contribution is withheld from compensation.

Payment of Benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

Use of Estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note C

Related Party Activity

Certain Plan investments are shares of investments managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative expenses for the year ended December 31, 2024, paid to Fidelity Management Trust Company totaled \$42,098. In addition, advisory fees paid by the Plan were paid to Creative Planning LLC, and Strategic Advisors, Inc., which totaled \$35,000 and \$5,074, respectively. Strategic Advisors, Inc. is a subsidiary of Fidelity and these advisor fees are related to advisory and management services of certain participant requested services. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note D

Information Prepared and Certified by Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

Note E

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note F

Plan Termination and Partial Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

As a result of a reduction of the Plan Sponsor's workforce, the Plan experienced a partial plan termination as defined by ERISA. Under ERISA, a partial plan termination may occur if a significant percentage of the Plan participants are terminated because of an action taken by the Plan Sponsor. If a partial plan termination occurs, full vesting in the employer's contribution is required for the affected participants, but the remaining participants' vesting continues to be determined per the plan provisions.

Note G

Income Tax Status

Effective September 22, 2021, the Plan was formally amended to adopt the pre-approved defined contribution plan sponsored by Fidelity Management & Research Co ("FMR, LLC"). The pre-approved plan provider has received an opinion letter from the Internal Revenue Service dated June 30, 2020, as to the pre-approved plan's qualified status. The pre-approved plan advisory letter has been relied upon by the Plan. The Plan has been amended since the pre-approved plan received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

GAAP requires plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note H

Investment Contracts with Insurance Company

Beginning in 2017, the Plan invested in the Prudential Guaranteed Income Fund (GIF). The GIF is a stable value fund designed to provide safety of principal, liquidity and a competitive rate of return. Under the group annuity insurance contract that supports this product, participants may ordinarily direct permitted withdrawal or transfers of all or a portion of their account balance at contract value within reasonable time-frames. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract is effected directly between the plan sponsor (or their trustee) and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer. Given these provisions, Empower Annuity Insurance Company (f/k/a Prudential) considers this contract to be fully benefit responsive. As described in Note B, because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract.

Generally there are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days or contract value paid over time. There are not any events that allow the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than contract value paid either within 90 days or over time. Distributions resulting from a plan participant's termination of employment, retirement, death or disability, hardship withdrawals and minimum required distributions will always be paid in full without any fees or restrictions and will not be deferred. Transfers and in-service withdrawals (other than hardship or minimum required distributions) and loan requests may be deferred if pool level cash outflows exceeds 10% of the pool's beginning of calendar year balance. Transfers may be deferred if plan level cash outflows exceed 25% of the plan's beginning of calendar year balance. Amounts withdrawn may not be transferred to a competing fund for 90 days after withdrawal. A Competing Fund is any stable value option or an investment option available under the plan that is primarily comprised of high quality fixed income securities with an average duration of less than or equal to 3.5 years.

Note I

Fair Value Measurements

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three Levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Common collective trusts: Valued at the NAV provided by the fund's trustee as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant level transactions take place daily and typically the liquidation would be requested on one day and processed the next business day.

Interest-bearing cash: Valued at quoted market prices in an active market.
