### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of PK U.S.A. 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024 and the nine months ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of PK U.S.A. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## **Note 1. Description of the Plan**

The following description of PK U.S.A. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

### **General**

The Plan is a defined-contribution retirement plan established to provide savings opportunities and retirement benefits for participants and their beneficiaries. The Plan was adopted effective August 1, 1989. Substantially all employees of PK U.S.A., Inc. (Company) and affiliate, Blue River Stamping, Inc., who are not subject to a collective bargaining agreement and have been employed with the Company for at least six months and have attained the age of 18, are eligible to participate, subject to certain requirements. Ocean Stream Enterprise, Inc. was a participating employer. Effective December 1, 2023, Ocean Stream Enterprise, Inc. will no longer be a participating employer of the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). American United Life Insurance Company (AUL) serves as Plan custodian. Reliance Trust Company serves as the trustee of the Plan.

Effective December 1, 2023, the Plan was restated to change from fiscal year ended March 31 to a calendar year of December 31. The accompanying financial statements present the nine months period ended December 31, 2023.

### **Contributions**

The Plan permits eligible employees through a Compensation Redirection Agreement to make annual contributions up to 100% of eligible compensation, as defined in the Plan, subject to annual maximum contribution limitations established annually by the Internal Revenue Service (IRS). Employee rollover and catch-up contributions are also permitted. The Plan also allows after-tax employee contributions and Roth contributions. Effective December 1, 2023, after-tax employee contributions are no longer permitted.

Effective January 1, 2024, the Plan was restated and adopted safe harbor 401(k) provisions, which includes a safe harbor contribution that equates to 100% of participant's elective deferrals that do not exceed 4% of the participant's compensation.

The Plan also provides for discretionary employer matching contributions. Prior to January 1, 2024, for participants with less than six years of service, the Company contributes 50% of the first 6% of a participant's contribution to the Plan, subject to certain limitations, as defined by the Plan. The Company contributes 50% of the first 8% of a participant's contribution for participants with six or more years of service. In addition, the Company may contribute discretionary employer nonelective contributions. There was no discretionary employer match and employer nonelective contributions for the year ended December 31, 2024 and for the nine months period ended December 31, 2023.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation, unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred and is ultimately capped at 8%.

### **Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's matching contribution, discretionary contributions, if applicable, and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary and any discretionary contributions plus earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus earnings thereon is based on years of service. A participant is fully vested after six years of service. The nonvested balance is forfeited upon termination of service. A participant becomes 100% vested in his total account balance regardless of the vesting schedule upon attaining age 65, age 55 and 5 years of service, death, retirement or disability, as defined by the Plan.

***Payment of Benefits***

Upon termination of service, a participant may elect to receive payment in the form of a qualified joint and survivor annuity or a lump-sum amount equal to the value of his account. Hardship withdrawals are not permitted by the Plan. Annuities are not allowed by the Plan. A participant may elect to receive a lump-sum, substantially equal installments or partial withdrawals.

***Notes Receivable From Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are repayable over a period not to exceed five-years (except for loans for the purchase of a principal residence) through payroll withholdings. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator. A participant may not have more than two loans outstanding at the same time.

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan Document.

***Forfeitures***

Forfeitures of \$103,182 and \$26,938 were used to reduce Company contributions as of December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$129 and \$1,455, respectively.

***Plan Termination***

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all of their accounts.

**Note 2. Summary of Significant Accounting Policies**

***Method of Accounting***

The accompanying financial statements are prepared on the accrual method of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

The fixed fund and stable value fund under the fully benefit-responsive AUL group annuity contracts are recorded at contract value. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Separate accounts under the group annuity contract are valued at fair value as determined by the custodian utilizing quoted market prices of the underlying assets daily. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The AUL Fixed Account and AUL Stable Value Account fully benefit-responsive investment contracts are valued at contract value that is estimated by AUL based on the contractual terms of the underlying agreement, providing a daily rate of income accretion. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

As described above, because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by AUL, represents contributions made under contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

***Plan Tax Status***

The Plan operates under a non-standardized pre-approved profit-sharing plan sponsored by OneAmerica Financial Partners, Inc. This prototype plan document has been filed with the appropriate agency and has obtained an opinion letter from the IRS stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax-exempt as of the financial statement date. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the employer or the Plan, at the employer's discretion.

**Note 3. Certification of Plan Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, AUL, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024 and the nine months period ended December 31, 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets held at year end as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. Level 2 securities include separate account investment options. See Note 2 for definition of inputs utilized to determine fair value.

**Note 5. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invests in pooled separate accounts and the fixed fund of the Plan custodian. Fees paid to the custodian by the Plan totaled \$4,110 and \$3,018 at December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

**Note 6. Significant Estimates and Concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7. Subsequent Events**

Subsequent events have been evaluated through October 2, 2025, which is the date the financial statements were available to be issued.
