Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Yeshiva University After-Tax Annuity Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Yeshiva University After-Tax Annuity Plan (the “Plan”) provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan became effective December 31, 1994. It is a defined contribution plan covering eligible employees of Yeshiva University (the “Sponsor”) and is intended to be a nonqualified annuity plan as described in Section 403(c) of the Internal Revenue Code (the “Code”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan administrator and the Plan’s tax counsel believe that the Plan is currently being operated in compliance with the applicable requirements of the Code. The Plan administrator is the Yeshiva University Retirement Plan Committee. Effective September 15, 2015, the Plan was frozen, and no additional participants could join after that date. All participants are fully vested, and no additional contributions can be made; however, participants may change their investment options.

Eligibility

Under the terms of the Plan, certain employees who participated in the Yeshiva University Retirement Income Plan, except employees covered by collective bargaining agreements, were eligible to participate in the Plan.

Vesting

Participants were immediately vested in the Sponsor’s contributions to their account, plus any investment earnings, gains, or losses thereon.

Contributions

Prior to the Plan freeze, the Sponsor had agreed to contribute to the Plan, on behalf of active participants who made the maximum contribution of 7 percent of compensation to the Yeshiva University Retirement Income Plan, an amount equal to 3 percent of eligible compensation based on job classification. In addition, certain employees received a 7 percent contribution in excess of the Code Section 401(a)(17) compensation limit.

Participant Accounts

Each participant’s account is credited with an allocation of Plan earnings and is charged with his or her withdrawals and an allocation of investment expenses. Allocations are based on the participant’s account balance, as defined.

Investment Options

Participants had the option to invest the amount credited to their accounts at Fidelity Management Trust Company (“Fidelity”), in either a Guaranteed Interest Account (“GIA”) and/or any of the 18 other investment options consisting of variable annuity assets. Participants may change their investment options daily.

(Continued)

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits

A participant is entitled to receive benefits under the Plan upon the earlier of termination of employment, on or after the attainment of the normal retirement age if he or she becomes ineligible to make employee contributions under the Yeshiva University Retirement Income Plan, or the attainment of age 73. A participant may receive benefits either in a lump sum amount equal to the value of his or her account, or in annuity payments over a period designated by the participant, but not more than the life expectancy of the participant, or the joint life expectancies of the participant and his or her designated beneficiary, if any. If a participant's balance is \$1,000 or less, the full value of the account shall automatically be paid as soon as administratively practicable following termination of employment or attainment of any of the other milestones entitling the participant to receive benefits, to the extent permitted under the applicable contracts between The Empower Annuity Insurance Company of America ("Empower").

Administrative and Investment Management Expenses

The Plan's recordkeeping and custodial fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Sponsor or through revenue-sharing arrangements. The Plan and Fidelity entered into a revenue-sharing arrangement whereby a portion of the revenue earned by the custodian for certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credit as a result of this revenue-sharing arrangement, and to use this credit to pay for Plan expenses, the Plan created a Revenue Credit Account. The Revenue Credit Account is a cash account within the Plan that is used to record the receipt of Plan-generated fund revenue and use of that revenue to offset the Plan administration costs. The Revenue Credit Account balance was \$245,185 and \$425,727 as of December 31, 2024 and 2023, respectively. During 2024, \$185,595 from the Revenue Credit Account was used to reduce Plan expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingencies at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

(Continued)

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

The Plan's investments, other than fully benefit-responsive investment contracts (see Note 5), are reported at fair value as further described in Note 3. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 – INVESTMENTS

The Plan's investments at fair value consist entirely of holdings in variable annuity contracts. The fair values of participation units held in variable annuity contracts are not leveled and are based on the net asset values reported by the fund managers as of the financial statement dates and recent transaction prices. The Plan makes available to participants 18 variable annuity accounts in which to invest existing balances. Each of these variable annuity accounts held directly by the Plan provides for daily redemptions by the Plan at reported net assets values per share, with no advance notice requirement.

NOTE 4 – CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the custodian of the Plan).

NOTE 5 – GUARANTEED INTEREST ACCOUNT

The Plan holds a fully benefit-responsive investment contract with Empower. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charges for participant withdrawals and administrative expenses. Empower, as issuer of the contract, is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the issuer or otherwise.

Under the Plan's investment contract, a Sponsor-initiated termination of the contract is an event that could limit the ability of the Plan to transact at contract value paid within 90 days. In this instance, contract value could be paid over time, or, at the Sponsor's discretion, paid over at most a one-year period after the application of market value adjustments.

There are no events that allow the issuer to terminate the contract and which require the Sponsor to settle at an amount different than contract value paid either within 90 days or over time. As of the date of these financial statements, Plan management does not believe that it is probable that the contract will be terminated.

NOTE 5 – GUARANTEED INTEREST ACCOUNT (Continued)

The crediting interest rate of the contract is determined by Empower without the use of a specific formula, as defined in the contract agreement, but cannot be less than 3 percent. Such interest rates are reviewed on a quarterly basis for resetting. The key factors that influence future interest crediting rates could include the following: current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various types of investments that are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate or amend the Plan at any time, subject to the provisions of ERISA.

NOTE 8 – PARTIES-IN-INTEREST

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan holds an investment contract with Empower and variable annuities managed by Empower, thus Plan transactions regarding these assets qualify as party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Sponsor, who may also be participants in the Plan. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Sponsor.

NOTE 9 – FEDERAL INCOME TAX STATUS

Since the Plan is maintained under Code Section 403(c), rather than Code Section 401(a), there is no Internal Revenue Service program pursuant to which an individual determination letter may be obtained for the Plan. The Plan administrator believes that the Plan and related trust are designed and are currently being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and, if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service, recognize a tax liability (or asset). The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 10 – SUBSEQUENT EVENTS

Subsequent events have been evaluated by Plan management for recognition and disclosure through October 3, 2025, which is the date the financial statements were available to be issued.
