Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Yeshiva University High Schools Retirement Income Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE 1 - DESCRIPTION OF THE PLAN

The Yeshiva University High Schools (the “Sponsor”) maintains the Yeshiva University High Schools Retirement Income Plan (the “Plan”) for the benefit of its employees. The following description of the Plan provides only general information about the Plan. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan, which satisfies the Internal Revenue Code (the “Code”) Section 403(b), covering substantially all employees. The effective date of the Plan was January 1, 2020. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan’s assets are held by the Plan’s custodian, Fidelity Management Trust Company (“Fidelity”), as of December 31, 2024 and 2023. The Plan administrator is the Yeshiva University High Schools Retirement Plan Committee.

Contributions and Eligibility

The Plan defines which employees of Yeshiva University High Schools are eligible to participate in the Plan. In general, employees may begin participating in the Plan upon their hire date. There is no age requirement to participate in the Plan. There is no service requirement to participate in the Plan, but employees who are normally scheduled to work less than 20 hours per week are not eligible for matching contributions until they complete 1,000 or more hours of service during the applicable computation period. Independent contractors, leased employees and certain other designated persons are ineligible to participate in the Plan and/or receive matching contributions. Each year, participants may make Tax Deferred (“TD”) contributions as defined by the Plan, subject to the limitations of the Code. In general, the Sponsor makes matching contributions for all participants who make TD contributions of at least 3 percent of compensation.

Participant Accounts

Each participant’s account is credited with (a) the participant’s contributions, (b) an allocation of the Sponsor’s contributions, and (c) an allocation of Plan earnings (losses), and is charged with the participant’s withdrawals and an allocation of administrative expenses. Allocations are based on the participant’s account balance.

Investment Options

Participants have the option to invest the amount credited to their account at Fidelity in guaranteed interest accounts and/or any of the other investment options consisting of mutual funds and variable annuity contracts. Participants may change their investment options daily.

Vesting

Participants are immediately vested in the Sponsor’s contributions to their account, plus any investment earnings, gains, or losses thereon. Participants are always 100 percent vested in their elective deferrals, including catch-up contributions and rollover contributions.

Payment of Benefits

Active participants can elect a withdrawal of all or a portion of (1) their TD contributions at any time on or after reaching 59 ½ years of age, during military service of at least 180 days, or upon hardship (as defined in the Plan Documents), (2) their entire account at any time on or after reaching age 70, or (3)

their rollover contributions at any time.

Participants who terminate employment can elect a distribution of all or a portion of their vested account at any time subject to applicable required minimum distribution rules that apply upon reaching age 73 and the involuntary cash-out rule. Under the involuntary cash-out rule, the accounts of participants with vested account balances of \$1,000 or less are automatically distributed to the participants in their entirety, as soon as administratively practicable following termination of employment or attainment of any of the other milestones entitling the participant to receive benefits.

Participants may receive benefits in a lump sum or, except in the case of hardship withdrawals or involuntary cash-outs, annuity payments over a period designated by the participant, but not more than the participant's life expectancy or the joint life expectancy of the participant and the designated beneficiary, if any. Participants can elect to have a lump sum payment (other than a hardship withdrawal) or fixed period payments of less than ten years be transferred to an individual retirement account or another employer's qualified plan.

The accounts of participants who die prior to commencing distributions are paid to surviving spouses unless they consented to the designation of another beneficiary. The payment of death benefits is also subject to the applicable required minimum distribution rules and the involuntary cash-out rule.

Notes Receivable From Participants

Participants may borrow from their account, from their employee contributions or rollover portions, a minimum of \$1,000 up to a maximum equal to the lesser of (1) \$50,000, reduced for participants with prior loans by the highest outstanding balance of loans from the Plan during the one-year period ending on the day before the date the loan is made, or (2) 50 percent of their vested employee contributions and rollover balance. The loans are secured by the balance in the participant's account. Loans used to purchase a primary residence can be repaid over 15 years. Loans for all other purposes must be repaid within five years. Principal and interest is repaid through personal or bank checks. Interest is determined at the time of the loan at a rate equal to prime plus 1 percent. Loans receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Documents.

Administrative and Investment Management Expenses

The Plan's recordkeeping and custodial fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Sponsor or through revenue-sharing arrangements or forfeitures.

The Plan and Fidelity entered into a revenue-sharing arrangement whereby a portion of the revenue earned by the custodian for certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive credit as a result of this revenue-sharing arrangement, and to use this credit to pay for Plan expenses, the Plan created a Revenue Credit Account. The Revenue Credit Account is a cash account within the Plan that is used to record the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Revenue Credit Account balance was \$13,943 and \$5,421 as of December 31, 2024 and 2023, respectively. During 2024, \$8,157 from the Revenue Credit Account was used to reduce Plan expenses.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingencies at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments, other than fully benefit-responsive investment contracts, are reported at fair value as further described in Note 3. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions.

Payment of Benefits

Benefit payments are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through personal or bank checks, and the notes are collateralized by the participants' account balances.

NOTE 3 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1 Quoted prices unadjusted for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.
- Level 2 Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

NOTE 3 - FAIR VALUE MEASUREMENTS (Continued)

The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

Variable Annuity Contracts

The fair value of the Plan's investments held in a variable annuity contract is based on the net asset values reported by the fund manager as of the financial statement date and recent transaction price. Among other funding options which the Plan makes available to participants for investment of their existing balances and new contributions, the Plan offers the Prudential Long Term Growth variable annuity account (the "VCA-2" contract from The Empower Annuity Insurance Company of America ("Empower")). The variable annuity contract provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the accounts' net asset value per unit.

Mutual Funds

The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

NOTE 4 - CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the custodian of the Plan).

NOTE 5 - INVESTMENT CONTRACTS

Guaranteed Interest Account

The Plan holds fully benefit-responsive investment contracts with Empower. The contracts are traditional investment contracts, and their value at December 31, 2024 and 2023 was \$2,272,194 and \$2,379,712, respectively. Empower maintains the contributions in general and separate accounts. The accounts are credited with earnings on the underlying investments and with charges for participant withdrawals and administrative expenses. Empower, as issuer of the contracts, is contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the issuer or otherwise.

Under the Plan's investment contracts, a Sponsor-initiated termination of the contracts is an event that could limit the ability of the Plan to transact at contract value paid within 90 days. In this instance, contract value could be paid over time, or, at the Sponsor's discretion, paid over at most a one year period after the application of market value adjustments.

There are no events that allow the issuer to terminate the contracts and which require the Sponsor to settle at an amount different than contract value paid either within 90 days or over time. As of the date of these financial statements, Plan management does not believe that it is probable that the contracts will be terminated.

The crediting interest rate of each contract is determined by Empower without the use of a specific formula. As defined in each of the contract agreements, the Guaranteed Interest Account cannot be less than 3 percent. Such interest rates are reviewed on a quarterly basis for resetting. The key factors that influence future interest crediting rates could include the following: current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

NOTE 6 – RISKS AND UNCERTAINTIES

The Plan invests in various types of investments that are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect the participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants are always 100% vested, which means they are entitled to all of the amounts in their Plan accounts.

NOTE 8 – PARTIES-IN-INTEREST

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. As of December 31, 2024 and 2023, Plan investments consist of interests in mutual funds with Fidelity Investments, a company related to Fidelity. Fidelity is the record-keeper and custodian of the Plan as of December 31, 2024 and 2023; therefore, these transactions qualify as parties-in-interest transactions. Empower holds investment contracts and variable annuities on behalf of the Plan, thus Plan transactions regarding these assets qualify as parties-in-interest transactions. Notes receivable from participants also reflect parties-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Sponsor who may also be participants in the Plan. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Sponsor.

NOTE 9 – FEDERAL INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated August 7, 2017 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. The Plan administrator believes that the Plan and related trust are designed and are currently being operated in compliance with the applicable requirements of the Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 10 - SUBSEQUENT EVENTS

Subsequent events have been performed and evaluated by Plan management through October 3, 2025 which is the date the financial statements were available to be issued.
