Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audits.

### **Supplemental Schedules Required by ERISA**

The supplemental schedules, Schedule of Delinquent Participant Contributions – Form 5500, Schedule H, Part IV, Line 4a for the year ended December 31, 2024, and Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or are derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1—Description of the Plan

The following description of The Keyes Company 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*General* – The Plan, as amended, was formed, and adopted in July 1997, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan is maintained for the employees of The Keyes Company and Subsidiaries (collectively, the “Company” or the “Employer”). The following are the subsidiaries that participate in the Plan: Keyes Asset Management, Inc.; Keyes National Referrals, Inc.; Home Partners Title, Inc.; Home Partners Mortgage Services; KFin, LLC; TKC of Palm Beach LLC d/b/a Valore Real Estate Group; Illustrated Properties, LLC; and Capital Partners Mortgage Services, LLC.

*Plan Administration* – The Plan is administered by the Company. The Plan’s assets are maintained by John Hancock Life Insurance Company (U.S.A.) (the “qualified institution”) as of December 31, 2024, and 2023 and for the year ended December 31, 2024. The maintenance of the Plan’s participant accounts was managed by John Hancock Retirement Plan Services.

*Eligibility* – Under the Plan, those eligible to participate are all full-time employees of the Company who have attained the age of 21 and completed one year of service. Participants of Capital Partners Mortgage Service are eligible to participate after six months of service.

*Employee Contributions* – Participants may contribute up to 100% of pre-tax annual compensation, as defined in the Plan document, without exceeding limitations prescribed by the Internal Revenue Code (“IRC”). Participants may begin making contributions to the Plan after becoming eligible to participate. The entry dates to the Plan are the first day of each Plan year quarter following the satisfaction of the eligibility requirements. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Additionally, participants ages 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their contribution rate set at 2% of eligible compensation and their contributions are automatically invested in a designated balanced fund until changed by the participant.

*Employer Contributions* – The Employer can make a discretionary matching contribution based on the employee elective contributions and compensation. The Employer elected to match 25% of an eligible participant contribution that does not exceed 6% of the participant’s eligible compensation. During the year ended December 31, 2024, matching contributions were approximately \$86,000. Additionally, the Employer may, at its discretion, make profit sharing contributions and qualified nonelective contributions. During the year ended December 31, 2024, the Company did not make any discretionary profit sharing or qualified nonelective contributions.

*Participant Investment Account Options* – The Plan currently offers various mutual funds as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at their discretion.

*Participant Accounts* – Each participant’s account is credited and/or reduced with the participant’s elective deferral contributions and distributions as well as allocation of (a) the Company’s contribution, (b) Plan earnings (losses), (c) forfeitures, and (d) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Note 1—Description of the Plan (continued)

*Forfeitures* – Forfeitures of terminated, nonvested account balances may be used to pay the Plan’s administrative expenses, or reduce Employer contributions. During the year ended December 31, 2024, forfeiture amounting to \$1,269 were used to reduce Employer contributions. As of December 31, 2024 and 2023, there were approximately \$3,900 and \$2,600, respectively, in forfeited nonvested accounts.

*Vesting* – Participants are immediately vested in their own contributions plus or minus any earnings or losses thereon. Participants also become fully vested in their account in the event of death, disability, or upon attaining the Plan’s normal retirement age, all as defined in the Plan document. Employer matching contributions, including profit sharing and qualified nonelective contributions, are subject to the following vesting schedule:

Less than 3	0%
3 or more	100%

*Notes Receivables from Participants* – Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance. Participants are allowed a maximum of two outstanding notes and the minimum amount of any note is \$1,000. The notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates ranged from 4.25% to 10.50% at December 31, 2024. Participant notes have a term of no more than five years, unless for the purchase of a principal residence, which term to be determined by the Plan administrator at the time of the loan. Principal and interest are paid ratably through payroll deductions.

*Payment Benefits* – Upon termination of service due to death, disability, or retirement or other reasons, the Plan provides for a lump-sum distribution or installment payments equal to the total value of the participant’s deferral contribution account, and the vested portion of his/her matching contribution and nonelective contribution accounts. Participants are allowed in service withdrawals of their vested participant’s vested interest in his or her account upon attainment of retirement age or in the event of a financial hardship. The Plan provides for involuntary cash-out distributions for terminated employees with a vested balance of less than \$1,000.

### Note 2—Summary of significant accounting policies

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

*Use of Estimates* – The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities in the financial statements and accompanying notes. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* – Investments held by the Plan are recorded at fair value. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction. A fair value hierarchy exists which requires an entity to maximize the use of observable inputs when measuring fair value.

### Note 2—Summary of significant accounting policies (continued)

Three levels of inputs may be used to measure fair value:

*Level 1* – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

*Level 2* – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

*Level 3* – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for instruments measured at fair value, including, if applicable, the general classification of such instruments pursuant to the valuation hierarchy. There have been no significant changes in the methodology used at December 31, 2024 or 2023:

*Pooled Separate Accounts* – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is used as a practical expedient to estimate fair value and is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. This practical expedient is not used when it is determined to be probable the fund will sell the investment for an amount different than the reported NAV. Transactions (purchases and sales) may occur daily. These investments measured using NAV practical expedient are exempt from classification under the fair value hierarchy.

The method described above may produce a fair value determination that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date and interest income is recognized when earned. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment related expenses are included in net appreciation of fair value of investments.

*Administrative Expenses* – Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment (distributed loan) is recorded.

*Payment of Benefits* – Benefits are recorded when they have been processed and paid by the Plan.

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, accordingly, the qualified institution of the Plan, has certified to the completeness and accuracy of the following data included in the accompanying financial statements and supplemental schedules as of December 31, 2024 and 2023 and for the year ended December 31, 2024:

- Total investments and notes receivable from participants as shown on the statements of net assets available for benefits, as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to the certified information, except for comparing such information to the related information included in the financial statements and supplemental schedule, Schedule of Assets (Held at End of Year).

### **Note 5—Party-in-interest transactions**

Plan investments and the related transactions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, were in investment funds managed by the qualified institution; therefore, these investments and transactions qualify as party-in-interest transactions. Fees paid during the year for accounting and other services rendered by parties-in-interest totaling approximately \$53,000 for the year ended December 31, 2024 were based on customary and reasonable rates for such services. Notes receivable from participants are also considered to be party-in-interest transactions because they are transacted with Plan participants.

### **Note 6—Income tax status**

The Company adopted a prototype non-standardized profit-sharing plan with a cash or deferral arrangement. The prototype plan received a favorable opinion letter from the Internal Revenue Service (“IRS”) in January 25, 2021, which stated the prototype plan is designed in accordance with applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements. The Plan has not received a determination letter specific to the Plan itself and the prototype plan has been amended since receiving the opinion letter. The Plan has been amended. However, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, there is no unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 7—Risks and uncertainties**

The Plan provides for various investment options which are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to the changes in the value of investment securities, it is at least reasonably possible that changes in the fair value of investments will occur in the near term and that such change could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8—Delinquent participant contributions**

During the years ended December 31, 2024, and 2023, the Company’s failure to remit certain employee contributions to the Plan in a timely manner resulted in a temporary use of participant funds by the Company, which constitutes a prohibited transaction under ERISA. As such, these transactions represented prohibited transactions between the Company and the Plan as identified in the Schedule of Delinquent Participant Contributions – Form 5500, Schedule H, Part IV, Line 4a. The Company has remitted the 2024 participant contributions and has calculated the lost earnings to finalize correction on those remittances. Subsequent to year end, the lost earnings were corrected. In addition, the Company is calculating the lost earnings pertaining to 2023 to finalize correction on those remittances.

**Note 9—Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their account balances.

**Note 10—Subsequent events**

The Plan has evaluated events through September 29, 2025, the date the financial statements were available to be issued. No events have occurred subsequent to the date of the financial statements that would require adjustment to, or disclosure in, the financial statements.
