### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Manac Trailers USA, Inc. Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Manac Trailers USA, Inc. Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE A | DESCRIPTION OF PLAN**

The following description of the Manac Trailers USA, Inc. (the “Company”) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*1. General*

The Manac Trailers USA, Inc. Savings Plan, which became effective on October 1, 2002, and most recently amended and restated effective November 1, 2023, is a defined contribution plan. Employees are eligible to participate in elective deferrals upon reaching age 18 and completing 3 months of service and enter the plan on the first day of the plan quarter thereafter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*2. Contributions and Investment Options*

Each year, participants may contribute up to the maximum amount determined by law, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Discretionary matching and profit-sharing contributions may be contributed at the option of the Company’s board of directors. Participants are eligible to share in these discretionary employer contributions after reaching age 18 and following one year of service. Participants must also be employed on the last day of the Plan year to receive the employer contributions unless they terminate due to death, disability, or early retirement. The Company contributed a matching contribution of 50 percent of the first six (6) percent of compensation that a participant contributes to the Plan during the Plan year during 2024 and 2023. The matching contribution was \$139,651 for 2024 and \$167,359 for 2023. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan offers various mutual funds and common collective trust funds as investment options for participants. Contributions are subject to certain Internal Revenue Code limitations.

*3. Participant Accounts and Allocations*

Each participant’s account is credited with the participant’s contribution, the employer’s contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

4. *Vesting*

Participants are 100% vested in their deferral contributions and Company discretionary contributions plus related earnings immediately.

5. *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding note balance the participant had under the Plan during the previous 12-month period. The notes are secured by the balance in the participant's account and bear interest at prime plus 1%. Principal and interest are paid ratably through payroll deductions. Participants are only allowed to have one loan outstanding at any one time.

6. *Payment of Benefits*

On termination of service due to death, disability, retirement or termination, the participant can receive a distribution of their vested account balance. If a participant's account balance is greater than \$1,000, the participant may elect to defer payment until a later date. The Plan also allows for in service distributions at age 59½ and hardship distributions from certain accounts. The distribution may be paid in a lump sum payment or rolled over to an IRA or another retirement plan.

7. *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,669 and \$1,434, respectively. These amounts may be used to reduce plan expenses or future employer contributions. In 2024 and 2023, no amounts were paid from forfeitures to reduce employer contributions or pay expenses of the Plan.

**NOTE B | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*1. Basis of Accounting*

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*2. Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

*3. Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and in the principal and most advantageous market for the asset or liability. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*4. Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. The Plan deems all participant notes receivable to be fully collectable; therefore, no allowance for uncollectable accounts is required. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

*5. Payment of Benefits*

Benefit payments to participants are recorded upon distribution.

*6. Administrative Expenses*

Expenses of maintaining the Plan are paid by the Plan and the participants.

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Ascensus, LLC as an agent for Ascensus Trust Company and Newport Trust Company, LLC (trustees) except for comparing such information certified on behalf of the trustees to information included in the Plan's financial statements and supplemental schedules.

**NOTE D | FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds*

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE G | PLAN TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the U.S. Department of Labor or Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Penalties and interest assessed by taxing authorities are included in the provision for income taxes, if applicable. There were no penalties and interest for 2024 and 2023.

The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE H | RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE I | PROHIBITED OR NON-EXEMPT TRANSACTIONS**

The Plan Sponsor failed to remit participant contributions on a timely basis in the amount of \$20,149 for 2024. As of December 31, 2024, the Plan Sponsor was in the process of self-correcting late remittances for 2024 by remitting lost earnings into the Plan in 2025. The Plan Sponsor was also working with the Plan's third party administrator to correct immaterial operational errors related to deferral and matching contributions for a limited number of employees during 2024. The corrections will be self-corrected by the Plan in 2025.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Manac Trailers USA, Inc. Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Manac Trailers USA, Inc. Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

**NOTE A | DESCRIPTION OF PLAN**

The following description of the Manac Trailers USA, Inc. (the “Company”) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

*1. General*

The Manac Trailers USA, Inc. Savings Plan, which became effective on October 1, 2002, and most recently amended and restated effective November 1, 2023, is a defined contribution plan. Employees are eligible to participate in elective deferrals upon reaching age 18 and completing 3 months of service and enter the plan on the first day of the plan quarter thereafter. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*2. Contributions and Investment Options*

Each year, participants may contribute up to the maximum amount determined by law, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Discretionary matching and profit-sharing contributions may be contributed at the option of the Company’s board of directors. Participants are eligible to share in these discretionary employer contributions after reaching age 18 and following one year of service. Participants must also be employed on the last day of the Plan year to receive the employer contributions unless they terminate due to death, disability, or early retirement. The Company contributed a matching contribution of 50 percent of the first six (6) percent of compensation that a participant contributes to the Plan during the Plan year during 2024 and 2023. The matching contribution was \$139,651 for 2024 and \$167,359 for 2023. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan offers various mutual funds and common collective trust funds as investment options for participants. Contributions are subject to certain Internal Revenue Code limitations.

*3. Participant Accounts and Allocations*

Each participant’s account is credited with the participant’s contribution, the employer’s contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

4. *Vesting*

Participants are 100% vested in their deferral contributions and Company discretionary contributions plus related earnings immediately.

5. *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the highest outstanding note balance the participant had under the Plan during the previous 12-month period. The notes are secured by the balance in the participant's account and bear interest at prime plus 1%. Principal and interest are paid ratably through payroll deductions. Participants are only allowed to have one loan outstanding at any one time.

6. *Payment of Benefits*

On termination of service due to death, disability, retirement or termination, the participant can receive a distribution of their vested account balance. If a participant's account balance is greater than \$1,000, the participant may elect to defer payment until a later date. The Plan also allows for in service distributions at age 59½ and hardship distributions from certain accounts. The distribution may be paid in a lump sum payment or rolled over to an IRA or another retirement plan.

7. *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,669 and \$1,434, respectively. These amounts may be used to reduce plan expenses or future employer contributions. In 2024 and 2023, no amounts were paid from forfeitures to reduce employer contributions or pay expenses of the Plan.

**NOTE B | SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*1. Basis of Accounting*

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*2. Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

*3. Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and in the principal and most advantageous market for the asset or liability. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*4. Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. The Plan deems all participant notes receivable to be fully collectable; therefore, no allowance for uncollectable accounts is required. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

*5. Payment of Benefits*

Benefit payments to participants are recorded upon distribution.

*6. Administrative Expenses*

Expenses of maintaining the Plan are paid by the Plan and the participants.

**NOTE D | FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds*

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE G | PLAN TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the U.S. Department of Labor or Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Penalties and interest assessed by taxing authorities are included in the provision for income taxes, if applicable. There were no penalties and interest for 2024 and 2023.

The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE H | RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE I | PROHIBITED OR NON-EXEMPT TRANSACTIONS**

The Plan Sponsor failed to remit participant contributions on a timely basis in the amount of \$20,149 for 2024. As of December 31, 2024, the Plan Sponsor was in the process of self-correcting late remittances for 2024 by remitting lost earnings into the Plan in 2025. The Plan Sponsor was also working with the Plan's third party administrator to correct immaterial operational errors related to deferral and matching contributions for a limited number of employees during 2024. The corrections will be self-corrected by the Plan in 2025.
