NOTE 1: DESCRIPTION OF PLAN

The following description of the Uftring Automotive Group 401(K) Plan and Trust (the Plan) provides only general information. Participants should refer to the Amended Plan agreement and Summary Plan Description for a more complete description of the Plan's provisions.

1. **General.** The Plan was established on June 1, 1989, and is a defined contribution plan covering all employees of Uftring Automotive Group (the Company) who have completed one year of continuous service and have reached the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The board of trustees is responsible for oversight of the Plan. The investment committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's board of trustees.
2. **Contributions.** Each year, participants may contribute before-tax and after-tax contributions as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants who have or will attain age 50 during the plan year may elect to contribute a "catch-up" contribution, not to exceed \$7,500 for 2024 and \$7,500 for 2023, not subject to any other limit. The Company contributes 50% of the first 2% of base compensation that a participant contributes to the Plan. Total contributions, both participant and employer, including discretionary, are subject to the limits of the Internal Revenue Code (the IRC) Section 415(c). Participant contributions and employer matching contributions of certain highly compensated participants may also be limited based on contribution nondiscrimination tests described in IRC Section 401(k) and 401(m).

Employer contributions include employer matching contributions and employer discretionary contributions. Participant contributions consist of participant pre-tax elective deferrals, after-tax contributions and rollover contributions.

Employer discretionary contributions are allocated to any person who was an active participant at any time during the year. The allocation is based on a ratio of each individual participant's compensation to all participants' compensation.

3. **Participant Accounts.** Each participant's account is credited with the participant's contribution, the employer's contribution, and an allocation of the Plan's earnings. The Plan's earnings are allocated according to participants' relative account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Forfeitures are used to offset administrative costs of the Plan. Any forfeitures in excess of plan expenses are applied to participants' accounts in the same manner as discretionary employer contributions. Total participant accounts are equal to the investments listed on the Statement of Net Assets Available for Benefits.
4. **Vesting.** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portions of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. Participant accounts become fully vested upon attainment of the normal

retirement age of 65, early retirement age of 55 with ten years of service, or in the event of death or total disability. Prior to any of these occurrences, a participant becomes vested based on the following schedule:

3.....	40%

6 or more.....	100%

5. Payment of Benefits. On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or in the form of an annuity. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Participants may withdraw, in a single sum, any part of their vested accounts resulting from voluntary contributions. Participants may only make two such withdrawals in any twelve-month period.

In certain hardship situations, as described in the plan agreement, participants may withdraw part of their vested account balances while actively employed; but such withdrawals are limited to the amount of hardship. Participants' withdrawals are limited to deferred account balances and may not include any earnings accrued thereon.

Participants may withdraw any part of their vested account balance, which does not result from voluntary contributions, at any time after the attainment of age 59 ½. Participants may only make two such withdrawals in any twelve-month period.

6. Investment Options. Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the selected investment options offered by Principal Financial Group. Participants may change their options daily.
7. Participant Notes Receivable. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years. Each loan is secured by the balance in the participant's account and bears interest at 1% over the prime rate. Principal and interest are paid ratably through weekly or monthly payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Document.

8. Forfeited Accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$14,722 and \$4,874, respectively. These accounts were used to offset plan expenses and employer contributions.
9. Plan Termination. Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer contributions.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's board of trustees determines the valuation policies by utilizing information provided by the custodian. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Participant Notes Receivable

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Loan balances are secured by remaining balances in the individuals' accounts. If a participant ceases to make loan repayments and management deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to corrective distributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Beginning in 2012, the Plan hired a Registered Investment Advisor (RIA) to provide advisory services. The RIA is compensated at a rate of .30% of market value billed quarterly in arrears. This fee was changed to .25% of market value as of January 1, 2018. This fee is separately stated in Statement B. The fee structure changed as of January 1, 2019, for the custodial fees charged. The record keeping fee is now charged to the participant accounts and was previously included in investment appreciation.

NOTE 3: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts. Valued at the net asset value of shares held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sold) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled Separate Accounts. Valued at the net asset value of shares held by the Plan at year end. Pooled separate accounts are made up of a wide variety of underlying investments such as equities, preferred stock, bonds, real estate and mutual funds. The NAV is based on the market value of its underlying investments. NAV is not a publicly-quoted price in an active market. These are similar to mutual funds; however, they are only available to Principal's group annuity contract holders.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Principal U.S. Property Separate Account has the ability to apply a contractual limitation that delays the payment of withdrawal requests and provides for payment on a pro rata basis as cash becomes available for distribution, as determined by Principal Life. On July 1, 2022, Principal Life applied the withdrawal limitation, and the outstanding requests totaled \$533,140,610 and \$1,351,042,194 at December 31, 2024 and 2023, respectively.

The current balances invested in Principal U.S. Property Separate Account that have been requested for a withdrawal total \$199,514 and \$758,832 as of December 31, 2024 and 2023.

NOTE 4: TAX STATUS

The IRS has determined and informed the Plan by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The total amounts of interest and penalties recognized in the Statements of Changes in Net Assets Available for Benefits and the total amounts of interest and penalties recognized in the Statements of Net Assets Available for Benefits are \$0. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan has never had unrelated business income tax (UBIT) nor has it filed the Form 990-T. Therefore, all tax years are open for examination by federal and state taxing authorities related to UBIT.

NOTE 10: RISKS AND UNCERTAINTIES

Investment Risk

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Concentration of Credit Risk

The Plan's investment in the Principal Stable Value Fund Z represents approximately 15% and 14% of the Plan's net assets available for benefits as of December 31, 2024 and 2023, respectively. This subjects the Plan to concentrations of credit risk.

NOTE 11: PRIOR YEAR RECLASSIFICATIONS

Certain reclassifications have been made to the prior year's financial statements to conform to the current year presentation. These reclassifications had no effect on previously reported results of operations or net assets available for benefits.
