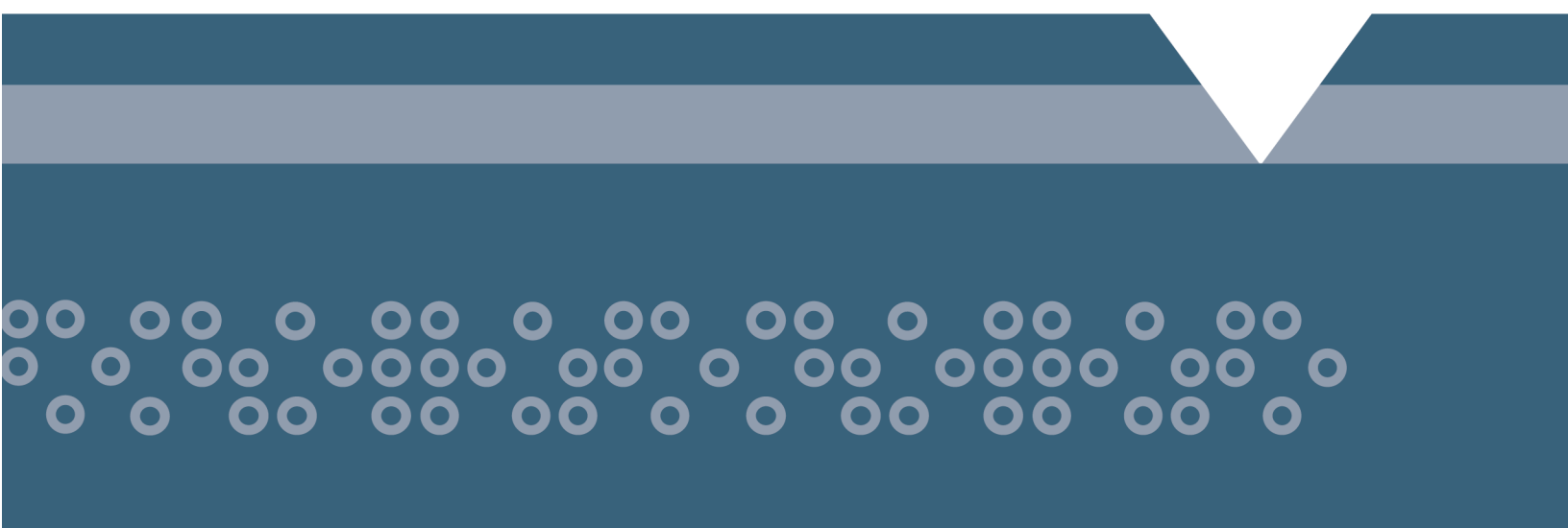

## INDEPENDENT AUDITOR'S REPORT

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements***

### 1. Description of Plan

The following description of the Bonvenu Bancorp, Inc (“Company”) Employee Stock Ownership Plan (“Plan”), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan is a defined contribution plan covering all employees of the Company who have completed three months of service and are twenty-one (21) years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### ***General***

The Plan was initially established January 1, 1993, and has since been amended, most recently effective on January 1, 2021. One component of the Plan is a profit sharing plan, which contains a cash-or-deferred feature described at Section 401(k) of the Internal Revenue Code of 1986, as amended. The other component of the Plan is intended to qualify as an employee stock ownership plan under Section 4975(e)(7) of the Internal Revenue Code, as amended. The Plan is administered by Argent Trust Company, who serves as the trustee.

#### ***Participant Accounts***

Each participant’s account is credited with the participant’s voluntary contribution, the Company’s matching contribution, any employer discretionary profit-sharing contributions, and Plan earnings, which are allocated proportionately among all participants based on their investment in each fund. All allocations of employer stock are made after the year-end valuation has been completed. Only those participants who are eligible employees of the Company on the last day of the plan year will be eligible to receive an allocation.

#### ***Employee Contributions***

Participants are permitted to contribute up to 80% of their annual compensation, as defined in the Plan document. The Plan allows for contributions to be made on a tax-deferred or roth basis. Participants may direct the investment of 100% of their deferrals. Transfers from qualified plans are allowed under the provisions of the Plan. Additional voluntary contributions are not allowed.

#### ***Employer Contributions***

The Company may make discretionary matching and/or profit sharing contributions. The Company made match contributions in the amount of \$240,000 and \$215,000 for 2024 and 2023, respectively. No profit sharing contributions were made for 2024 or 2023.

#### ***Vesting***

Participants are fully vested in their employee contributions and matching contributions, plus actual earnings thereon. Vesting the Company’s profit-sharing contributions and earnings thereon is subject to a six year graded schedule.

#### ***Payment of Benefits***

Upon termination of a participant’s employment, the participant (or beneficiary in the case of death) may elect to receive a lump sum payment equal to the vested interest of the account balance, or substantially equal installments over a minimum 5-year period. The Plan also contains provisions for distributions in cases of hardship or upon reaching the age of 59 ½.

Under the provisions of the Plan, any Company stock that is distributed to participants may be subject to a right of first refusal by the Company and may be subject to a put option for any distributed Company stock that cannot be readily sold.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

***Forfeitures***

The Plan provides that amounts credited to a participant's account in which the participant does not have a vested interest will be forfeited to the Plan upon termination. These forfeitures, as defined by the Plan, are to be used to pay administrative expenses incurred by the Plan, restore eligible rehired participant's accounts and/or to reduce future company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts were immaterial.

***Voting Rights***

All shares of Company stock held by the Plan are voted in such manner as the Trustee determines. Each participant may direct the Trustee as to the manner in which Company stock allocated to the participant's account is to be voted on any corporate matter involving mergers, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets or similar transaction included in Treasury regulations.

***Put Option***

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations including a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

***Diversification***

Diversification is offered to participants close to retirement age so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify may receive a cash distribution, transfer to another qualified plan, or be invested at the

election of the Qualified Participant in alternative investments offered by the plan. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

***Reclassification***

Certain amounts from prior year have been reclassified to conform to current year presentation.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements of the Plan have been prepared on an accrual basis of accounting and present the net assets available for Plan benefits and changes in those assets.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and appraisers. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. The Plan does not place loans on non-accrual status, as the loan repayments are set up as automatic deductions through payroll that continue until either the loan is repaid, or the participant terminates employment. In instances where employment is terminated, the loan is considered a deemed distribution that is deducted from the participant's account balance.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

**3. Information Certified by the Plan's Trustee**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at December 31, 2024 and 2023, and investment income, contributions and distributions for the year ended December 31, 2024, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Argent Trust Company and Fidelity Personal Trust Company.

**4. Fair Value Measurements**

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price which is based on the net asset value (NAV) of shares held by the plan at year end.

*Employer stock:* Valued annually by an independent third-party appraiser.

*Money market funds:* The funds intend to keep a constant \$1 net asset value (NAV) and are valued using the amortized cost method.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. Related Party and Parties In Interest Transactions**

The Plan's shares of Bonvenu Bancorp, Inc. common stock are held by Argent Trust, the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invest cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers of the Company. No such officers receive compensation from the Plan. The Trust is to pay all costs of administering the Plan unless such expenses are paid by the Company. As described in Note 2, the Company or the Plan is paying all Plan expenses other than fees associated with loan distributions. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

**7. Plan's Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated November 16, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**10. Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transaction and events that affect the financial statements. Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.

The Plan restated the plan document effective June 1, 2025 by moving to a prototype plan document. As part of the restatement, the plan reduced the minimum age of participation in the plan from 21 to 18 years of age.

The Plan also moved their assets held by the Fidelity Trust to Principal during July 2025.
