INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of
Cronimet Holdings 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cronimet Holdings 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Cronimet Holdings 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Cronimet Holdings 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

NOTE 1: PLAN DESCRIPTION

The following description of the Cronimet Holdings (“Employer” or the “Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the summary plan description and plan document for a more complete description of the Plan’s provisions.

The Plan was established on August 1, 2002, which has been amended and restated effective January 1, 2022 and is a defined contribution plan covering all eligible employees of Cronimet Holdings, Inc, Cronimet Corporation, Cronimet Specialty Metals, Inc, and Unico Alloy & Metals, Inc. United Alloys & Metals, Inc. in Santa Fe Springs, CA was shut down and, effective December 31, 2023, filed a Certificate of Dissolution in the State of California. Cronimet Green Energy was formed on January 6, 2024. Cronimet Green Energy has yet to hire any employees. The Plan was amended to reflect the Bipartisan Budget Act of 2018, and Code Sections 401(k) and 401(m) 2019 Final Hardship Regulations as well as the adoption of the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility:

Employees are eligible to participate in the Plan and receive employer discretionary matching contributions upon the attainment of 18 years of age and completion of three months of service. Employees eligible to participate in the Plan are automatically enrolled in the first day of the 1st, 4th, 7th, or 10th month of the Plan year on or next following eligibility satisfaction. Employees may elect not to participate in the Plan.

In addition, participants are eligible to receive a discretionary employer contribution if the participant earns a minimum of 1 hour of service and is employed on the last day of the Plan year. The last day requirement will be waived in the event of a participant’s death, disability or after having reached normal retirement age of 59.

Contributions:

The Plan provides each participant with an opportunity to make elective pre-tax contributions to the Plan and subject to the limitations of the Internal Revenue Code (“IRC”). Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants are automatically enrolled into the Plan at a rate of 1%, unless the participant elects otherwise.

The Company may make a discretionary matching contribution in accordance with the provisions contained in the plan document. For the years ended December 31, 2024 and 2023, the Company made a discretionary matching contribution of \$669,313 and \$914,243, respectively.

Vesting:

Participants are always 100% vested in their contributions to the plan as well as their percentage of the Employer contribution account.

Forfeitures:

Forfeitures, plus earnings thereon, can be used to reduce plan administrative expenses or future employer contributions. Forfeitures remaining as of December 31, 2024 and 2023 were \$354 and \$217, respectively.

Participants Accounts:

Each participant's account is credited with their contributions, employer contributions, and the earnings thereon. Contributions to the Plan are invested by the custodian as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the plan document.

Notes Receivable from Participants:

Loans are not permitted under the Plan document.

Benefits:

In the event of death, disability, retirement or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or an annuity as specified by the Plan. Vested account balances less than \$5,000 upon termination may be distributed without the participant's consent in a lump-sum.

Rollover:

An employee may rollover distributions from a former employer's qualified plan to the Plan, regardless of eligibility if it has been determined by the plan administrator to be an "eligible rollover distribution" as defined by the Internal Revenue Code ("IRC").

Excess Contributions Payable:

Amount payable to participants for contributions in excess of amounts allowed by the Internal Revenue Services ("IRS") or Plan provisions are recorded as a liability with corresponding reduction to contributions.

Administrative Expenses:

All transaction fees are paid from participants' accounts. Substantially all other administrative expenses of the Plan are paid by the Company.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments Valuation and Income Recognition:

Investments are reported at their fair value (except for fully benefit-responsive investment contracts, which are recorded at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits:

Benefits are recorded when paid.

Subsequent Events:

The Plan has evaluated subsequent events through August 26, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

NOTE 3: INVESTMENT INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The following is a summary of the investments and notes receivable from participants information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by Voya Retirement Insurance and Annuity Company ("Voya"), the custodian of the Plan, and furnished to the plan administrator. The plan administrator has obtained certifications from the custodian that such information is complete and accurate.

Investment Contract with Insurance Company:

The Plan entered into an investment contract with Voya, whereby Voya maintains the contributions in a guaranteed interest contract. The guaranteed investment contract is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Voya. The contract is fully benefit-responsive and is reflected in the financial statements at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with Voya. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The guaranteed investment contract does not permit Voya to terminate the agreement prior to the scheduled maturity date.

NOTE 4: FAIR VALUE MEASUREMENTS

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1 - Unadjusted quoted prices in active markets for identical investments.
- Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- Mutual funds - Mutual funds are stated at fair value based on quoted prices in an active market for each share held by the Plan.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5: PARTIES-IN-INTEREST TRANSACTIONS

During the year ended December 31, 2024, Voya Retirement Insurance and Annuity Company was the custodian as defined by the Plan. Administrative expenses paid by the Plan to the custodian qualify as a party-in-interest transaction. Total administrative expenses paid by the Plan to Voya Retirement Insurance and Annuity Company amounted to approximately \$3,336 for the year ended December 31, 2024.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan in whole or in part at any time subject to the provisions set forth in the Employer Retirement Income Security Act of 1974 (“ERISA”). Upon termination, partial termination or complete discontinuance of contributions under the Plan, all participants become fully vested in their individual accounts.

NOTE 7: TAX STATUS

Although the Plan has not requested determination from the Internal Revenue Service (“IRS”) as to the Plan’s tax-exempt status, the master prototype plan from which the Plan was drafted has received a favorable opinion letter from the IRS dated March 31, 2014. The Plan administrator believes that the Sponsor has operated the Plan in a manner that did not jeopardize this tax status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8: RISK AND UNCERTAINTIES

The Plan's investments are concentrated in funds that invest in marketable securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain securities and level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.
