NOTE 1. DESCRIPTION OF PLAN

Sierra Management and Technologies, Inc. 401(k) Plan (the “Plan”) is a defined contribution plan of Sierra Management and Technologies, Inc. (the “Company” or “Plan Sponsor”) established on January 1, 1996. The trustee and custodian of the Plan is John Hancock Trust Company, LLC (the “Trustee”).

Effective January 1, 2022, the Plan was amended and restated to bring the Plan into compliance with legislative and regulatory changes. There were no other changes in the Plan provisions.

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

(a) *Eligibility*

The Plan covers all employees of the Company who have attained age 18, with the exception of union employees and non-resident aliens. Eligible employees may enter the Plan on the first day of the Plan year’s quarter coinciding with or following the date the eligibility requirements are met. Employees are eligible to receive employer matching and nonelective contributions upon the completion of at least one year of service.

(b) *Participant Contributions*

Eligible participants may elect to make salary reduction contributions up to 100% of eligible compensation, as defined by the Plan, subject to the limitations of the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as defined in the IRC. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

(c) *Employer Contributions*

For participants who have been employed at least one year, the Company provides a safe harbor match of 100% of the participant’s elective deferrals that do not exceed 3% of that participant’s compensation, plus 50% of the participant’s elective deferrals between 3% and 5% of the participant’s compensation. Additional discretionary matching and profit-sharing amounts may be contributed at the option of the Company’s Board of Directors. There were no discretionary matching or profit-sharing contributions for the years ended December 31, 2024 or 2023.

(d) *Rollover Contributions*

Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans, subject to Plan provisions.

(e) *Vesting*

Participants are immediately vested in their salary deferral and safe harbor matching contributions, and related earnings thereon. Participants become 20% vested in discretionary matching and profit-sharing contributions, and earnings thereon, after two years of service, 40% vested after three years of service, 60% vested after four years of service, and 100% vested after five years of service. A participant becomes 100% vested upon death, disability, or attaining normal retirement age.

(f) *Investment Options*

The Plan provides for participant-directed investment programs; whereby, the Plan Sponsor determines which investment options are available and the participants may choose among the available options. Participants may change their investment options at any time by reallocating contributions among different investment alternatives. Participants may also transfer contributions into and out of investments provided under the Plan, subject to possible restrictions.

(g) *Participant Accounts*

Each participant's account is participant-directed and is credited with the participant's contributions, as well as allocations of the Company's contributions and Plan earnings or losses. Participant accounts may also be charged with an allocation of certain administrative expenses and expenses specifically attributable to a participant. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(h) *Notes Receivable from Participants*

Participants are allowed to borrow a minimum of \$1,000 and a maximum of \$50,000 from their fund accounts, up to 50% of the participant's vested account balance. Note terms generally range from one to five years except for notes to purchase a principal residence, which can exceed five years. Principal and interest are paid ratably through payroll deductions. A participant may have no more than one note outstanding at a time.

NOTE 1. DESCRIPTION OF PLAN – continued

(i) *Payment of Benefits*

The Plan provides for distribution of accumulated benefits upon death, separation of service, financial hardship, in-service at age 59½, disability, and retirement of participants. Participants who are age 72 and over are required by the Internal Revenue Service (“IRS”) to make certain required minimum distributions. Distributions may be made in the form of lump sum payments, substantially equal installments or partial withdrawals of at least \$1,000. If the total benefit is \$5,000 or less, the entire amount is paid in a lump-sum distribution. If the total benefit is greater than \$5,000, the participant must consent to the distribution. The taxable portion of a withdrawal is subject to federal and state income taxes and an additional tax if the participant has not reached retirement age, unless the amount is rolled over into another eligible plan or an Individual Retirement Account. Vested benefits may be paid to the participants in a lump-sum distribution or as a direct rollover distribution to another qualified plan.

(j) *Forfeited Accounts*

Forfeitures represent unvested portions of terminated participants’ accounts. The Plan allows the balance of forfeited non-vested contributions to be used to reduce Company contributions. As of December 31, 2024 and 2023, there were no forfeited nonvested account balances.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) *Basis of Accounting*

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with generally accepted accounting principles in the United State of America.

(b) *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) *Benefit Payments*

Benefit payments to participants are recorded when the related expenses are incurred.

(d) *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(e) *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced by the amount of Plan assets, and a benefit payment is recorded.

(f) *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Company. Investment fees and transaction expenses, such as loan and distribution administration fees, are charged directly to the participant's account and are included in administrative expenses in the accompanying statement of changes in net assets available for benefits. Plan expenses, such as recordkeeping and advisor fees, may be charged directly to the participant's account as an asset-based fee. Investment-related expenses are included in the net depreciation of the fair value of investments.

NOTE 3. INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the alternative method of compliance permitted by ERISA Section 103 (a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, information certified by John Hancock Trust Company, LLC (the "Trustee"), as of and for the years ended December 31, 2024 and 2023, was not audited, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, were obtained or derived from information provided to the Plan administrator and certified as complete and accurate by the Trustee of the Plan.

NOTE 4. FAIR VALUE MEASUREMENT

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2* Inputs to the valuation methodology include a) quoted prices for similar assets or liabilities in active markets; b) quoted prices for identical or similar assets or liabilities in inactive markets; c) inputs other than quoted prices that are observable for the asset or liability; and d) inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of mutual funds is determined by using the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. FULLY BENEFIT - RESPONSIVE INVESTMENT CONTRACT

The Plan has entered into a fully-benefit responsive investment contract with John Hancock. John Hancock maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by John Hancock but may not be less than zero percent. The crediting rate is reviewed on January 1 and July 1 of each year for resetting. The contract does not permit John Hancock to terminate the agreement prior to the scheduled maturity date.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by the Custodian, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include, but are not limited to the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletions of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer. Investments measured at contract value as of December 31, 2024 and 2023, totaled \$481,734 and \$223,748, respectively.

NOTE 6. RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST

Certain Plan investments are managed by affiliates of the Plan's Custodian, and therefore, the transactions qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. For the years ended December 31, 2024 and 2023, fees paid by the Plan for contract administrative services totaled \$68,662 and \$65,175, respectively.

NOTE 7. PRIORITIES UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to amend the Plan, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA and the Plan document. In the event of Plan termination, participants would become 100% vested in their account balances as of the date of termination.

NOTE 8. TAX STATUS

The Plan has adopted a pre-approved defined contribution plan sponsored by Coastal Pension Services Inc. which was intended to satisfy the tax qualification requirements under IRC 401(a) and was therefore not subject to tax under current income tax law. The Internal Revenue Service ("IRS") has informed the pre-approved defined contribution Plan Sponsor in an opinion letter dated November 30, 2020, stating that the pre-approved defined contribution plan satisfies the applicable provisions of the IRS. The Plan administrator believes that the Plan is currently designed and operating in compliance with the requirements of the IRC.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require the recognition of a liability or (asset) or any type of disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9. RISKS AND UNCERTAINTIES

The Plan provides for investments in different investment securities that are exposed to various risks such as interest rate, credit risks, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.
