## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements**

We have performed audits of the accompanying financial statements of Nexus/Sherwood Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

#### A. DESCRIPTION OF PLAN

The following brief description of the Nexus/Sherwood Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

##### **General**

The Plan is a defined contribution plan covering all employees of Nexus Properties, Inc. and affiliates (the "Company") who have completed at least one year of service, which consists of 1,000 hours of service, and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Empower Annuity Insurance Company of America (the "Custodian") is the custodian of the Plan.

The Plan was amended July 1, 2018 to add an automatic enrollment provision for new participants.

##### **Contributions**

Each year, participants may contribute pretax annual compensation up to the Section 402(g) limit, as defined in the Plan. The Plan allows for automatic enrollment. Unless an employee is excluded from participating, or elects not to participate in the Plan, the Company will withhold 3% of the employee's eligible wages each payroll period. Participants may also elect to contribute a different amount of post-tax compensation as defined by Section 402A up to the Section 402(g) limit. Participants may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans, subject to employer limitations on an operational and nondiscriminatory basis. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds and a guaranteed portfolio fund as investment options for participants. The Company may contribute a discretionary amount as a matching contribution. Additional discretionary or non-elective contributions may be made at the option of the employer. A discretionary match equal to 50% of employee contributions up to 6% of compensation, as defined in the Plan, was made during the plan year ended December 31, 2024. No additional discretionary or non-elective contributions were made. Contributions are subject to certain limitations.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, and (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of continuous service.

##### Notes Receivable from Participants

From their fund accounts, participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the account balance in the participant's account. Each loan will bear a rate of interest of prime rate plus 1% and must be repaid within five years by equal payments at least quarterly, except for a loan to buy the participant's principal residence, which can be repaid over a period up to thirty years. The loan interest rates are determined by the Plan Administrator and are consistent with the provisions of section 4975(d)(1) of the Internal Revenue Code ("IRC"), Section 2550.408b-1 of the Regulations of the Department of Labor and other applicable legal requirements. Delinquent notes receivable are treated as distributions based upon the terms of the Plan document. The interest rates on notes receivable from participants ranged from 4.25% to 9.50% as of December 31, 2024 and 2023. Interest income received from repayment of participant loans was \$28,097 for the year ended December 31, 2024.

##### Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account if the amount of vested interest is \$5,000 or less. If the amount of vested interest is greater than \$5,000, a participant may elect to receive his or her distribution in a lump sum or in monthly, quarterly, semi-annual or annual installments over a fixed period of time that does not exceed the life expectancy of the participant as determined by published life expectancy rate tables.

##### Forfeitures

Amounts forfeited by Plan participants are allocated to a forfeitures account. Forfeited amounts arising from matching contributions are used to either offset matching contributions for the current or a future Plan year or pay for Plan expenses. Forfeited amounts arising from non-elective contributions will be allocated to participants eligible to receive non-elective contributions for that Plan year based on the ratio of the individual participant's compensation to the compensation of the entire group of eligible participants. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7,197 and \$7,896, respectively. For the year ended December 31, 2024, \$12,223 of the forfeiture balance was utilized to reduce the employer match contributions.

##### Plan Expenses

Plan fees and expenses, including fees and expenses connected with the providing of administrative services by external service providers, are paid from Plan assets.

#### B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

##### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

##### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

##### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fully benefit-responsive guaranteed investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

##### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent receivables are treated as distributions based upon terms of the Plan document.

##### **Excess Deferrals Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions.

##### **Subsequent Events**

Management has evaluated subsequent events for potential recognition and disclosure that occurred through September 29, 2025, the date the financial statements were available to be issued. No items were determined by management to require disclosure.

#### C. INFORMATION CERTIFIED AND PROVIDED BY THE CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Total investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

- Investments and notes receivable from participants' information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### D. INVESTMENTS IN GUARANTEED PORTFOLIO FUND

In accordance with ASU 2015-12, *Plan Accounting: Defined Benefit Pension Plans (Topic 960), Defined Contribution Pension Plans (Topic 962), Health and Welfare Benefit Plans (Topic 965) – (I) Fully Benefit-Responsive Investment Contracts, (II) Plan Investment Disclosures, and (III) Measurement Date Practical Expedient (a Consensus of the FASB Emerging Issues Task Force)*, investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan invests in the Key Guaranteed Portfolio Fund from Empower Annuity Insurance Company of America (the "Trust"). The Trust seeks to provide maximum current income while maintaining stability of principal. The Trust invests primarily in medium-long term portfolios. Withdrawals are permitted at any time without penalty, and the contract is determined to be fully benefit responsive. The statements of net assets available for benefits presents the Trust at contract value. Contract value is calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations.

The Plan's investments in the Trust at contract value at the Custodian as of December 31, 2024 and 2023, were \$946,724 and \$1,357,458, respectively.

#### E. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in less active markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be active.

*Collective trust funds:* Valued at NAV as reported to the Plan by the Custodian based on the market values of the underlying investments of the fund. The fund is not required to publish a daily NAV, therefore, the NAV is a practical expedient in determining the fair value of the funds.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Changes in Fair Value Levels

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Level 3.

#### F. TAX STATUS

The IRS has determined and informed the Company that the Plan and related Trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management evaluated the Plan's tax positions and concluded that the Plan had taken no uncertain tax positions that require adjustment to the financial statements to comply with the provisions of this guidance. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### G. RISKS AND UNCERTAINTIES

The Plan maintains cash balances and investment balances which exceed federally or other insured limits, although historically the Plan has not experienced any credit-related losses. The assets of the Plan are primarily financial instruments. Financial instruments are exposed to various risks, such as market performance, interest rates, economic conditions and world affairs. Due to the level of risk associated with certain financial instruments, it is at least reasonably possible that changes in the values of financial instruments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### H. TERMINATION OF THE PLAN

Although it has not expressed any intent to do so, Nexus Management, LLC (the "Plan Sponsor") reserves the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants' rights to their accrued benefits are nonforfeitable.

#### I. RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds and the key guaranteed portfolio fund managed by the Custodian. Empower Annuity Insurance Corporation of America is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Nexus Management, LLC is the Plan Sponsor and administrator and pays certain administrative costs including accounting, legal and consulting fees on behalf of the Plan. Some of the Plan trustees are also participants of the Plan. Fees paid by the Plan for investment management services amounted to \$77,377 for the year ended December 31, 2024.
