## NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

### 1. Description Of The Plan

The following description of the milkrite InterPuls, Inc. 401(k) Plan (the Plan), is provided for general information only. Plan participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan that provides retirement benefits for eligible employees of milkrite InterPuls, Inc. (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan utilizes Fidelity Management Trust Company (Fidelity) as the third-party administrator.

#### **Eligibility**

Employees who have reached the age of 18 and have completed 90 days of service for the Employer are eligible to make 401(k) salary deferrals and receive the discretionary Employer matching contribution and nonelective contribution. Employees can begin participation as of the first day of the next calendar month following completion of the service conditions.

#### **Contributions**

Each year, participants may contribute a percentage of their annual compensation, as defined in the Plan, not to exceed certain Internal Revenue Service (IRS) limitations. Salary deferral contributions can be made as either pre-tax or Roth (after-tax) contributions. Eligible employees may elect to defer up to 75% of their annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution and defined benefit plans (rollover). Unless participants make a positive election otherwise, eligible employees are automatically enrolled at 6% with an annual 1% step increase up to a maximum of 15%.

### Notes To Financial Statements (*Continued*)

The Employer contributions consist of a discretionary matching contribution and a nonelective contribution. For the years ended December 31, 2024 and 2023, the Employer made a discretionary matching contribution. The Employer matched 50% up to the first 6% of compensation to participants who are eligible and participating in the Plan. The Employer did not make a nonelective contribution for the years ended December 31, 2024 or 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, the Employer discretionary matching contributions, nonelective contributions, and an allocation of Plan earnings. Allocations are based on participant compensation or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately 100% vested in all contribution types.

#### **Notes Receivable From Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum of \$50,000. Loans are for a period not exceeding five years unless used to acquire a personal residence and bear interest at a reasonable fixed rate of interest based on prevailing market rates. Loans are secured by participants' vested account balances. The loans are repaid in semi-monthly payments, through payroll withholdings, including principal and interest at rates ranging from 4.25% to 9.50%. The final installments are due on various dates through December 2029. Participants may only have one outstanding loan at a time.

#### **Payment Of Benefits**

Upon termination of service due to death, disability, retirement or other termination of employment, a participant's benefit can be distributed in a lump sum, or in substantially equal monthly, quarterly, semi-annual, annual or other installments over a period not to exceed certain life expectancies. Certain distributions of accounts less than \$1,000 are limited to a lump sum form of distribution. In-service withdrawals are allowed for any reason upon reaching age 59½.

#### **Hardship Withdrawals**

A participant may make withdrawals from his or her participant deferral contributions account in the event of undue financial hardship, which includes payments for education expenses, medical or burial expenses, the purchase of a home or delinquent mortgage payments, and for the repair of damage to the participant's principal residence as defined by the Plan Agreement.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions, and when appropriate, reasonable and supportable forecasts.

The Plan does not have an Employer contribution receivable as of December 31, 2024 or 2023; therefore, there is no allowance for current expected credit losses at December 31, 2024 or 2023.

#### **Investment Valuation And Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net change in fair value of investments includes the Plan's gains and losses on investments that were bought and sold as well as held during the year. Investment related expenses are included in net change of fair value of investments.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on an accrual basis. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document.

#### **Payment Of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

#### 4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2      Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  
  - Quoted prices for identical or similar assets or liabilities in inactive markets;

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

#### **Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

#### **Common/Collective Trust**

Valued at the unit value or NAV (or NAV equivalent) of units, of the individual funds. The NAV (or NAV equivalent), as provided by the trustees of each of the invested funds, is used as a practical expedient to estimate fair value. The NAV (or NAV equivalent) is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV (or NAV equivalent). Each of these investments file an annual report on Form 5500 as direct filing entities.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Plan Termination

The Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

## **6. Income Tax Status**

The Plan utilizes a pre-approved plan document sponsored by FMR LLC. FMRC LLC received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **7. Transactions With Parties In Interest**

The Plan invests in mutual funds managed by an affiliate of Fidelity and, therefore, qualify as party in interest transactions allowable under ERISA.

Certain employees have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered party in interest transactions allowable under ERISA.

## **8. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
