### 1. Description of Plan

The following description of the Shipman & Goodwin LLP Profit Sharing Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan established effective December 31, 1968, as restated January 1, 2015. The Plan covers all employees, excluding employees who are a non-resident alien and who receive no earned income from an employer which constitutes income from sources within the United States, employees during a period covered by a collective bargaining agreement entered into with the employer if such agreement does not provide for participation of such Employee in the Plan, and employees who are lease employees, of Shipman & Goodwin LLP (the Partnership or Employer) who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Shipman & Goodwin LLP and the Plan's Retirement Committee are responsible for oversight of the Plan. The Plan's Retirement Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Contributions*

For nonlawyer staff, the Company will make a profit sharing contribution to the Plan of 7% of eligible compensation, as defined by the Plan, plus an additional 5.7% of their eligible compensation in excess of the Social Security Wage Base. For partner employees, the Company will make a profit sharing contribution to the Plan of 9.9% (except where a lower percentage is otherwise applicable to a partner as noted in the Plan) of eligible compensation, as defined by the Plan, plus an additional 5.7% of their eligible compensation in excess of the Social Security Wage Base.

Additional discretionary nonelective contributions may also be contributed at the option of the Partnership. For the 2024 Plan year, an additional dollar amount equal to 0.52% of eligible compensation was contributed into the Plan on behalf of all partners in the Plan. Participants also direct the investment of Company contributions. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### *Participant Accounts*

Each participant's account is credited with the participant's contributions, Partnership profit sharing contributions, allocations of the Partnership's discretionary contributions and an allocation of the Plan's earnings. Participant accounts are charged with the administrative expenses that specifically relate to a participant's account, such as a plan loan fee. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *Vesting*

Participants are vested immediately in their contributions plus actual earnings thereon. In the event of termination due to death, disability or early or normal retirement, participants shall become 100% vested in the Partnership's contribution portion of their account. In addition, if a participant was terminated from employment on or after July 31, 2020, as part of the Company's reduction in force action taken in response to the COVID-19 pandemic, they became 100% vested in the Partnership's contribution portion of their account. All other participants who complete an hour of service on or after January 1, 2020, vest in the Partnership's contribution portion of their account at a rate of 34% after one year of service, 67% after two years of service and 100% after three years of service. For all participants who do not complete an hour of service on or after January 1, 2020, vesting in the Partnership's contribution portion of their accounts is based on years of continuous service. A participant is 20 percent vested after 2 years of credited service and continues to vest in increments of 20 percent until 100 percent vested after 6 years of credited service.

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined annually, is set at the Prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Terms range from 1 to 5 years up to 15 years for the purchase of a primary residence.

#### *Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, the Plan allows for hardship distributions if certain criteria are met, and also allows for in-service withdrawals for participants from their vested accounts after they have reached age 62.

#### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$164,439 and \$146,682, respectively. These accounts will be used to reduce future employer contributions. During 2024, employer contributions were reduced by \$9,344, from forfeited nonvested accounts, in accordance with plan provisions.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

#### *Contributions*

Contributions from Plan participants and the employer contributions from the Partnership are recorded in the year in which the employee contributions are withheld from compensation, and in the case of the employer contributions, in the plan year to which they relate.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Partnership. Expenses that are paid by the Partnership are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### *Subsequent Events*

Subsequent events were evaluated through September 29, 2025, the date the financial statements were available to be issued. No events were identified requiring recognition or disclosure in the financial statements.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

**Level 1** – Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**Level 3** – Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Self-directed brokerage accounts: Self-directed brokerage accounts consist of common stock, exchange traded funds, money market funds and mutual funds. The common stock and the exchange traded funds are actively traded and are valued at the closing price reported on the active market on which the individual securities are traded. The money market funds are actively traded open-end funds registered with the Securities and Exchange Commission and are valued at daily closing price as reported by the fund. These funds are required to publish its daily NAV and to transact at that price.

*Investment contracts at fair value:* Commingled trust: Valued at the NAV of units of a bank commingled trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the commingled trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

### 5. Related-Party and Party In Interest Transactions

Certain Plan investments are managed by the Custodian, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Partnership. No such officer or employee receives compensation from the Plan.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### 7. Tax Status

The IRS has determined and informed the Partnership by a letter dated August 17, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods pending or in progress.
